FPCCI has the pleasure to invite applications for 42nd FPCCI Export Awards for the year 2017-2018 (July-June). As you are aware FPCCI export awards are considered highly prestigious at home and abroad and the recipients of FPCCI Awards enjoy an exalted position in international markets and are recognized as high profile exporters of the country.

As per tradition, the FPCCI Export Awards will be presented by a VVIP Personality at a usually impressive function attended by Parliamentarians, Bureaucrats, Foreign Diplomats, Leading Businessmen and the Social Elite. The event is expected to be held in the first week of November 2018.

Applications are invited for the following Categories of Awards, latest by:

Saturday, 20th October 2018

1. PRESIDENT OF PAKISTAN AWARD

The President of Pakistan Award will be given to a Group of Company / Organization whose overall export performance is the highest in the country during the year 2017-2018 (July to June) in any one or more of the categories of Exports (please submit documentary proof for this category of award). It may be noted that each application (see Annexure C) shall be accompanied by Pay Order or Bank Draft of Rs. 15,00,000/= (Rupees Fifteen Lacs only), which shall be refunded to unsuccessful applicants.

2. PRIME MINISTER OF PAKISTAN AWARD

The Prime Minister of Pakistan Award will be given to a Group of Company / Organization whose overall service performance is the highest in the country during the year 2017-2018 (July to June) in any one or more of the categories of (i) General Services (ii) Investment (please submit documentary proof for this category of award). It may be noted that each application (see Annexure C) shall be accompanied by Pay Order or Bank Draft of Rs. 15,00,000/= (Rupees Fifteen Lacs only), which shall be refunded to unsuccessful applicants.

3. BUSINESSMAN OF THE YEAR GOLD MEDAL

Businessman of the Year Gold Medals will be given to Leading Businessmen / Companies in sub-sectors of the following Categories during the year 2017-2018 (July to June). Complete documentation and proof / evidence in support shall be required for each category of Gold Medal:

- (i). **Export:** Export to Traditional Markets/New Markets, by the Company/Organization/Multinational Company (whose branch office in Pakistan).
- (ii). **Services Sector:** (1) Airline & Aviation (2) Banking & Financial Services (3) Buying Houses (4) Freight Forwarding & Logistics (5) Foreign Exchange Earnings (6) Hotel & Tourism (7) Housing & Construction (8) Insurance (9) Leasing (10) Ports & Shipping (11) Pre-shipment Inspection (please submit documentary proof for this category of award).
- (iii). **IT & Telecom Sector:** (1) Call Centers (2) Computer Marketing & Networks (3) Infrastructure Development (4) Software Development (5) Telecommunication (6) Web Development.
- (iv). **Investment:** Foreign / Local Investment (establishment of New Units / Industries in Pakistan), by the company or group of companies (please submit documentary proof for this category of award).
