SUBJECT: APPEAL TO THE ELECTION COMMISSION OF THE FPCCI BY SECRETARY GENERAL MAKKRAN CHAMBER OF COMMERCE & INDUSTRY AGAINST THE DECISION OF SECRETARY GENERAL OF THE FPCCI AGAINST CHANGE OF STATUS OF NOMINATIONS OF THE EXECUTIVE COMMITTEE AND GENERAL BODY NOMINEES OF MAKKRAN CHAMBER OF COMMERCE & INDUSTRY FROM THE PROVISIONAL LIST OF VOTERS FOR THE FPCCI ELECTIONS FOR THE YEAR 2019

The appellant aggrieved with the decision of the Secretary General of the FPCCI under Rule 18(6) of the TOR 2013 made representation to the Election Commission of the FPCCI vide letter no. nil dated November 9, 2018 received in FPCCI Head Office Karachi on November 9, 2018 on the grounds mentioned therein.

Written statement of the appellant:

The appellant in his appeal to the Election Commission of FPCCI stated that their initial request made to the Secretary General of FPCCI for the change of status of nominations on the Executive Committee and General Body which was erroneously communicated back then should be entertained. He added that the Association has nominated Mr. Abdul Ghaffar on the Executive Committee and Mr. Haji Abdul Jalil on the General Body of the FPCCI for the year 2019, however, the provisional list issued on October 27, 2018 depicts Haji Abdul Jalil on the Executive Committee and Mr. Abdul Ghaffar on the General Body of the FPCCI which should be corrected accordingly.

Decision of the Secretary General of FPCCI


The Secretary General rejected the initial representation made by the appellant on the following reasoning:

“Original nomination papers submitted to this office on 18th October, 2018 have been examined and we have found that the names of the nominees mentioned in papers for the Executive Committee and the General Body have been recorded correctly in the provisional voters list published on 27th October, 2018 matching aforementioned documents. Therefore, there is no error on our part in issuing of these names in our provisional list. Hence, your application cannot be entertained.”


Decision of the Members of the Election Commission of FPCCI:

While concluding the matter, the Members of the Election Commission of FPCCI decided as under:


That, since Makkran Chamber of Commerce & Industry has furnished all the prerequisites for the swopping of the existing nominations, thereby confirming the nominations of Mr. Abdul Ghaffar on the Executive Committee and Mr. Haji Abdul Jalil on the General Body of the FPCCI, therefore, the **said representation is hereby being ACCEPTED.**
