SUBJECT: APPEAL TO THE ELECTION COMMISSION OF THE FPCCI BY MR. AMIN KHATRI AGAINST THE DECISION OF SECRETARY GENERAL OF THE FPCCI AGAINST INCLUSION OF THE NOMINATIONS OF HYDERABAD CHAMBER OF COMMERCE & INDUSTRY IN THE PROVISIONAL LIST OF VOTERS OF THE FPCCI FOR THE YEAR 2019

The appellant aggrieved with the decision of the Secretary General of the FPCCI under Rule 18(6) of the TOR 2013 made representation to the Election Commission of the FPCCI vide letter no. Nil. Dated 13<sup>th</sup> November 2018.



**Written statement of the appellant:**

The appellant while opposing the decision of the Secretary General FPCCI objected on the nominees of Hyderabad CCI of Mr. Muhammad Shakir Memon on EC & GB from Associate Class and Mr. Muhammad Adnan Khan on GB from Corporate Class.

**The decision of the Secretary General Dated November 7, 2018**

The Secretary General decided the matter referred to him as under:-

*"18(4) The members who have any objection to the entries in the list of voters shall send their objections in writing to the Secretary General within seven days of the issuance of the voters' list."*

*As per aforementioned Rule of Trade Organizations Rules 2013, only the Members nominated for the year 2019 by the Trade Bodies, may object on the list. Since Mr. Muhammad Amin Khatri, is not a member in the list of voters, therefore, the objection on the nominees of Hyderabad CCI cannot be entertained.*

**Decision of the Members of the Election Commission of FPCCI:**

While concluding the matter the Members of the Election Commission of FPCCI decided as under:

That, as per Rule 18(4) of the TOR 2018 only the Members nominated for the year 2019 by the Trade Bodies, can legally object on the list and it noticeable that Mr. Muhammad Amin Khatri, is not a member in the list of voters for the year 2019.

Furthermore, the signature of Secretary General of Hyderabad Chamber of Small Traders & Small Industry is appearing on the letter head of M/s. D. S. Motors Pvt. Limited, which is also not valid.

Thus, in the light of the above, the very representation is here being dismissed and accordingly the orders of the Secretary General of FPCCI are upheld.


In view of the above facts, the Election Commission did not consider it necessary to summon the party for pleading the representation in person.
