As-salamu Alaykum!



## Participation in Seminar on Business Opportunities Under CPFTA- II

Trade Development Authority of Pakistan (TDAP) organized an awareness seminar on "Business Opportunities under CPFTA-II at Pearl Continent Hotel, Karachi. In this seminar, I discussed the following points.

- In today's world of globalization, the importance of free trade cannot be ignored. As you are
  well aware, Pakistan, with great enthusiasm, laid the foundation for Phase I of FTA with China in
  July 2006. The Second Phase of which was supposed to commence in 2013 but due to prolonged
  negotiations and delays, it was concluded last year and has just commence on January 01, 2020.
- Under this agreement, Pakistan will reduce duties to zero on 75% of total tariff lines in 15 years
  while China will do the same in 10 years period. The greatest opportunity for Pakistan is the
  elimination of tariff on 313 tariff lines, covering most of our exports and it is supposed to
  increase significantly our exports to China.
- However, in our considered opinion, this is where the greatest challenge lies for Pakistan. If we
  look at Phase I of China Pakistan FTA, the balance of trade remained greatly in favor of China.
  China managed to export 57% of its product lines while Pakistan could take advantage of only
  5% of its product lines under the Phase I.
- Therefore, our greatest concern is how Pakistan will benefit from Phase II, when we do not have
  excess products to export. Unfortunately, the industrial output is declining because of deindustrialization in the last few years. The Government of Pakistan needs to address serious
  issues like, high interest rates, frequent increases in power and gas tariff, unavailability of gas to
  industrial sector, abrupt changes in government policies, smuggling and refunds to exporters are
  some of the major impediments due to which industries find it difficult to sustain their
  existence.
- We need to develop a robust industrial policy that would lead to industrialization in Pakistan, encourage R&D, innovation, diversification and development of new products, improve quality standards, improve technical skills of our labor, encourage joint ventures with Chine companies and relocation of their industries to Special Economic Zones.
- Otherwise, we will not be able to receive benefits from supposed vast opportunities available to
  us and the fate of second phase of China Pakistan FTA will not be any different than the First
  phase.

#### **Interactive Sessions**

#### Impact of Corona Virus on Pakistan's Trade

FPCCI organized a session on "Impact of Corona Virus on Pakistan's Trade" which was presided by Sheikh Sultan Rehman Vice President FPCCI simultaneously at Federation House Karachi, Regional Office Lahore and Capital Office Islamabad.

The session was graced by Dr. Murtaza Syed, Deputy Governor State Bank of Pakistan (SBP) as Chief Guest while Dr. S.M. Qaiser Secretary General Pakistan Medical Association, Dr. Adil H. Haider Dean (Pakistan Chapter) Aga Khan Medical University, Secretary Heath Sindh Government, Senior Economist SBP Dr. Farooq Arby, Dr. Samreen Sarfaraz, Pakistan Medical Association, Dr. Saeed Qureshi, SINA Welfare, Representatives of Dow Medical University, Pakistan National Shipping Corporation, Karachi Port, Additional Secretary Industries & Commerce Sindh Government, etc were special invitees of the meeting. The meeting was also attended by Vice Presidents, representatives of Trade Bodies, Executive Committee and General Body members, Prominent Leading Businessmen & Industrialist, Conveners & Deputy Conveners of Standing Committees and Members of Business Councils. The purpose of the meeting was to analyze the possible impact of Corona Virus on Pakistan's Trade and devise a strategy to minimize the risk.

While welcoming the participants, Sheikh Sultan Rehman stated that Pakistan's neighboring countries i.e. China and Iran are most affected with the corona virus. The economy of Pakistan is highly dependent on China as the trade volume between both nations stood at US\$ 20 billion. He also cited the statement of Mr. Razzaq Dawood, Advisor to President on Commerce that corona virus is affecting the imports of Pakistan as currently the import of agricultural commodities, chemical and raw material are banned which may create shortage in future. He also quoted that according to Asian Development Bank, at present the global losses from the corona virus have reached to US\$ 347 billion and it can decline Pakistan's GDP to negative 1.57 percent. The United Nation Center for Trade and Development also stated that Pakistan is among the 20 nations whose economy will be affected due to current crisis in China.

In his remarks, Dr. Murtaza Syed Deputy Governor SBP stated that the economy of Pakistan can be affected with the spread of Corona Virus but it also create an opportunity for Pakistan to enhance its exports as most of Chinese orders in world have been cancelled particularly textile orders. He suggested that Pakistan should look towards Africa and Europe whose imports from China made ten percent of Chinese exports. He further stated that Pakistan imported sixty percent of machinery from China and 2 percent of raw material from China and due to disruption in supply chain in China; local importers are looking towards other countries as alternate sources for import. He also stated that the slowdown in world economies led to central banks in major market bringing down the interest rate and coming up with the fiscal stimulas to support the market. He further added that the lowering of oil prices in international market also give opportunity to improve its balance of payment and revive Pakistan's industry. Dr. S. M. Qaisar Sajjad Secretary General Pakistan Medical Association and Dr. Samreen Sarfaraz gave a presentation and highlighted the issues emerging from corona virus. Dr. Samreen made a presentation on the precautionary and preventive measures to contain the spread of the virus such as washing of hands with a soap and water atleast 20 seconds, avoid unnecessary and insecure contact with wild or domestic animal, in case of coughing and sneezing, cover your mouth with a tissue paper or an elbow, maintain safe distance from a person who is coughing, to avoid crowd, avoid sharing utensil like cup, towel food etc They informed that the death toll due to corona virus is just 3 percent while 85 percent patients are recoverable. The social media should play its due role to spread the precautionary and preventive measures. All the 20 cases in Pakistan have travel history, she informed.

During the session, the participants suggested that the present circumstance provide the opportunity to increase exports and government should facilitate the local industry in terms of lowering interest rate and oil prices. The participants also talked about the panic which increased the prices of mask, gloves, medicines and sanitizers to many fold as these items are necessity for the doctors and para medical staff. Moreover, Government has imposed more than 70% duty on imports of gloves and masks which create shortage and increased their prices. The participants also suggested but the National Economic Disaster Management Cell play its due role to minimize the economic losses. The participants also underscored the need of formulating strategy for domestic as well as international trade particularly in this uncertain period.

#### Post Lockdown Scenario of Covid-19 and Its Effects on Pakistan's Economy

Mian Anjum Nisar, President of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI) said that coronavirus (COVID-19) has severely affected the economy, businesses, industries and small traders. He was speaking in the seminar on post lockdown scenario of COVID-19 and effects of coronavirus pandemic on Pakistan's economy via video link on zoom held FPCCI Head Office Karachi. The seminar was attended by Agha Fakhar Hussain, Additional Secretary – Industry and Commerce, Government of Sindh, Sheikh Sultan Rehman, VP FPCCI, prominent businessmen and representatives of State Bank of Pakistan, Principal and Dean of Dow University of Health Sciences, Trade Development Authority of Pakistan, PHMA and other associations. Haji Ghulam Ali former President FPCCI, Mr. Qaiser Khan, VP FPCCI, Muhammad Ali Mian and Nasir Hayat Magoon also attended the seminar.

The President of FPCCI in his welcome address showed his serious concerns over the consequences of COVID-19 on Pakistan's economy. He said that Pakistan has been one of the countries worst affected by COVID-19, with the economic disruption caused by the pandemic exacerbating an already existing crisis. He said that the coronavirus pandemic has become dreadful contagion across the globe and we have been passing through the second wave of coronavirus (COVID-19) which has severely affected the economy, businesses, industries and small traders. The lockdown measure sparked a wave of unemployment and created socio-economic challenges, and economic pandemonium in the country and many people lost their jobs as many companies/factories shut their production in the country owing to the coronavirus pandemic.

He appreciated the refinance scheme by State Bank of Pakistan (SBP) for businesses to support the employment of workers in the face of economic challenges posed by the spread of the novel coronavirus (COVID-19). We have provided the salaries to all FPCCI employees during the given situation of coronavirus pandemic even liabilities and financial burden is increasing.

He also emphasized that it is clear that COVID-19 proved as catastrophic for Pakistan's already ailing economy and the country's economic performance is at standstill due to the pandemic because the worst-case scenario is "high impact," and entails a 0–1.5 per cent GDP growth While formal sector workers are also at risk. It is estimated that the poverty rate will increase from around 23.4 per cent to nearly 59. Despite the prevailing situation of COVID-19, locust swarms have also harmed the agriculture sector of the country, he added.

While conducting the seminar, Sheikh Sultan Rehman, VP FPCCI showed his deepest concerns regarding COVID – 19. He said that it has proved as a catastrophic and deadly disease and engendered lives and livelihoods of millions in the country and across the world. He lauded the relief and exemption provided by the government for facilitating the businesses in Pakistan especially to the construction industry and others sectors of the economy.

He further said that coronavirus cases are increasing because people are not following the standard operational procedures (SOPs). In this regard, the government has to manage the situation efficiently and competently by implementing new economic priorities, relief on income tax to companies producing products related to life necessities, and health protection and to announce support for exporters. Along with all this, it is a major responsibility of citizens to self-quarantine and provides the government with a free hand to gear up some economic activities in a proper manner under the war of COVID-19.

Agha Fakhar Hussain – Additional Secretary, Sindh Government stated that it has been noticed that people and traders are not following the standard operational procedures (SOPs) in their business premises. He further said that the business community should create awareness and assure implementation of SOPs at District level through economic zones in order to control the spread of COVID-19. Sindh Government is ready to facilitate the business community at every stage but it is the responsibility of all to follow the SOPs so that we may be able to cope with this difficult situation of the pandemic, he added.

#### **Food Security in Pakistan**

Almost 37 percent of our population is food insecure despite the fact that Pakistan is self-sufficient in major staples at present and the main problem is access and affordability to food, this was stated by Shaikh Sultan Rehman Vice President Federation of Pakistan Chambers of Commerce and Industry (FPCCI) in an interactive webinar on Food Security in Pakistan held at Federation House Karachi, Regional Office Lahore and Capital Office Islamabad via Zoom video link.

The Seminar was attended by Khurram Ijaz and Qaiser Khan, Vice Presidents FPCCI, Former Sr. Vice President FPCCI Shaukat Ahmed, Senior Members FPCCI Masir Hayat Magoon, Nousherwan Mughal and Qaisra Sheikh, Muhammad Khalid Qaim Khani, Additional Director Food & Finance Sindh Government, Dr. Rafique Ahmed Chandio, Director General Agriculture Policy Institute, Ms Asma Khalid Sr. Economist, State Bank of Pakistan, Representative of Pakistan Agricultural Storage and Services Corporation and Croplife Pakistan, Mr. Jamshed Iqbal Cheema, Chairman Crop Protection Association of Pakistan, Representatives of Sitara Chemicals, Representative from Quetta Chamber of Commerce and Industry, and Mr. Sultan Mehmood. While welcoming the participants, Shaikh Sultan Rehman Vice President FPCCI emphasized on the food security in Pakistan which has high linkage with human capital and strong economic implications. While highlighting the facts and figures of the Food and Agriculture Organization (FAO) of the United Nation, he added that high rate of malnutrition can cost an economy around 3-4 percent of GDP which primary affects our young generation mainly due to rising of death rate, malnutrition, low future productivity. Moreover, rising of population and climate changes are other challenges which may risk food security in future. He informed that globally Pakistan ranked 8<sup>th</sup> in production of wheat, 10<sup>th</sup> in rice, 5<sup>th</sup> in sugarcane and 4<sup>th</sup> in milk production, despite this Pakistan faces occasionally shortage of these products which affects their prices. He added that hoarding and smuggling are other issues also create food shortage in Pakistan. He underscored the need for implementation of National Food Security Policy announced in 2018; wherein it was decided that the agriculture production will be increased by 4 percent every vear and special attention will be given on agriculture research.

Mr. Khurram Ijaz, Vice President FPCCI also showed his concern over the locust attack on different crops in Pakistan which affects the agriculture productivity. He emphasized on strong institution which can contribute significantly in coming out from crisis.

Dr. Rafique Ahmed Chandio, Director General Agriculture Policy Institute discussed different dimensions of food security like productivity, availability of variety of food, accessibility and affordability. He emphasized on the strong coordination between federal and provincial government and private sector. He added that the COVID-19 increased poverty and unemployment in Pakistan which may create food insecurity in Pakistan. Government initiated different programs in order to overcome the poverty and unemployment but institutions response is very weak due to insufficient data availability. Moreover, global economic policies of WTO, unfair trade regime and tariff rationalization are hurting agriculture investment in Pakistan.

Ms. Asma Khalid Senior Economist State Bank of Pakistan stated that Per Capita consumption of food products that possess high-nutritional value like beef, chicken, fish, milk, vegetables and fruits is almost 6-10 times lower than that of developed countries which affects the labor productivity and young population. She added that Pakistan ranked 106<sup>th</sup> among 119 countries in Global Hunger Index, and has been characterized as facing a "serious" level of hunger due to under-nourishment, micronutrient (iron, calcium, vitamin-A) deficiencies and a deficit of safe drinkable water. under-5 malnutrition costs around US\$ 7.5 billion every year, which is equivalent to 3 percent of GDP and the cost comprises loss of future labor force, high under 5 mortality, low labor productivity emanating from stunting, anemia or jodine deficiencies in childhood; and prevalence of chronic weakness and fatigue etc. She also emphasized on the support price of all crops and agriculture insurance in order to support the farmers. Rising population and climate changes will create challenges for Pakistan to secure food. Mr. Muhammad Khalid Qaim Khani, Additional Director Food & Finance Sindh Government highlighted the issues of harvesting particularly declining of wheat production in Punjab and shifting from staple crops to other crops. He also emphasized on the improvement in crops quality, enhancing of crops yield, better usage of pesticides etc. Mr. Jamshed Igbal Cheema, Chairman Crop Protection Association of Pakistan added that there is high food insecurity in Baluchistan and KPK followed by Sindh due to rising of poverty, unemployment and low income of people. He emphasized on the changing of eating habits towards that crops where there is high potential available like potatoes, maize, cow milk etc and have better nutritions compared to traditional foods which will help in reducing the under-nutrition issues and improve labor productivity. Ms. Qaisra Sheikh Coordinator Women Entrepreneurs of FPCCI also focused on purification of food items and wastage of food in Pakistan. She also highlighted the issues of household women whose are facing deficiency in food and anemia etc. Mr. Nousherwan Mughal FPCCI member also underscored the need of establishing agriculture labs for value addition of agriculture products and innovation of new varieties of agriculture product.

In his concluding remarks, Sheikh Sultan Rehman, Vice President FPCCI emphasized the need to form long-term, consistent policies with consultation with all stakeholders, establish warehouses and cold storages to save fruits and vegetables from being rotten, utilize modern irrigation technologies to increase Food Security in Pakistan.

#### **Horticulture Sector in Pakistan: Potentials & Impediments**

There are 11 agro-climate zones where Pakistan can cultivate different varieties of fruits, vegetables and flowers to earn foreign exchange, this was stated by Shaikh Sultan Rehman, Vice President of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI), in an interactive webinar on "Horticulture Sector in Pakistan: Potentials & Impediments" held at Federation House Karachi, Regional Office Lahore and Capital Office Islamabad via zoom video link.

The Seminar was attended byDr. Muhammad Arshad Vice President, Executive Committee and General Body Members, Qaisra Shaikh, FPCCI Coordinator Women Entrepreneurs, Saadat Ejaz Qureshi, Former Chairman Pakistan Horticulture Development and Export Board, Fahim Siddiqui, Chairman Horticulture Society of Pakistan, Dr. Hafeez ur Rehman, Director National Coordinator (Horticulture), Muhammad Amin, Agriculture University Faisalabad, Dr. Ishfaq Ahmed Hafiz, Chairman Department of Horticulture, PMAS Arid Agriculture University and Representatives of All Pakistan Fruit & Vegetable Exporters, Importers & Merchants Association.

While welcoming the participants, Shaikh Sultan Rehman, Vice President FPCCI emphasized on the value addition of horticulture sector wherein there is huge scope of exports. He added that citrus, mango, potato, peach, and cherries from Pakistan are those horticulture products which are highly recognized in international market. Unfortunately this sector was ignored in Pakistan; as a result the production of key fruits and vegetables indicate a declining trend. He stated that Pakistan is still using old and traditional methods for harvesting which result in low yield per hectare compared to other countries. He further added that Pakistan has potentials to increase exports as well as domestic consumption by investing in research and technology. He also quoted the facts and figure of Asian Development Bank Studies which reflect that per capital consumption of vegetables and fruits is very low compared to USA and European Countries which also affect our human capital and productivity. He also highlighted issues related to post harvest losses and lack of cold storage warehouses.

Mr. Saadat Ejaz Qureshi, Former Chairman Horticulture Development Board and Exports stated that there is no coordination amongst the different departments of agriculture sector as agriculture production is looked after by provincial governments while exports are under federal government. He stated that Pakistan is losing markets of Europe and Middle East for orange and mango exports due to fruit flies and absence of treatment plants. Pakistan is currently exporting 5 to 7 percent of its horticulture production as our yield is very low compared to other countries. He underscored he need of freight subsidy as our export price are very high and can't compete internationally. He also appreciated the government for increasing custom duty on import of fruits to discourage its import and protecting domestic production. He advised to improve the farm conditions by giving its management to the professional people.

Mr. Sarfaraz Iqbal, Pakistan Horticulture Development and Export Board emphasized on the need to give special treatment to fruits at each stage of production and exports as there is lack of consistency in production. He also suggested the usage of hybrid seed and inventions/innovations of new varieties of fruits and vegetables. He also urged for the adoption of sanitary and phyto sanitary standards for international markets and improving of quality of packaging. He added that there is huge scope for export of vegetables in Pakistan China FTA which need to be utilized. He also underlined the need of improving conditions of farmers by offering incentives in order to encourage them to increase production.

Dr. Ishfaq Ahmed, Chairman Horticulture Department, PMAS Arid Agriculture University Informed about different areas of Pakistan where there are opportunities available for production of fruits like olives, grapes etc. He highlighted different issues which create hindrance in exports of horticulture like SPS compliance, lack of value addition, lack of adoption of good agriculture practices, weak supply chain, high cost of production, non-compliance on quality competition as per international market, lack of diversification in crop production and post-harvest losses & quality assurance.

Dr. Hafeezur Rehman, Director National Coordinator (Horticulture), PARC stated the potentials available in Khyber Pakhtunkhwa where off-season crops can also be harvested. He urged reduction in post-harvest losses, identification of new markets, technological advancement and supply consistency.

Mr. Fahim Siddiqui, Chairman Horticulture Society of Pakistan emphasized on the promotion of floriculture in Pakistan where there is huge potential as Pakistan spends millions of dollars in importing flowers.

Muhammad Amin, Horticulturist, Agriculture University Faisalabad focused on value addition, better preservation of fruits, branding, packaging of fruits and vegetable in order to increase Pakistan's share in international market. He urged the Government to set the uniform price of Pakistan fruit exports for all countries. Moreover, he suggested the government to devise a strategy for exporting dates to Saudi Arabia and other countries.

In his concluding remarks, Sheikh Sultan Rehman, Vice President FPCCI emphasized the need to form long-term, consistent policies with consultation of all stakeholders, establish warehouses and cold storages to save fruits and vegetables from being rotten, utilize modern irrigation technologies to increase the production and improving quality. He offered vote of thanks to the participants.

#### SMEs in Pakistan: Challenges and Way Forward

Almost 90% enterprises in Pakistan are SMEs that contribute 40% in GDP, 25% in exports and 80% in nonagriculture labor force. Unfortunately, 7 to 8 percent credit financing of private sectors is given to SMEs sector and most of the credit is given to corporate sector, this was stated by Shaikh Sultan Rehman Vice President of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI) in an Interactive Webinar on SMES in Pakistan: Challenges and Way Forward at FPCCI Head Office Karachi and Capital Office Islamabad & Regional Office Lahore through Video conferencing.

The session was attended by Former President FPCCI, Zakaria Usman, Executive Committee and General Body Members, Qaisra Shaikh, FPCCI Coordinator Women Entrepreneurs, Muhammad Ali Mian, Coordinator FPCCI Regional Office Lahore, Muhammad Asim Anis Convener & Iftikhar Ghani Vohra Deputy Convener FPCCI Standing Committee on SMEs, Rehmatullah Javed, Former Convener FPCCI Standing Committee on SMEs, Arjumand Qazi, Group Head SME Banking Pak-Brunei Investment Company Limited, Representatives of SMEDA, Nazli Abid, Former Vice President FPCCI, Doulat Ram Lohana, Wasif Majeed and Muhammad Atif Haleem Presidents Hyderabad, Jhang and Peshawar Small Chambers & Traders Association respectively.

While welcoming the participants, Shaikh Sultan Rehman Vice President FPCCI highlighted the issues of SMEs including access to finance, high cost of doing business, low value addition, technological advancement, complicated tax system etc. While quoting the examples of other countries he added that SMEs are dominating in China, Taiwan, Singapore, Hong Kong and Korea and contributed more than 80 percent in their development. These countries achieved the status of industrial advanced countries or newly industrial nations just on the basis of development of SMEs sector. Pakistan should learn from the experience of these countries and formulate SMEs-driven policies, he stated. He emphasized on the promotion of SMEs as it provide low cost employment. He also informed the losses to SMEs due to COVID-19 and suggested to provide collateral free loans upto Rs. 5.0 million to SMEs on easy conditions. Moreover, those SMEs who are registered with FBR and filed returns for last three years should be give grants of 0.5 million by direct transfer in their account. The details of account are already available with FBR. He also urged for holding training sessions for SMEs on E-Commerce.

Mr. Zakaria Usman Former President FPCCI also emphasized on the collateral free loan facilities and allotment of small plots to SMEs. Convener and Deputy Convener of SMEs Committee of FPCCI also stated about the SMEs situation in the period of COVID-19 which also affected the small importers. They underscored the need of special scheme for the SMEs during the period of COVID-19 which should facilitate and stabilize the growth. Arjumand Qazi, Pak-Brunei Investment Company Limited updated the participants about different financing schemes for small, medium, women and special person enterprises segments. She stated that SBP has given incentives to SMEs and extended loan deferment scheme up to September 30, 2020. They are facilitating the women entrepreneurs in enhancing their skills and providing loan on 5% for 5 years with No KIBOR. The Presidents of Small Chambers and Traders Association of Hyderabad, Jhang and Peshawar also informed about the problems faced by SMEs and suggested the government to provide business friendly environment with simplification of registration process and favorable trade and tax policy. They also enlightened about the non-acceptance of small denomination of Pak currency by banks and restrictive timings of banks. They also demanded exemption on the withholding tax as they are already paying advance tax.

Muhammad Ali Mian, Coordinator FPCCI Regional Office Lahore stated that Financing of SMEs which does not include the cost of building and land and suggested the SMEs financing amount should be based on turnover of last five years. During the session, the participants also showed their reservations on various definitions of SME being proposed and discussed. They suggested that a single definition requires to be notified and preferably with higher business turnovers in order to keep accommodating the SMEs in proportion to their business growth in terms of growing sales turnovers with passage of time. Moreover, the SBP should include all sectors in SMEs Financing instead of present restricted to 8-9 sectors and all the banks should consider financing on cash flow basis instead of collateral basis. The participants also suggested establishment of business centers in all cities and organization for capacity building program for SMEs. The participants added that the SME Policy 2007 is neither implemented properly nor the data of SMEs are available for further research and strategy analysis.

#### **CPEC and Pak China FTA (Phase II)**

There are huge opportunities available for Pakistan under CPEC projects by joint ventures and technological transfers while imports under Pak China FTA (Phase II) affected our local industry; this was stated by Mian Anjum Nisar President of the Federation of Pakistan Chambers of Commerce and industry (FPCCI) in an interactive webinar on China Pakistan Economic Corridor and Pakistan China Free Trade Agreement (FTA Phase II) held at Federation house Karachi, Regional Office Lahore and Capital Office Islamabad via Zoom link.

The webinar was organized by Sheikh Sultan Rehman Vice President FPCCI and attended by Mr. Nadeem Sheikh Vice President FPCCI, Mr. Zakaria Usman former President, H.E. Li Bijjan Chinese Consul General in Karachi, H.E. Wang Zhihua, Minister Counselor from Chinese Embassy, Riaz Sheikh, Acting Secretary TDAP, Zarak Khan President Pakistan China Joint Chamber of Commerce and Industry (PCICCI), Dr. Liaqat Ali Shah, Executive Director Centre of Excellence CPEC, Syed Mehdi Raza, Deputy Director SBP, Representatives of All Pakistan Bedsheets & Upholstery Manufacturers Association, Pakistan Readymade Garments Manufacturers & Exporters Association, Pakistan Chemicals and Dyes Association and Members of Pakistan China Business Council of FPCCI.

While welcoming the participants, Mian Anjum Nisar President FPCCI stated that China Pakistan FTA Phase I has increased trade deficit to US\$ 16 billion and it is expected that it will increase further in Phase II. At present, Pak China FTA (Phase II), allowed duty free access to 313 tariff lines of China, total imports of these products stands US\$ 67 billion. He emphasized on the need of removal of under-invoicing, Sanitary and Phytosanitary measures (SP\$), Technical Barriers to Trade (TBT) and other barriers.

In his remarks, Sheikh Sultan Rehman, Vice President FPCCI underlined the need for offering of same incentives to Pakistan industries which Pakistan igovernment is offering to Chinese investors. While highlighting the project, he added that China has already completed 80% of Phase I projects related to energy and infrastructure and the Phase II includes the projects related to socio-economic development, industrial cooperation and agriculture. He emphasized on the need for innovation, product diversification and joint ventures as vast opportunities are available in Pakistan China FTA (Phase II). He added that China should give concrete plan of relocating its labor intensive industries in SEZs of Pakistan and include Pakistan in the supply chain of its finish goods exports from Pakistan like Vietnam & Cambodia.


In his statement, H.E. Li Bijian, Chinese Consul General in Karachi stated that his consulate is ready to help the Pakistani businessmen for creating interaction with Chinese companies which offer huge socio-economic benefits to Pakistan and create employment opportunities. He also talked about environmental protection fulfilled by the projects. He added that CPEC will benefit local people particularly young population in enhancing their skills and providing employment opportunities. He also underscored the need of improvement in quality of products, facilities at investment location, reduction in time for new investment, better prices of Pakistani products, reduction in labor cost etc. Moreover, security and consistency in economic policies related to taxation, time duration is also important for new investment.

Mr. Zarak Khan, President Pakistan China Joint Chamber of Commerce and Industry stated about the need of elimination of administrative hundles and improvement in infrastructure for Chinese investment in Pakistan. He also emphasized on the need of study of success model of China Vietnam trade in order to get the benefits of Pakistan China FTA (Phase III).

Mr. Riaz Sheikh, Acting Secretary Trade Development Authority of Pakistan stated that ASEAN and other countries have taken huge benefits with FTA with China and there are a lot of opportunities available for Pakistani traders in exporting agriculture goods, gems, jewelry, frozen sea food, textile etc. Pakistan has to follow all compliance, quality and other requirements. There are eight SEZs under the CPEC which need facilities for investment. He also talked about series of countrywide seminars for apprising the business community of the business and export opportunities arising out from second phase of CPFTA.

H.E. Wang Zhihua, Minister Counselor from Chinese Embassy in Islamabad that China informed that China is planning to organize trade fair from November which will provide opportunities to Pakistan to enhance its trade with China. Their Embassy is encouraging more Chinese investment in Pakistan. Dr. Liaquat Ali Shah Executive Director Centre of Excellence CPEC informed the constitution of CPEC Authority, CPEC Business Council and other institutions for facilitating the investment under CPEC. He also underlined the need of industrial cooperation, entrepreneurship activities in Pakistan etc for getting advantage from China.

Syed Mehdi Raza, Representative of SBP also informed about the measures taken in the period of COVID-1 9 for supporting trade with China like refinance scheme etc. The other participants also stated about the availability of equal sovereign guarantee in SEZs for Pakistani investors and using of Pakistani labors in Chinese projects.

#### Impact of BREXIT on Trade and Economy of Pakistan

Pakistan must have same level of market access with UK after BREXIT which Pakistan is enjoying with the EU, this was stated by Sheikh Sultan Rehman Vice President of the Federation of Pakistan Chamber of Commerce and Industry (FPCCI) in a webinar on "Impact of BREXIT on Trade and Economy of Pakistan" organized by FPCCI Head Office Karachi, Regional Office Lahore and Capital Office Islamabad via Zoom Video Conference.

The Webinar was attended by Kamal Shahryar, Adviser on GSP Plus Trade Development Authority of Pakistan, Ms. Aaisha Makhdum and Mr. Baber Khan Joint Secretary and Deputy Secretary Ministry of Commerce, Mr. Asim Yousuf, Vice President Pak-UK Chamber of Commerce and Industry, Dr. Zulfiqar Hyder, Senior Economist, Syed Ali Raza Mehdi, Deputy Director State Bank of Pakistan, Sheikh Tariq, Chairman Pak UK Business Council of FPCCI, Mr. Zakaria Usman, Former President FPCCI, Ms Qaisra Sheikh, Coordinator Women Entrepreneurs and Executive Committee and General Body Members of FPCCI.

While welcoming the participants, Sheikh Sultan Rehman Vice President FPCCI stated that there was a historical referendum in UK in 2016 wherein the people of UK voted against remaining in the EU which created a wave of shock and caused loss of US\$ 2 trillion in a day. He added that UK plays a key role in economic and social development of Pakistan. At present, the balance of trade between Pakistan and UK is in favor of Pakistan. Pakistan's exports to UK stood at US\$ 1.7 billion and Pakistan is mainly exporting textiles cotton fabrics, knitwear, readymade garments, bed wear and rice to UK. He stated that currently the trade between Pakistan and UK is going on under the EU GSP Plus scheme which will end for UK from January 01, 2021. He also urged Pakistani Government to sign Bilateral Investment Treaty with UK.

In his remarks, Trade Development Authority of Pakistan (TDAP) GSP Plus Advisor Kamal Shahryar stated that the negotiation between Pakistan and UK is continuing for getting the similar facility which Pakistan is enjoying under EU GSP Plus. He stated that UK has not shared conditionalities of new trade agreement but in principle agreed for similar level of facilities. He added that after BREXIT the border trade with EU will not take place for moving goods into EU member countries. UK has started revision of its MFN tariff for all countries which will also benefit Pakistan. Ms. Aaisha Makhdum, Joint Secretary Ministry of Commerce informed about their negotiations regarding post-BREXIT arrangements with Trade Department of UK and stated that the demand of UK about adoption of conventions are same which Pakistan is already ratified in EU GSP plus. Mr. Zakaria Usman, Former President FPCCI emphasized to finalize the agreement with UK as Pakistani exporters have made huge investment in textile sector in accordance to EU GSP plus requirements which should not be affected with BREXIT.

Mr. Asim Yousuf, Vice President Pakistan UK Chamber of Commerce and Industry added that there are huge opportunities for Pakistan's export in agriculture, textile and food items to UK. In this context, there is a need of early formulation of Pakistan's trade delegation to UK for getting new orders from UK. Moreover, Pakistani community in UK also plays a crucial role in Pak-UK Trade and at present, 80% of our trade with UK is conducted by Pakistani companies.

Sheikh Tariq, Chairman Pakistan UK Business Council of FPCCI informed about the registration of his company for filing of UK custom declaration service from January 2021. After completion of BREXIT transition period, additional more than 250 million custom declarations will be filed and processed. He also urged Pakistan to comply with standards and SPS measures as UK is importing 1.2 million ton of meat. He also underlined the need of developing Pakistani business center in UK as UK is establishing business hub wherein all the countries are establishing their offices.

Mr. Shariq Vohra underscored the need of research for enhancing exports to potentials market as our Pakistan export is stagnant for 10 years. Ms Qaisra Sheikh, Coordination Women Entrepreneurs emphasized on the development of mechanism for transformation of informal trade into formal trade as most of the women are exporting to UK informally. She also suggested to expand the list of product mix for enhancement of exports. The participants also stated that State Bank of Pakistan should sign agreement with central bank of England for trading in property of UK on collateral basis as India has signed. This agreement will also facilitate transfer of remittances from UK to Pakistan. Moreover UK should also follow REX system after BREXIT which is convenient to Pakistani exporters.

#### **Promotion of Exports of Non Traditional Items**

Pakistan must expand its export basket by exploring market of non-traditional items; this was stated by Sheikh Sultan Rehman Vice President of the Federation of Pakistan Chamber of Commerce and Industry (FPCCI) in a webinar on "Promotion of Exports of Non Traditional Items" organized by FPCCI Head Office Karachi, Regional Office Lahore and Capital Office Islamabad via Zoom Video Conference.

The Webinar was attended by Zubair Baweja, Vice President FPCCI, Mr. Riaz Sheikh, Acting Secretary TDAP, Mr. Zakaria Usman Former President FPCCI, Mr. Saquib Fayyaz Magoon, Former Vice President FPCCI, Ms Qaisra Sheikh Coordinator Women Entrepreneurs, Ms Mehreen Ilahi President Women Chamber of Commerce and Industry District East Karachi and Executive Committee and General Body Members of FPCCI.


While welcoming the participants, Sheikh Sultan Rehman Vice President FPCCI stated that Pakistan's exports are stagnant between US\$ 20 billion to US\$ 25 billion since many years. He added that Pakistan has limited its exports to few items i.e. textiles, carpets, sports, leather and surgical items which contributed more than 75 percent in exports of Pakistan. At present, Pakistan is facing tough competition from regional countries in terms of cost of production, quality and economy of scale. He underlined the need of promotion of handicrafts, jewelry, softwares, vegetables, fruits, dry fruits, livestock, chemicals, dairy products etc. He also emphasized on exploration of non-traditional market with non-traditional items.

Mr. Riaz Sheikh, Acting Secretary Trade Development Authority of Pakistan (TDAP) appreciated the exports performance of Pakistan which is comparably better than the other countries despite the fact that COVID-19 resulted in lock down of all provinces of Pakistan for three months. Pakistan has started exports of sanitizers and surgical mask to the COVID-19 affected countries. He further informed that TDAP is giving 60% subsidy to non-traditional items and 80% to non-traditional markets. He suggested the need of organizing single country exhibitions/ trade fairs in Central Asian countries, Africa and South America region for marketing of non-traditional items. He also appreciated the role of commercial counselors of Pakistan for deferring the exports contract of Pakistan during the period of COVID-19.

Mr. Zubair Baweja Vice President FPCCI stated that exports is an engine of economic growth and Pakistan can walk on path of economic recovery by enhancing its exports. Mr. Zakaria Usman, Former President FPCCI added that the enhancement of exports is need of the hour for earning of foreign exchange. He underscored the need of incentives to be given by the government on the exports of non-traditional items. He also urged new investment in import substitution in plastic and agro based industries in order to save foreign exchange. At present, per capita consumption of plastic is more than 100 kg in developed countries while it is average 60 kg in Pakistan. He also suggested the government to increase the private sector credit for investment in non-traditional sector.

Ms. Qaisra Sheikh, Coordinator Women Enterpreneurs highlighted engineering sector wherein there is huge potential of exports. She urged for enhancement of participation in exhibitions of non-traditional items. Moreover, Pakistani mission in foreign countries should also market the potential of Pakistan's non-traditional exports.

Mr. Saquib Fayyaz Magoon Vice President FPCCI highlighted the scope of chemicals for exports of sanitizers and other products during the period of COVID-19. He said that by value-addition Pakistan can become a big exporter of chemical items as well. Ms. Mehreen llahi, President Women Chamber District East drew attention toward the export potentials of pink and rock salt, stones, religious items, gems & jewelry, ceramics and handicraft to Europe and African countries. She also urged the participation of women entrepreneurs in handicraft and other specialized exhibitions. The other participants also stated about the potentials of livestock, dairy farming and other products and requested to revive the exports promotion programs like AHAN, SARSO etc.

#### E-Commerce and Digital Pakistan: Challenges and Way Forward

COVID-19 has increased the requirement of E-Commerce and Digital Pakistan; this was stated by Sheikh Sultan Rehman, Vice President of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI) in a webinar on "E-commerce and Digital Pakistan: Prospects & Challenges" held at Federation House Karachi, Regional Office Lahore and Capital Office Islamabad via zoom link.

The webinar was attended by Ms Aisha Moriani, Joint Secretary Ministry of Commerce, Mr. Raza Ahmed Sukhera, Project Manager, Ministry of Information Technology, Mr. Shehzad Shahid, Chairman Pakistan Software Houses Association (PASHA), Mr. Talha Nadeem, Senior Analyst, State Bank of Pakistan, Mr. Liaquat Sheikh, Mr. Zain Rafique Project Manager SMEDA, Ms Shamim Rajani, COO Genetech Solutions, Mr. Sultan Hamdani, Maison Consulting & Solutions, Ms Mehreen Ilahi, President Karachi Women Chamber of Commerce & Industry (District East), Mr. Altaf Haswani, Sana Safinaz, Mr. Rahim Ali, Ms Jehan Ara, President PASHA Mr. Mehmood Parekh and other prominent businessmen of Pakistan.

While welcoming the participants, Sheikh Sultan Rehman Vice President FPCCI emphasized on the implementation of E-Commerce and Digital Pakistan policy for the promotion of E-Business in Pakistan. He added that the COVID-19 has increased online business wherein social marketing also plays a crucial role. Promotion of E-Commerce doesn't need large investment for the promotion of brand and marketing of new products. He also focused to provide awareness to small businesses for utilization of technology as 64% of Pakistan's population is youth which can quickly adoot technology and subsequently promotes IT business.

In her remarks, Ms Aisha Moriani, Joint Secretary Ministry of Commerce updated the participants about important aspects of E-Commerce Policy like Regulation and Facilitation, Financial Inclusion and Digitization through Payment Infrastructure, Empowering Youth and SMEs through Business Support Programs and Trade Development, Customer Protection, Taxation Structure, ICT Infrastructure and Telecom Services in Pakistan, Logistics, Data Protection and Investment and Global Connectivity etc. She also informed about the development of cross border E-Commerce system for promotion of trade and establishment of National E-Commerce Councils for promoting startups, simplifying payment options, reducing disputes and protection of consumer rights.

Mr. Raza Ahmed Sukhera, Project Manager, Ministry of Information Technology also enlightened the participants about development of new softwares, availability of internet access, business facilitation measures, establishment of IT valley, strengthening of R&D in ICT sector, facilitation of SMEs, and start ups etc. He added that there is huge potential in E-Commerce Industry as the Global E-Commerce Sales has reached to US\$ 3.4 trillion while Pakistan E-Commerce Sales stands at US\$ 2 billion.Mr. Shehzad Shahid, Chairman Pakistan Software Houses Association (PASHA) indicated that the IT related exports of Pakistan were increased by 23% last year which reflects the potential of this sector. He added that the government has set target for next three years upto US\$ 5 billion for E-Commerce Sales. Most of the companies working in IT sector are at small scale and we have to increase investment in IT sector. Technology has improved the business environment and we have to improve connectivity and quality of internet service in order to compete globally. Pakistan is currently using cash on delivery system which has to be digital and in this context, banks should come forward with better incentives in order to facilitate digital payments. He informed that Puniab Government has reduced GST to 5 percent on E-payments and other provinces should also adopt similar policy. Moreover, we have to give incentives on buying of Pakistani products which will improve our innovation and ultimately benefit the domestic industry. Pakistan Post is the only company in Pakistan which has largest logistics network which also need facilitation for improving their services and reduction of cost.

Mr. Talha Nadeem, Senior Analyst SBP also suggested enhancement of role of Pakistan Post in Financial Inclusion and urged for enhancement of It penetration for SMEs, freelance and microfirms. Ms. Shamim Rajani COO Genetech Solutions also requested for holding of training sessions on digital marketing particularly for handicrafts and other products of women entrepreneurs. Mr. Altaf Hashwani, Sana Safinaz also updated the houses about growth in their business with E-Commerce domestically to 70 percent. Ms Mehreen Illahi stated about the involvement of E-Business in fashion and handicraft industry.

#### Covid-19: Trade & Trade Related Measures

The Federation of Pakistan Chambers of Commerce and Industry (FPCCI) organized an interactive webinar on "COVID-19: Trade and Trade Related Measures" via Zooom Video link. The webinar was organized by Sheikh Sultan Rehman, Vice President FPCCI along with Engr. M.A. Jabbar, Conveoler FPCCI Standing Committee on WTO Affairs.


The event highlighted the importance of World Trading Rules of WTO for trade and trade related measures, recognizing the same as an effective tool to sustain the growth of individual member economies and aggregate global economy conducting trade under World Trade Rules. The event also acknowledged the continued role of WTO in providing guidance as to mitigate the adverse effect of decline in global trade affecting the member countries.

Sheikh Sultan Rehman, Vice President FPCCI while opening the debate said that we should watch the ongoing advisory and other guiding role of WTO, which should be under our focus in the CoVID-19 situation to remain compliant with the obligations of World Trading Rules. We should also take benefit of the relaxations as are available and agreed to under arrangement of special and emergency clauses allowed by the world trading system under WTO. He further said that the trade and trade facilitated allowances should also be capitalized for making appropriate pressure on public sector to structure the temporary policies towards the gain of trade and economy in present economic crisis generated by declining world trade due to COVID-19. He said that the successful temporary policies may eventually convert into permanent policies for time to come to conduct World trade.

Engr. M.A. Jabbar, convener FPCCI Standing Committee on WTO Affairs said that Pakistan was moving in accordance with the requirements of WTO during past and the same spirit needs to be continued. Once the situation is settled and becomes normal, the rules of world trading application will generate complaints in WTO against countries which are not following the applied rules. He said that Ministry of Commerce, Ministry of Industries & Production, Ministry of Agriculture, Ministry of IT & Telecom, bodies like PSQCA and IPO have been extending knowledge based contributions for taking up policy stance by our WTO mission in Geneva. Due to weak interest and deactivation of United States in WTO affairs, the WTO system working for further agreed positions became less relevant but we should always prepare ourselves for facing the normal working system of WTO for trade conducting. He further said that WTO is presently asking and guiding member countries to help their economies through trade related supporting measures which includes alignments of fiscal, monetary, trade policy reviews as well as other regulatory functions in such a way that the concessions extended should suit the domestic trade related measures to help the economic recovery in crisis like situations being faced in CoVID-19.

The participants included from Ministry of Finance, Ministry of Commerce, Trade Development Authority of Pakistan (TDAP), Applied Economic Research Center (AERC) and trade bodies. Mr. Sohail Hanif, Joint Economic Adviser Ministry of Finance said that we are continuously endeavoring to make fiscal adjustments through FBR as well as providing budget lines for tax refunds and have been fully engaged in convincing SBP to take appropriate measures for reducing the cost of exports and domestic commerce beside providing other refinance facilities to off load the pressure from the manufacturing and trade units to reduce the cost push generated by CoVID-19 situation. Mr. Shahid Sattar, Secretary General of All Pakistan Textile Mills Association (APTMA) said that our main concern is the fiscal related ease which is to have in-time settlement of refunds of taxes, which also appears to be in alignment with the guidance of WTO for member countries to make all the fiscal adjustments to mitigate the effects of the CoVID-19. Representative from Faisalabad CCI also said that the promised automation system on refunds in-time is still not in place and asked for the same to be installed on urgent basis as to help the manufacturers to manage its cash flow. Mr. Zaka ur Rehman Chairman of Pakistan Pharmaceutical Manufacturer Association (PPMA) said that they look forward for ease in regulatory framework in respect of imports of raw materials from the traditional destinations so that the present exports of \$300 million pharma products can be enhanced to likely to \$2 billion in near future. He also requested for a new round of meetings in MoC to help in reducing the regulatory burden coming in the way of access to raw materials in manufacturing of pharmaceutical products.

Dr. Amir Hussain Siddiqui from Academia said that we have opportunities and threats in the present situation. We are under the ongoing departure in trade of goods & services, which may be considered to be analyzed towards the need of export diversification in order to expand the present limited horizon of our exports focused on traditional goods being demand driven and are adversely affected under the present crisis affecting the reduction in demand. He further recommended that on the entire policy making in respect of business, the private sector should be completely involved so that the practical terminology of calling government as facilitator becomes practical for private sector which has all the knowledge related to types of business and destinations of imports as well as exports.

#### Halal Industry in Pakistan: Potentials and Challenges

The consumption of halal goods and services is mandatory requirement of muslims, this was stated by Mian Anjum Nisar, President of the Federation of Pakistan Chambers of Commerce and Industry in a webinar on "Halal Industry in Pakistan: Potentials and Challenges" held at Federation House Karachi and Regional Office hahore via zoom link.

The webinar was organized and conducted by Sheikh Sultan Rehman, Vice President and attended by Vice Presidents FPCCI Dr. Muhammad Arshad and Qaiser Khan, Muhammad Ali Mian, Coordinator, FPCCI Regional Office Lahore, Eng M A Jabbar Former Vice President FPCCI, Nasser Hayatt Magoon, Former President Karachi Chamber of Commerce and Industry, Shaukat Ahmed Former Sr. Vice President FPCCI, Dr. Akhtar Ahmed Bughio, Director General, Pakistan Halal Authority, Representative of Punjab Halal Development Authority, Mufti Yousaf Abdul Razzaq, CEO SANHA Halal Associates, Muhammad Zubair Mughal, Research Associate, Halal Research Council, Muhammad Awais Khan, Managing Director, Global Halal Services, Mr. Asad Sajjad Convener FPCCI Standing Committee on Halal goods and Services, Mufti Zeeshan Abdul Aziz, CEO International Halal Certification (Pvt) Ltd, Ms Sehrish Zuberi, Renaissance Inspection & Certification Agency (Pvt.) Ltd and Syed Farrukh Mazhar, Managing Director F&M Inspections.

Mian Anjum Nisar, President FPCCI stated that globally the halal industry is expanding more rapidly in non-Muslim nations compared to Muslim nations due to safer, hygienic, reliable and nutritious products. He further added that the volume of global halal trade is more than US\$ 3 trillion but the share of Pakistan is very minimal. He emphasized on the need to increase the halal food production and exports of semi cooked meat which is in highly demand in China and other Far East countries.

In his remarks, Sheikh Sultan Rehman, Vice President FPCCI stated that Halal industry has emerged into fast growing industry; attracting 2.4 billion people from all over the world. Pakistan, with a huge Muslim population, stands a chance of becoming a global hub for halal business, if the government pays attention to this industry. While quoting the statistics, he added that the trade of Halal industry has crossed three trillion dollars but the share of Pakistan is negligible (0.25 percent). He further stated that Pakistan has direct access to 470 million consumers of halal products in Central Asia, Middle East and Europe; we may achieve great success, if we adopt proper strategy and planning for establishing this industry. This industry is not limited to foods and beverages; but includes pharmaceutical, food services, cosmetics, financial services, logistics, tourism etc, he added.Dr. Akhtar Ahmed Bughio, Director General, Pakistan Halal Authority stated that standardization and conformity of halal products is need of the hour to increase halal sector related exports. He added that halal is value addition and we need to modify our standards as per international requirement. He informed that there is huge demand of Pakistani Gelatin to be used in halal medicines in Muslim countries. At present, only 5-6 companies are working in this sector and Pakistan is importing 75 million Gelatin capsule. A Representative of Punjab Halal Development Agency informed that Halal standards are not uniform in all countries which increase the cost of production and exports. There is need of development of one organization at OIC level which should develop their own rules and procedures of halal exports.

Dr. Muhammad Arshad Vice President FPCCI highlighted the potentials of halal meat which is highly demanded internationally due to texture and taste. He also informed that there is huge market of Pakistani meat in neighboring countries i.e. Afghanistan and Iran which can be explored by making investment in cattle farming and slaughterhouses. Muhammad Ali Mian Coordinator FPCCI Regional Office Lahore said that halal products cannot be deemed fully halal if they are produced through a process that is not entirely Shari'a compliance. A product will only be halal if its production and ingredients from start to finish, packaging, transportation and procedures are halal. As it happens, many halal manufacturers use interest-based borrowing or other Shari'a-repugnant methods of finance, therefore their products cannot be considered 100% halal. Muhammad Awais Khan, Managing Director, Global Halal Services focused on the expansion of Pakistan Halal Development Council and requested to ban self-developed halal logo which is creating problems in halal export. Mufti Zeeshan Abdul Aziz, CEO International Halal Certification (Pvt) Ltd added that Pakistan has complete system of standardization which is internationally accepted by other countries.

Moreover, there is a need of approval of Pakistan's certification by other countries. Moreover, PSQCA should be strengthened to fulfill the mandatory standards requirement of other countries. Muhamma Zubair Mughal, Research Associate, Halal Research Council proposed to introduce halal in tourism sector wherein Pakistan can earn millions of dollars. Eng. M. A. Jabbar Former VP FPCCI underscored the need of development of Halal food industries through extending fiscal, monetary, trade policy adjustments along with regulatory framework. He further stated that Halal Development Authority should engage in facilitating mutual recognizing agreements on SPS to provide market access to our halal products. Mufti Yousaf Abdul Razzaq, CEO SANHA Halal Associates informed that Europe is currently generating 80 percent of global halal revenue and Pakistan has an opportunity to increase its export of halal commodity as 90 percent of our raw material are halal. He urged the government to give tax and monetary incentives to investors for promoting halal brands like other nations Brazil, Thailand, Indonesia, Malaysia etc. Moreover, Pakistan has to participate in international halal exhibitions for promotion of Pakistani products.

#### **Textile Industry in Pakistan: Challenges and Way Forward**

Government must formulate long-term, durable and consistent policies to combat the declining trend in the textile manufacturing and our exports around the world, this was stated by Sheikh Sultan Rehman Vice President of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI) in an interactive webinar on "Textile Industry of Pakistan: Challenges & Way Forward" organized by FPCCI Head Office Karachi via Zoom video link.

The webinar was attended by Representative of All Pakistan Textile Mills Association (APTMA), Chaudhry Muhammad Nawaz, Chairman Pakistan Cotton Power Looms Association, Mr. Naqi Bari, CEO Bari Textile Mills, Ms. Qaisra Sheikh, Coordinator-Women Entrepreneur FPCCI, Mr. Danish Javed, Executive Committee Member FPCCI, Ms. Shagufta Rehman, Senior Vice President Women CCI Lahore and members from different trade bodies of Pakistan of the textile and related sectors.

While welcoming the participants, Sheikh Sultan Rehman Vice President FPCCI said that since 1950s, the textile sector of Pakistan has been the main driving force of our economy, with more than 60% share in our total exports and offers employment to almost 40% of our work force. However, there has been decline in our manufacturing as well as exports of textile products in recent years. He further said that government must take immediate measures for the timely refunds of sales and income tax, issuance of income tax exemptions on utility bills, and resolve issues faced by this export-oriented sector as these measures will help control the liquidity crunch faced by the stakeholders who are already facing hardship in the prevailing economic conditions.

During the discussion, Mr. Naqi Bari, CEO Bari Textile Mills said that decline in the production of cotton have increased the cost of manufacturing textile products which have ultimately affected our exports Pakistan. He further said that we must increase our cotton production along with value addition to increase our exports. Mr. Danish Javed, Convener FPCCI Standing Committee on Bed wear said that Bangladesh studied from our success in the textile sector and implemented effective policies which helped their textile sector and economy to grow a lot. He further said that we demand the exemption of import duties on spare parts for textile machinery as well as restoration of of zero rating which have created severe liquidity crunch for the textile exporters. Chaudhry Muhammad Nawaz, Chairman All Pakistan Cotton Power Looms Association said that this sub-sector is mainly comprised of SMEs who are severely affected in present times and needs special support from government to revive again. He further highlighted that commercial banks are reluctant to extend loans and financing schemes to SMEs particularly in Faisalabad. Mr. Nawaz on this occasion appreciated the initiative of FPCCI of taking all the stakeholders under one roof through video link for discussion on this important topic.

Representative from APTMA also said that issues of regionally uncompetitive industrial tariffs as well as high turnover taxes are one of the few major reasons of continuous decline in the manufacturing of textile in the economy. He further said that we should learn from the examples of Bangladesh and Vietnam who timely addresses these issues and now their textile sectors are playing an important role in their economic development. Ms. Qaisra Sheikh, Coordinator Women Entrepreneurs FPCCI said that FPCCI is the most relevant platform for the business communities to address these issues. Ms. Shagufta Rehman, Senior Vice President Women CCI Lahore stated that government must extend support to women entrepreneurs particularly belonging to textile sector. Taking the opportunity, she also identified the issue of commercial banks' reluctance to release the loans schemes to women entrepreneurs.

Concluding the event, Sheikh Sultan Rehman, VP FPCCI invited all the stakeholders belonging to this essential segment of the economy to send their suggestions and proposals so that same can be pursued with relevant government departments.

#### **Issues and Challenges Faced by Women Entrepreneurs**

"Increased share and willingness of Women Entrepreneurs in the economic development is highly appreciable, government and SBP have designed effective policies and financial schemes for women entrepreneurs, however compliance on the same by Commercial banks is not satisfactory", This was stated by Mian Anjum Nisar, President FPCCI in an interactive webinar on "Issues and Challenges Faced by the Women Entrepreneurs" organized by FPCCI Head Office Karachi.

The webinar was facilitated and conducted by Sheikh Sultan Rehman, Vice President FPCCI, Mr. Qaiser Khan Daduzai, Vice President FPCCI, Ms. Qaiser Sheikh, Coordinator Women Entrepreneurs FPCCI, Ms. Mehreen Ilahi, President WCCI Karachi East, Dr. Fouzia Hameed, President WCCI Karachi South, Ms. Nazii Abid Nisar, Former VP FPCCI, Ms. Naima Ansari, Former VP FPCCI, Ms. Masuma Sibtain, Former VP FPCCI, Ms. Shagufta Rehman, SVP WCCI Lahore, and a large number of women entrepreneurs and members of different Women Chambers from all over Pakistan.

Discussing the challenges faced by the women entrepreneurs, President FPCCI further shared that SBP had approached FPCCI to provide the data of the women business owners which will be utilized to provide financial reliefs to our hardworking businesswomen. Appreciating the efforts of women entrepreneurs, Sheikh Sultan Rehman, Vice President FPCCI demanded equal opportunities, level playing field and financial assistance to the Women Entrepreneurs to survive in the present economic conditions. He said that FPCCI through its Women Standing Committees and WCCIs across Pakistan extending cooperation to the female business owners in the country, Mr. Qaiser Khan, Vice President FPCCI invited the participants in the upcoming workshops to be conducted by FPCCI Capital office Islamabad in coordination with TDAP to share awareness regarding the loans under Export Development Fund (EDF) to women owned businesses. Mrs. Shahla Isavya, Women Wing, TUMSIAD Pakistan is a Turkish organization working to increase trade between Pakistan and Turkey and said that her organization is very much willing to coordinate with Pakistani women entrepreneurs to access Turkish market.

Prof Dr. M. Shahid Qureshi, Program Director AMAN Centre for Entrepreneurial Development-EBA appreciated FPCCI for organizing this webinar and said that finance is indeed a primary need to run a business, but we must also focus to develop business and entrepreneurial abilities in our female business owners. While discussing the problems faced by the Women Entrepreneurs, Ms. Qaisra Sheikh said that collateral and interest free loans must be provided to the small and micro level business owners. Furthermore, she highlighted the non-cooperative attitude of commercial banks towards the women entrepreneurs. Ms. Nazil Abid said that the pandemic and recent devastating rain and flooding in Karachi have severely affected the small and micro level businesses run by women who needs urgent and utmost financial assistance from government to survive in the market.

Ms. Mehreen Ilahi highlighted major issues including access to finances, lack of capacity building and market knowledge, issues and cost of transportation for micro level business owners in remote areas etc. She urged that a special task force should be formulated by government to resolve these issues on war footing. Ms. Naima Ansari said that indeed finance is the main issue that we are facing currently, however, individual's will, non-compliance with documentary requirements and capacity building is what we need to expand our outreach on the basis of which we can demand government to provide us the required financial assistance.

Ms. Masuma Sibtain also endorsed the issues highlighted in the discussion and mentioned that FPCCI published a policy document "Women National Business Agenda" including the issues and recommendation, and in continuation to our efforts SBP launched the credit policy for women entrepreneurs. Ms. Shabana Asif proposed that all WCCIs should submit a joint proposal to the government from the platform. She further said that we as WCCIs must also ensure proper documentation of the members.

Aspiring entrepreneurs and members of WCCI including Ms. Farzana Kousar, Ms. Amna Khurram, Ms. Iqra Saqib, Ms. Sadia Khurram, Ms. Faiza Nabeel, Ms. Zeenat Soboohi, actively The Concluding the event, Sheikh Sultan Rehman proposed to organize "All Pakistan Business Women Convention" for increased cooperation and interaction amongst the WCCIs and female business community of Pakistan. The participants unanimously demanded the government to provide financial grants upto PKR 0.5 million and interest/collateral free loans upto PKR 9.5 million to all SMEs and Women Entrepreneurs.

#### **Geo-Political Challenges Faced by Pakistan**

"Pakistan has high geographical as well as geo-political significance in the region which should be utilized diplomatically to ensure our social and economic development in the region, stated by Sheikh Sultan Rehman, Vice President FPCCI during and interactive webinar on "Geo-Political Challenges Faced by Pakistan" organized by FPCCI Head Office Karachi.

The webinar was organized and conducted by Sheikh Sultan Rehman and attended by senior analyst of international relations, economist etc. including Ms. Qaisra Sheikh, Coordinator Women Entrepreneurs FPCCI, Prof. Dr. Shaista Tabassum, Chairman Department of International Relations, University of Karachi, Dr. Aghar Ali Research Economist from Applied Economics Research Centre (AERC), Dr. Seema Shafique Khan, Director PITAD, Prof. Dr. Abdul Jabbar, President Pakistan society of Neuro Scientist, Mr. Nasser Hyatt Magoon, former President Karachi CCI, Mr. Amjad Rafi, Chairman Pakistan-Turkey Business Council of FPCCI and Dr. Saba Sheikh.

While sharing views on the topic, Sheikh Sultan Rehman said that Pakistan has tricky diplomatic relations with Afghanistan, Iran and particularly India on Issue of Kashmir, increasing international influence of China, the position of USA in the global arena, acceptance of Israel by some gulf nations are a few incidents in the recent history which have changed the paradigm of geo-politics globally.

While discussing, Qaisra Sheikh, said that military, economic stability, ideological leadership and good governance are the four pillars of a strong nation, Pakistan is lucky to have a strong military however economic growth, strong leadership and good governance will raise our significance in the region. While briefing the participants about the present day geo-political challenges faced by Pakistan on different fronts, Prof. Dr. Shaista Tabassum briefly discussed the geo-political challenges Pakistan is facing due to continuous terrorism, Pak-Afghan relation, Pak-Iran relations and its impact on our economic and political ties with the USA, the emerging scenario in Middle East with regards to Israel and most importantly Pakistan-India inherited cold war on Kashmir dispute. She said that the present global political scenario demands our strong diplomatic presence on international platforms.

Dr. Asghar Ali said that Covid-19 has taught us that import dependency and dependence on remittances from Middle East are one of the reasons that are making our geo-political position weak. While expressing her views, Dr. Seema Shafique Khan said that Pakistan is in no position to escape or evade from the emerging geo-political challenges and must realize that no economy can survive in isolation in the global village. Further highlighting the importance of China Pakistan and CPEC, she said that China is the only power that can contain Increasing influence of India in our region and we must manage this with effective diplomatic strategies.

Prof. Dr. Abdul Jabbar said that a weak economy cannot project influence in the region. Talking about the issues faced by Pakistan internally, he stated that horizontal and vertical polarization is breaking our internal strength and Pakistan has to become strong internally to emerge as a influencing nation in external affairs. Naser Hyatt Magoon highlighted the significance of Pak-China relations and CPEC in our efforts to gain a better of stronger influence on geo-political arena. Concluding the event, Sheikh Sultan Rehman urged that we must keep our house in order to fight the challenges on the regional and international front.

#### **Exploring Trade Potentials in Islamic World: Opportunities & Challenges**

Muslim countries have enormous resources and potentials to succeed, but the task is to translate these potential into real asset. Promotion of economic linkage within the Muslim communities by creating opportunities could help generate greater flow of capital from within and beyond the Islamic world, this was stated by Sheikh Sultan Rehman Vice President FPCCI in webinar organized by Federation of Pakistan Chambers of Commerce and Industry (FPCCI) at Federation House Karachi, Regional Office Lahore and Capital Office Islamabad via Zoom link.

The webinar was organized by Sheikh Sultan Rehman Vice President FPCCI and attended by Khurram Ijaz Vice President FPCCI, Amjad Rafi and Nasser Hayatt Magoo, Former Presidents Karachi Chamber of Commerce and Industry, Ms Aliya Jaffer, Assistant Secretary General Islamic Chamber of Commerce, Industry and Agriculture (ICCIA), Shabana Asif Sr. Vice President Women Chamber of Commerce and Industry, Ms Uniasa Deputy Secretary, Ministry of Commerce and the Pakistan's Trade Missions in Turkey, Oman, Qatar, Jordan, Indonesia and Tajikistan.

In this remarks, Sheikh Sultan Rehman Vice President PPCCI stated that absence of unity among the OIC Countries is a biggest challenge in the present uncertain political and economic situation in Islamic countries. He added that OIC which is the second largest bloc of the world represented one fourth of total land with 4.1 percent of the world population. While highlighting the statistics, he added that the collective GDP of OIC is US\$ 6.5 trillion with average per capita income US\$ 7,189. He further added that the intra-regional trade among the OIC Countries is 17.5 percent of total trade of OIC Countries while the intra-region FDI stood 2-3% of GDP. He also highlighted the World Islamic Economy figures that Muslim spent US\$ 2.2 Billion on Food, lifestyle and tourism which is growing 5-6 percent annually which indicates the potentials of halal industry. While commenting on Pakistan relations with Muslim World, he stated that Pakistan has strong and significant relations with all Muslim relations at political level but these relations are not reflects in terms of trade volume despite the fact that there is huge potential of trade due to geographical proximity, religion and cultural ties, similarities and availability of narral resources. The reason behind the low level of trade is lack of information sharing and low level of interaction among the private sector of Pakistan and OIC countries. He stated that among OIC member states, Pakistan has signed FTA only with Malaysia and PTAs with Indonesia Mauritius and Iran.

During the discussion, Mr. Muhammad Salman Ali, Trade and Investment Attache of Pakistan in Qatar stated that value added food products, pharmaceutical, construction material and agro based product has huge export opportunities to Qatar. FPCCI and TDAP should regularly participate in the exhibitions organized by Qatar for the enhancement of trade. Mr. Khadim Ali, Trade and Investment Attache of Pakistan in Jordan stated that Qatar is a consumer market and is importing rice, meat, fruits, sugar, tea, coffee, textile fabric, plastic items, ceramics etc wherein there is potentials for Pakistan to export, Currently, India and Europe is penetrating in Jordan and share of Pakistan in Jordan's trade is less than one percent. Mr. Bilal Pasha, Consul General of Pakistan in Turkey added that there is no operational trade agreement among 57 countries of OIC which is the main reason of low intra-regional trade. Market access, connectivity, transportation, financial connectivity and B2B connectivity are challenges which Pakistan faces in trade with Islamic Countries. Turkey is advance in science and technology and there is scope of collaboration for both countries in light engineering, chemical, agriculture, leather and textile. Ms Fauzia Perveen, Trade and Investment Attache of Pakistan in Indonesia stated that there are huge non-tariff barriers in terms of import license, quality requirements etc. Pakistan and Indonesia operationalized Preferential Trade Agreement in 2013 which is mainly benefiting Indonesia. Lack of shipping lines is another issue and almost 20-25 days are required for trade with Indonesia. Dates, meat and ethanol has potentials of exports towards Indonesia. Mr. Rashid Imtiaz, Commercial Secretary of Pakistan in Tajikistan stated that Tajikistan is gateway to Central Asia and Pakistan is mainly exporting sugar and importing cotton from Tajikistan. Connectivity is the main issue due to uncertain situation in Afghanistan. Ms Aliya Jaffer, Assistant Secretary General of ICCIA also suggested replicating of border trade of TOBB by other Islamic countries.

Mr. Muhammad Hanif Bashir, Commercial Consellor of Pakistan in Oman informed that India and China is aggressively marketing their products in Oman as Oman is mainly importing country. He also suggested regular holding of Joint Business Council meeting with respective country by FPCCI and participation in trade fairs and exhibitions. During the question- answer session, Mr. Amjad Rafi, Former President Karachi Chamber of Commerce and Industry also inquired about the trade agreements of Jordan with Turkey and Egypt and TIR conventions.

#### **Cyber Security: Cyber Threats to Digital Pakistan**

The Prevention of Electronic Crime Act, (PECA) 2016 does not include so many important aspect of cybercrimes being committed in our country, stated by Sheikh Sultan Rehman, Vice President FPCCI during an interactive webinar on "Cyber Security: Threats to Digital Pakistan" organized by FPCCI Head Office Karachi.

The webinar was attended by Mehmood ul Hasan, Deputy Director National Response Centre for Cyber Crime (NR3C)-FIA, Bilal Abbasi, Director IT, Ministry of Information Technology and Telecom, M.A. Zaeem, Deputy Director Cyber Crime Wing FIA, Ammar Jaffri, Founder President Pakistan Information Security Association, Qazi M. Misbah uddin, CEO Pak-CERT, Zaheema Iqbal, Cyber Security Policy Researcher, Bahria University, Mehreen Ilahi President Karachi WCCI (East) and Mohsin Sheikh, MD Trillium Information Security System.

While chairing the webinar, Sheikh Sultan Rehman emphasized on the strong and timely implementation of PECA 2016 which can reduce the already increasing rate of cyber crimes in the country. He further mentioned that improved infrastructure for cyber security is not only important for the financial and social safety of the people, but it is also essential to fight the cyber warfare.

During the discussion, M.A. Zaeem said that increased cyber security is the need of the time to decrease the cyber crime in our country. He further requested the business community to realize the significance of cyber and information security.

Ammar Jaffri that suggested FPCCI to establish FPCCI-CERT and offered his technological expertise for the business community. Bilal Abbasi said that the ministry of IT is working on the draft Personal Data Protection Bill which will be an authentic framework of cyber security in the country. He also endorsed the establishment of FPCCI-CERT. Mehmood ul Hassan said that implementation of the law is an equal responsibility of public and private sector and events like these will improve the coordination between both. He also said that technology moves really very fast and our public sector have to move at the same pace to fight the modern day challenges.

Zaheema Iqbal highlighted the significance of awareness, regulation and data governance in order to improve our cyber security infrastructure. Qazi Misbah Uddin recommended to apply penalties on companies on their weak information security systems which will reduce the cyber crime in the country. Mohsin Sheikh said that we as a country must focus on legislation, regulation and certification to strengthen our information and cyber security infrastructure.

While concluding the webinar, Sheikh Sultan Rehman offered collaboration with NR3C and Ministry of IT to conduct workshops and seminars to spread awareness amongst the business community regarding the importance of strong cyber and information security.

### **Corporate Governance: Issues & Challenges in Pakistan**

Good Corporate Governance stands on the principle of transparency, accountability, responsibility and fairness; this was stated by Sheikh Sultan Rehman Vice President of the Federation of Pakistan Chambers of Commerce and Industry in a webinar on "Corporate Governance: Issues and Challenges in Pakistan, held at Federation House Karachi via Zoom link.

The webinar was attended by Former Presidents Karachi Chamber of Commerce and Industry Mr. Amjad Rafi and Naseer Haytt Magoon, Prof. Dr. Abdul Jabbar, Mr. Ahsan Jamil, CEO, Pakistan Institute of Corporate Governance, Mr. Daulat Ram, Chairman Hyderabad Small Chamber of Commerce and Industry, Eng. M A Jabbar, Former Vice President FPCCI, Mr. Abdul Qayyum Raza, Secretary General Faisalabad Chamber of Commerce and Industry, Mr. Amanullah Representative of Pharmaceutical & Homeopathic Association, Iftikhar Ghani Vohra Deputy Convener Standing Committee on SMEs and Shabana Asif, Executive Committee Member from Women Chamber etc.

While welcoming the participants, Sheikh Sultan Rehman Vice President FPCCI stated that good corporate governance contributes to sustainable economic development by enhancing the performance of companies, reinforcement of property rights; reduces vulnerability of the financial crises, reduces transaction cost and cost of capital and leads to capital market development. Corporate governance has been adopted as one of twelve core best-practice standards by the international financial community. He also highlighted the reforms taken by the government to improve the regulation of corporate governance in 2017, including the updates to the Companies Act, the issuance of the Listed Companies (Code of Corporate Governance) Regulations and updates to the Public Sector Companies (Corporate Governance) Rules 2013. He also discussed the family legislation in the management of public and private company and talked about draft of new code of corporate governance for public listed companies under which the chairman shall be elected subject to such terms and conditions and responsibilities as provided and the board of directors shall appoint chief financial officer, company secretary and head of internal audit of companies for enhancing transparency and efficiency in the companies.

Prof Dr. Abdul Jabbar urged restructuring of Security Exchange Commission of Pakistan, Competition Commission of Pakistan and State Bank of Pakistan in order to improve the role and investment environment of Corporate Governance in Pakistan. He emphasized on the reforms with the assistance of private sector so that in these three organizations work collectively for good corporate governance in Pakistan. He highlighted the vulnerable picture of Sindh which is severely affected during the recent monsoon season due to lack of good governance and infrastructure.

Mr. Ahsan Jamil, CEO, Pakistan Institute of Corporate Governance underscored the need of improvement in corporate governance wherein private sector can play a leading role. He informed that COVID-19 has changed the working environment and now challenges related to health and safety has increases. There is lack of long term planning in Pakistan which has created environment and climate related problems. He added that Corporate Governance is a social requirement for society in addition to legal requirement.

Eng M A Jabbar, Former Vice President FPCCI underlined the need of monitoring of implementation of corporate governance rules which were developed in 2002 and are very comprehensive. He stated that family legislation always dominate in the corporate sector while in develop countries it is not more than 25 percent. He also suggested amendment in the Company Act, 2017 regarding classification of companies according to Corporate Governance Rules and the Chairman and CEO of the company should be elected/appointed separately by the Board of Directors. He also emphasized on the need of creation of awareness in the management of companies. Other participants also expressed their views and emphasized on good corporate governance. While concluding the webinar, Sheikh Sultan Rehman urged the government and the private sector to work together for better corporate Governance leading for a better economic and social development.

## Poverty Alleviation in Pakistan: Challenges & Way Forward

Poverty alleviation has not attained the level of political priority in Pakistan given its importance and urgency stated by Sheikh Sultan Rehman, Vice President FPCCI during an interactive webinar on "Interactive Webinar on Poverty Alleviation in Pakistan: Challenges and Way Forward" organized by FPCCI Head Office Karachi. He further said that poverty alleviation is not an option, and all the segments of the society must realize their responsibility towards the alleviation of poverty from the country.

The meeting was attended by representatives from leading public and private organizations including Dr. M. Ali Kemal Economic Policy Adviser from Sustainable Development Goals (SDG) Support Unit GoP, Dr. Shahid Hussain Javed Senior Economist from State Bank of Pakistan, Mr. Jawad Rehmani representative from National Rural Support Program, Ms. Maryam Anas Ganaie from Small Medium Enterprises Development Authority, Ms. Aisha Salma & Mr. Shehryar Shahid from Pakistan Poverty Alleviation Fund, Ms. Madiha Hasan, Provincial Focal Person from Benzair Income Support Program, Engr. M.A. Jabbar, Former VP FPCCI, Prof. Dr. Abdul Jabbar, renowned Economist, Ms. Nazli Abid Nisar, Former Vice President FPCCI, Commodore (R) Sadeed A. Malik Kashir, Dy. Convener FPCCI Standing Committee on Technical & Vocational Education & Training and Pir Muhammad Yaquib Chishti.

During the discussion, Mr. M Ali Kemal highlighted the different techniques for poverty data collection in Pakistan, at present around 24% of our population is living below the poverty line while 19% are the vulnerable. He further encouraged strong coordination between public and private sector for the economic development and poverty alleviation in the country. Sharing the details regarding the initiatives taken by SBP, Dr. Shahid Hussain Javed said that all the financing schemes of SBP aim to generate economic activities which are essential to provide income generation opportunities for the poor. Ms. Aisha Salma was of the opinion that government's target to reduce poverty rate from 24% to 19% can be achieved by inclusive growth, participation of women in the economy and education. Appreciating FPCCI, Ms. Salma further said that private sector must play its social responsibility to the maximum. Ms. Madiha Hasan shared that BISP disbursed around PKR160 million during lockdown. She also said that apart from providing cash assistance, Ehsaas Ministry is also working on education, nutrition, awareness on population control in the rural and remote areas. Ms. Maryam Anas highlighted the significance of SMEs and said that promotion of micro, small and medium enterprises is an important tool for dignified employment generation for the poor and unskilled/less educated class of population. Mr. Jawad Rehmani said that NRSP is working at grass root level for the community development. education, health and the entire primary and secondary aspects of increasing poverty in rural areas.

Engr. M.A Jabbar said that the available data related to poverty measurement in the country in not accurate and expressed his concern over the increasing rate of vulnerable in the country. He further suggested the need of correct utilization and mobilization of resources to the lowest to get positive outcome from government's poverty alleviation strategies. Prof. Dr. Jabbar criticized the performance of public sector organizations and ministries working for poverty alleviation in country and stressed the need of taking purchasing power parity (PPP) while measuring poverty strong public-private partnership and political will for the better of the poorest segment of the population. Mr. Sadeed Anver Kashir emphasized on the need of effective poverty alleviation policies particularly for the people depending upon the agriculture income sources. Pir Yaquib identified the significance of population control in the process of poverty alleviation in a country. Ms. Nazli Abid Nisar suggested financial support to the micro level workers without which it will be difficult for the government to contain and reduce the poverty in Pakistan.

While concluding, Sheikh Sultan Rehman said that the government cannot alone reduce the poverty in our country and hence it's the social and religious responsibility of private sector, community and civil society and they must work together for the alleviation of poverty.

## Webinar on "Problems faced by Cotton Industry in Pakistan" by Center for Global Strategic Studies (CGSS)

On 10<sup>th</sup> August 2020, Center for Global & Strategic Studies organized a webinar on "Problems Faced by the Cotton Industry in Pakistan" to discuss the various issues faced by the cotton industry in Pakistan including the production challenges, quality deterioration of cotton and the limited variety of seeds in the Cotton Industry of Pakistan. The webinar was commenced by Major Gen Syed Khalid Amir Jaffery (Retd), President, CGSS and moderated by Lieutenant Colonel Khalid Taimur Akram (Retd), Executive Director, CGSS.

Syed Fakhar Imam, Federal Minister for National Food Security and Research-informed the participants regarding the shift of farmers from cotton to other crops due to the minimum support price provided to the cotton crop. Moreover, Mr. Fakhar Imam mentioned that due to the high contamination rate of the cotton produced in Pakistan, the export of the Cotton gets affected. He also stated that the most important factor which affects the cotton quality in Pakistan is the Seed Quality.

Mian Anjum Nisar, President, Federation of Pakistan Chambers of Commerce & Industry mentioned that Cotton production not only supports the overall agriculture sector but it also, directly and indirectly, supports the various industries of Pakistan. Additionally, he mentioned that cotton contributes (directly and indirectly) to 50 percent of the total exports of Pakistan. Lastly, Mr. Anjum Nisar mentioned that to compete at the global level, the input cost of the cotton has to be reduced taxes on agriculture inpurts, sales tax on pesticides, ferticlizer shuld also be removed. Agri-research centre also need to produce high quality seed and ginning technology should also be improve with the help of China.

Shaikh Sultan Rehman Vice President FPCCI stated the development of an efficient transport system in ECO region will lower the transportation costs and improve the competitiveness of member countries. He also emphasized on the operationalization of Islamabad Tehran Istanbul cargo train project, KTAI project by completing rehabilitation and construction of missing links of the existing railway routes. He urged the member countries to implement ECO- Transit Transport Framework Agreement (TTFA) which will reduce transportation cost and acceleration of the transport services through harmonization and modernization of transit transport, facilitation of movement of goods and passengers, ensuring the safety of goods and passengers and avoiding unnecessary delays during the transit traffic, avoidance of incidence of customs frauds, tax evasion and harmonizing necessary administrative affairs in the region.

Mr. Baber Iqbal, Convener of the Specialized Committee on Transportation also highlighted the issues faced by Pakistan during COVID-19 which affects the border and air cargo trade. He also discussed CPEC which will bring prosperity and development in the region by providing transit to Central Asian countries through Pakistan to Middle East and Africa through shortest route and low cost of trade to the land locked member countries.

During the meeting, the participants shared the experience of pandemic and measures taken by their government for facilitating the transportation and discussed in details the issues of operationalizing of TIR convention which may help in reducing cost of transportation and increase competitiveness, ITI, KTAI train, cross border transport agreement, Afghan transit trade agreement, transit cargo were emphasized. Moreover, the participants suggested training session for traders and transporters on TIR by TOBB and sharing of Border gate experience by TOBB.

## **Specialized Committee Meeting of Trade Facilitation of ECO-CCI**

The Specialized Committee Meeting of Trade Facilitation of ECO Chamber of Commerce & Industry (ECO-CCI) was held via video link and attended by representatives of the Chambers of Commerce & Industry of member countries including Afghanistan, Azerbaijan, Iran, Kyrgyz Republic, Turkey, Uzbekistan and Pakistan and ECO Secretariat. The meeting was presided over by Mr. Amjad Rafi, Chairman National Committee of ECO-CCI (Pakistan Chapter) and Chairman Specialized Committee of Trade Facilitation and Shaikh Sultan Rehman, Vice President of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI) also attended the meeting from Pakistan.

While chairing the meeting, Mr. Amjad Rafi, Chairman stated that the real challenge of trade facilitation is to minimize transaction costs and the complexity of international trade for businesses, without compromising efficient and effective levels of collection of customs revenues and other border controls. He also highlighted the pandemic situation and measures taken by the Government to minimize the risk for trade and industry. He also discussed in details the issues related to regional cooperation, SPS measures, trade cost, ECO visa sticker scheme, lack of bilateral trade agreements, intra-ECO investment, exchange of knowledge, tariff rationalization, implementation of ECOTA, ECO Trade Fair, ECO exhibition, technological transformation, Joint ventures, promotion of barter trade and opening of border gates, implementation of ECO trade transit agreement etc.

Shaikh Sultan Rehman, Vice President FPCCI emphasized on promotion of intra regional trade and investment among the ECO countries. He highlighted intra ECO tariff and non-tariff related issues which increases cost of trade. He added that expanding of trade volumes require trade liberalization, harmonization of policies, reducing the cost of doing business, financial infrastructure, economic efficiency and institutional capacity building. He stressed on the implementation of ECOTA, Agreement on Protection & Promotion of Investment, ECO Trade Facilitation agreement, ECO Visa & White card scheme. He urged the member countries to move towards export of high valueadded, medium-to-high technology exports by upgrading and diversifying their industrial structure.

Dr. Syed Yahya Akhlaq, Deputy Secretary General ECO Secretariat also updated the status of implementation of ECOTA. He further informed that the agreement will come into force after approval in the next meeting ECOTA Cooperation Council likely to be held in August 2020 and ECOTA will be implemented either in the end of 2020 or early 2021. The house also suggested the holding of training sessions and workshops regarding the imports/exports procedures among member countries. During the meeting, the participants shared the experience of pandemic and measures taken by their government for facilitating their trade and investment by their government.

# **Specialized Committee Meeting of Tourism of ECO-CCI**

The Specialized Committee Meeting of Tourism of ECO Chamber of Commerce & Industry (ECO-CCI) was held via video link and attended by representatives of the Chambers of Commerce & Industry of member countries including Afghanistan, Azerbaijan, Iran, Turkey, Tajikistan, Uzbekistan, Pakistan and ECO Secretariat. The FPCCI was represented by Sohail Lashari, Convener and Ismail Suttar, Member ECO-CCI Specialized Committee on Tourism (Pakistan Chapter) and Shaikh Sultan Rehman, Vice President FPCCI.

Shaikh Sultan Rehman Vice President FPCCI emphasized on the need of the promotion of tourism among the member countries as ECO Region is one of the world's richest in terms of historical and cultural heritage and echoes memories of the ancient Silk Road. He stated that despite various activities and events on tourism, the ECO Region still lacks a comprehensive regional strategy for sustainable tourism development. He added that to utilize the great potential of the region, diversification and easement of tourism activities, availability of quality services and visibility of the region is a necessary requirement. He also highlighted the measures taken by Pakistani Government for the promotion of tourism and visit of the royal couple Prince William and Kate Middleton (UK), the maiden visit of the Buddhist Monks, and visit of thousands of Sikh pilgrims to Nankana Sahib Birthplace through Kartarpur Corridor on his 550th anniversary attracted the international media attention.

Sohail Lashari, Convener of the Specialized Committee on Tourism of ECO-CCI (Pakistan Chapter) informed the participants about the impact of COVID-19 on tourism industry which caused losses to US\$ 300 billion globally in terms of cancellation of hotel booking, closing of restaurants, disruption of air travel and others. COVID-19, not only suspended the international tourism, it also affected the domestic tourism. Ismail Suttar Member of Specialized Committee also shared the tourism prospects and hoped the tourism activities will be resumed after the pandemic over.

During the Specialized Committee meeting on Tourism, member countries emphasized on bilateral and trilateral cooperation of tourism, enhancing the connectivity, promotion of regional tourism prospects, harmonization of visa regime, holding of ECO Tourism Forum, Investment in tourism related projects, health tourism, religion tourism, holding of tourism exhibitions, sharing of tourism aspects etc.

### **Turkey and Pakistan to Explore New Avenues of Collaboration**

Pakistan and Turkey to explore new avenues for promotion of bilateral trade, economic relations and other socio-economic sectors particularly education, health and tourism this was stated by Sheikh Sultan Rehman, Vice President of the Federation of Pakistan Chambers of Commerce and Industry (FPCCI) in a meeting with Consul General of Turkey Tolga Uçak accompanied by Trade Attache Eyyup Yildrim.

During the course of meeting, wide range of discussion and views were exchanged on various issues and matter of mutual interest. Sheikh Sultan Rehman, Vice President FPCCI particularly emphasized on the need of collaboration in education institutions. Pakistan should make use of Turkish education sector which in terms of technology and knowledge are well advanced he added. He urged that there is also scope of joint ventures possible in education sector. Pakistani students are getting higher education from UK and USA while same education of such standard is provided by Turkey. He also emphasized that Pakistan and Turkey should join hands in exploration of tourism prospects. Turkey is earning substantial foreign exchange through tourism and it is considered the six popular tourist destinations in the world. He also invited the Turkish investors for the development of infrastructure at tourist places of Pakistan.

Turkish Consul General Tolga Uçak welcome the proposals and assured that the office of Consul General would to do utmost best to take up all recommendations with Concerned Ministries and potential investors. He also emphasized on the need of intensive interaction between business communities of both countries so that new avenues could be explored.

Both sides also discussed in detail the potential of bilateral trade which is currently stood at US\$ 803 million and is in favor of Turkey. FPCCI also showed its concern over the imposition of countervailing duties and additional regulatory duties by Turkish Government on imports which has badly hurt Pakistan's export to Turkey. The meeting also discussed the signing of FTA between both countries and implementation of Strategic Economic Framework. #### Balanced and Equitable FTA between Pakistan and Turkey Urged

The Federation of Pakistan Chambers of Commerce & Industry (FPCCI) and Union of Chambers and Commodity Exchange of Turkey (TOBB) has urged upon the Governments to foster the process of signing equitable and balanced Free Trade Agreement (FTA) to unleash enormous potential available markets.

This was transpired in a joint meeting of the Board of Directors of Pak-Turkey Chamber of Commerce organized via zoom link, which was co-chaired by Mr. Amjad Rafi from Pakistan and Dr. Omar Bolt from Turkish side in presence of Ambassadors of Pakistan to Turkey Syrus Sajjad Qazi and Ambassador of Turkey to Pakistan Mustafa Yardakul who acknowledge the efforts of FPCCI and TOBB towards promotion of bilateral economic cooperation.

Speaking on the occasion, Prof. Dr. Omer Bolat, Co-Chairman TPC Forum (Turkish chapter) said that the bilateral trade between Pakistan and Turkey is very low and and mutual efforts and initiatives of both Chambers will help us achieve our goal. Mr. Amjad Rafi, Co-Chairman TPC Forum (Pakistan Chapter) emphasized on the need of early implementation of FTA for enhancement of bilateral trade as decided in the recent visit of the Head of the States of both the countries.He however was of the opinion that being competitors in textile and denim fabric, Turkey should consider concession to Pakistani products at far with these availed by EU, so that Pakistani products could made vide and help balance trade gap.

He also highlighted that there was enormous opportunities for collaboration in various sectors including tourism, education, construction, infrastructure development, health, entertainment etc. He further said that Pakistan's exports to Turkey is hampered by the imposition of countervailing duties by Turkey and the recent enhancement of custom duties on various items including textile resulting in further reduction of Pakistan's exports. He also emphasized on the need of transfer of technology in various sectors and joint ventures under CPEC. He also informed the Turkish businessmen about the low housing scheme introduced by Pakistani PM which open vistas for the construction industry. He also suggested for operational ITI known as Gul Train.

The ambassador of both the countries made comprehensive presentations on economic issues and assured their full support to the BoDs of the forum to enhance the bilateral trade to US\$ 5 billion as desired by the heads of the states. They further said that both the countries passing through Covid-19 pandemic which has badly hurt the trade of economy of both the countries reducing their economic activities. They advised to intensify interaction between the business communities of both of countries. The Board of Directors also exchanged views on various specific sectors including power, solar energy, marble, textile, tourism, education, surgical instruments, construction etc and also discussed the need of organizing business road shows, forums, and trade fairs to explore new avenues of business and investment in both countries.



He emphasized early implementation of ECO TRADE AGREEMENT (ECOTA) which was signed in 2008 and issuance of VISA STICKERS to bonafide Businessmen for easy travel as in the case of SAARC.

During the meeting, the Presidency of ECO-CCI handed over to Iran Chamber of Commerce, Industry, Mines and Agriculture and Vice Presidency to Azerbaijan Chamber of Commerce and Industry. The participants also appreciated the services of outgoing President of ECO-CCI Mr. Azarakhsh Haifizi. Moreover, the Members Chambers expressed their solidarity with the peoples of Azerbaijan who losses their life in war with Armenia. #### Seminar by Karachi Citizen's Forum on "Economic Revival of Karachi-The Way Forward"

Sheikh Sultan Rehman, Vice President FPCCI participated in a seminar on "Economic Revival of Karachi-The Way Forward" organized by Karachi Citizen's Forum.

Addressing the participants of the seminar, Sheikh Sultan Rehman said that Karachi is the economic hub of the country. No doubt, Karachi is a cosmopolitan city one of the big cities among top the world top cosmopolitans and it also welcomes everyone with open arms, but it lacks sense of ownership. Highlighting the significance of the city in the economy, he mentioned that The city accounts about half of the total collections of the Federal Board of Revenue, out of which, approximately half are customs duty and sales tax on imports. However the people of this city are struggling to manage their business and economic activities. Industrial zones/areas of this city are facing issues of sewerage waste. Combined Effluent Treatment Plants (Five mega effluent treatment plants have been designed for Karachi at the cost of Rs.12 billion to treat the industrial waste water. It was expected that the plants will be functional by June 2021.

However, due to negligence the project is yet to show any signs of commencement after a year-long delay. He also highlighted the devastated effect of the recent rain and urban flooding and demanded the government to work for the infrastructural development on war footing manner. While concluding he suggested that Karachi transformation Plan should address four important issues i.e. removal of Garbage through effective Solid Waste Management, demolish of illegal properties built on Nallahs, arrangement of Drinking water and Rebuilding of infrastructure of the city.

The event was graced by the presence of prominent businessmen and analysts from Karachi including Dr. Hafeez Pasha Saheb, Eminent Economist, Former Federal Minister for Finance, Planning, Dr. S.M. Qaisar Sajjad, Secretary General PMA and Ms. Nargis Rehman, Convener, Karachi Citizens Forum.




