**Reply by the Respondent**


Ms. Hina Mansab Khan submitted the requisite documents.

Sir,

Ms.Hina Mansab nominee of Attock Women Chamber of Commerce & Industry which is under 3(c) 2 of the trade organization act 2013. The purpose of the said organization to represent the women entrepreneurs engaged in trade / Industries / services in each administrative division. Attock women chamber of commerce & industry issued the license no 221 and can allow any member who is doing her business within the Attock district. According to Rule 11 sub rule (b) the Attock Women Chamber can grant membership only to those Businesses with Attock district.

Ms.Hina Mansab is shown as C.E.O. Laila (Pvt) Ltd which is registered with the S.E.C.P Islamabad and the head office of the said company is situated in Islamabad, the company is also assessed for the purposes of income tax at RTO Islamabad, the residence of the said nominee or the business concern is also at Islamabad. Hence Ms.Hina Mansab is not eligible to be member of the Attock Women Chamber therefore her nomination cannot be forwarded as nominee of Attock Women Chamber.

It is further. Submitted that according to the ratio decidendi settle in writ petition 4172 of 2019 the said candidate is not. Eligible to contest or be the representative of Attock Women Chamber of Commerce & Industry therefore the nomination by the said candidate (Hina Mansab Khan) may kindly be rejected.

Prayer:

In view of the above humble submissions, it is requested that as explained and prayed in the above paras, nominations of the ineligible and incompetent persons be graciously rejected from the candidate list for the post of Vice President women seat and also remove her from provisional voter list of Members of the General Body of FPCCI for the year 2021.
