**SUB: OBJECTION AGAINST THE NOMINATION OF MR. SALMAN ELAHI MALIK, CONTESTING AS
CANDIDATE OF VICE PRESIDENT OF CHAMBERS OF SMALL TRADE REPRESENTING EC MEMBER OF
PESHAWAR CHAMBER OF SMALL TRADE FOR UPCOMING FPCCI ELECTION OF THE YEAR 2021**

Objection by Appellant

Objection filed by Mr. Izhar-ul-Haq Qamar Candidate for Vice President nominated by Pakistan International Freight Forwarders Association against the nomination of Mr. Salman Elahi Malik nominated by Peshawar Chamber of Small Traders & Trade Industry for Candidate of Vice President – Small Chambers (copy attached).

Response by Election Commission

An email was sent to Mr. Izhar ul Haq Qamar and copy to Mr. Salman Elahi Malik on 16th December, 2020 requesting both to appear before Election Commission on 17th December, 2020 between 10.30 a.m. to 11.00 a.m. The objector was requested to bring evidences of objections filed and Respondent to provide the relevant documents in his defense.

Response of Appellant

Mr. Izhar-ul-Haq Qamar did not appear for personal hearing till 11.30 a.m.

Statement by Respondent

Mr. Zakaria Usman appeared on behalf of Mr. Salman Elahi Malik with authority letter. He informed the Election Commission that all requisite documents were provided to FPCCI at the time of submission of nomination papers on 27-10-2020, however the requisite documents are being provided through email to the Election Commission.

Decision of the Members of the Election Commission of FPCCI

The Appellant did not appear on the given time and date and even not responded or nominated any person on his behalf to substantiate his claim/objections on Mr. Salman Elahi Malik. However in the afternoon he requested for new hearing time by telephone. Due to paucity of time his request could not be entertained.

Whereas the Peshawar Chamber of Small Traders & Trade Industry has provided the requisite documents which are placed in the File.

On review of the objections it is pointed out that the objector Mr. Izhar-ul-Haq Qamar is the Candidate for Vice President of Association Class and he is not a voter falling in the category of Chamber of Small Traders & Trade Industry thus he is not an aggrieved person, therefore he has no justification to object on the nominations of other category, hence his objection is overruled.

Sub: **Objections against the illegal nomination of Mr. Salman Elahi Malik contesting as candidate of Vice President of Chambers of Small Traders representing EC member of Peshawar Chamber of Small Traders for upcoming FPCCI Election of the year 2021.**

Dear Sir,

With reference to the above, I would like to raise my objection on illegal nomination of Mr. Salman Elahi Malik contesting as candidate of Vice President of Chambers of Small Traders representing EC member of Peshawar Chamber of Small Traders, KPK for upcoming FPCCI Election of the year 2021. Details of my objections are as under.

- o That their Chamber of Small Traders have failed to conduct its annual election. Letter copy attached.
- o That their Chamber of Small Traders have altogether 282 members and did not qualify the total number of 500 members. Copy attached.
- o That their Chambers of Small Traders did not held any Annual General Meeting.
- o That their Chambers of Small Traders did not conduct Annual Audit of their Accounts.
- o That they did not pay their building rent from last two years.

Hence violated the provision of Trade Organizations Rules and Trade Organizations Act 2013. According to the judgment passed in W.P.No.4172 /2019, Mr. Aftab Ahmad Barlas v/s DGTO the Trade Organization who failed to follow the Rules or the Act is not eligible to participate in the FPCCI elections.

I am therefore submitting herewith the evidences, further evidences will be provided at time of hearing.

You are requested to please acknowledge my objections and reject his nomination as well as his papers submitted at FPCCI for contest of election as Vice President for the seat of Chambers of Small Traders for FPCCI Election 2021.
