On review the documents available in the File of Gilgit Chamber of Small Traders & Small Industry with FPCCI , it is cleared that Mr. Hassan Abbas is eligible to be a member of said Chamber as his permanent residence and business address is situated in Gilgit.

Further the eligibility of Section 2 (S) of TOA 2013 could not be determined at this stage.

On review of the objections it is pointed out that the objector Mr. Muhammad Salman Aslam is the Candidate for Vice President of Association Class and he is not a voter falling in the category of Chamber of Small Traders & Trade Industry thus he is not an aggrieved person, therefore he has no justification to object on the nominations of other category.

Hence the objections are overruled.

That the said person being a nominee of Private Limited Company is not eligible to contest an Election. Private Business Limited concerns cannot be a member Chambers of Small Traders as defined in Section 2(1) (S) of Trade Organization Act 2013.

That as copy of NTN taken from FBR website shown their address belong to the territory of Islamabad is not eligible to represent District Gilgat based Chamber of Small Traders.

Hence the said person does not fulfill the criteria being the member from Chamber of Small Traders is not eligible to be nominated and is also not being eligible to contest for upcoming FPCCI Election of the year 2021, in accordance with the Writ Petition No. 4172 of 2019.

You are requested to please acknowledge our objections and reject his nomination as well as his papers submitted at FPCCI for contest of election as Vice President for the seat of Chambers of Small Traders for FPCCI Election 2021.
