**Response by Election Commission**

An email was sent to Makran CCI to produce the valid license or any correspondence/relevant documents in their defense.

**Decision of the Members of the Election Commission of FPCCI**

No response was received from Makran CCI in their defense until 5.30 p.m. of 17<sup>th</sup> December, 2020.

On review of the documents available in the record of FPCCI it transpired that Makran CCI was eliminated as a voter for the Election of FPCCI 2020 and the Honorable High Court of Balochistan, Quetta had passed an Order in Civil Misc. Appeal No. (T)02/2019 dated 24.12.2019 to include the name of Makran CCI for casting the vote in FPCCI Election 2020.

The said order entitled the Makran CCI for casting vote for only 1 year i.e. FPCCI Election 2020 and no further order is available for the FPCCI Election 2021, hence the name of Makran CCI is being excluded from the List of Candidates as well as from the Voters List of FPCCI Election 2021.

- III.** **That** as per Rules 2 (g) of the Trade Organization Rules 2013, a "**Corporate Member**" means a chamber of trade organization which is either a body corporate or multinational corporation with its head office or branch office in Pakistan or sales-tax registered manufacturing concern or a sales-tax-registered business concern having annual turn-over of not less than fifty million rupees.

**That** Mr. Muhammad Amir is neither a body corporate nor a multinational corporation, not even having a sales-tax-registered manufacturing concern or a sales-tax-registered business concern having annual turn-over of not less than fifty million rupees.

His company namely the 'Humsafar Trading Company' is not even registered with the SECP (Proof attached) which means he is running fake company, hence in addition to violation of Laws of the country, he is a dummy corporate member of the Makran Chamber of Commerce and Industry.

**V.** **That** the license of the Makran Chamber of Commerce and Industry has been expired and time bar not applied for the renewal within specified time, hence this Trade organization on expired base not able to send the any nomination for the FPCCI election 2021.

Keeping in view the above information, it is kindly requested to remove the name of Mr. Muhammad Amir from Makran Chamber of Commerce & Industry from the final voters list as well as his candidacy from the Vice President in Baluchistan seat.
