
**SUBJECT: APPEAL UNDER RULE 18(6) OF TRADE ORGANIZATION RULES 2013

Dear Sirs,

1. The undersigned filed an objection against nomination of the aforementioned individual on grounds that:-
 - a. Col (R) Sadiq Sultan is serving as executive member of FPCCI currently and accordingly under Article 13 of FPCCI Article of Association he must serve one year cooling out period.
2. The Complaint is being denied for lack of evidence, however, sufficient record was provided to establish the allegation and this record is available with FPCCI.
