
Objection was not substantiated with any prudent evidences and accordingly the objection(s) are declined at this stage.







Dear Sir,

I hereby, raise the following objections on nomination of the aforementioned individual

1. Women Chamber of Commerce, Peshawar has listed Ms. Shabnum Riaz as Corporate member of its chamber. However, I would draw your attention to Rule 2(r) of the Trade Organizations Rules, 2013, requires a member of women chamber to have majority shares in a private limited company. According to the best of the knowledge Ms. Shabnum Riaz don't have majority shares in M/s Libra Private Limited and she is put to strict proof of it.
2. No sales tax number is either provided or available on record, whereas it is compulsory for a corporate member to be a registered sales tax entity

Please note in light of Islamabad High Court decision in case titled Aftab Ahmad Barlas V Director General Trade Organization and others WP 4172/2019, an individual is required to eligible to vote for the specific class in his nominating chamber, which is evident, that Ms. Shabnum Riaz fails to do so.

In the light of foregoing, you're requested to reject nomination of Ms. Shabnum Riaz from Women Chamber of Commerce and Industry, Peshawar

SUBJECT: APPEAL UNDER RULE 18(6) OF TRADE ORGANIZATION RULES 2013 AGAINST FPCCI SECRETARY GENERAL DECISION DATED 16TH NOVEMBER 2020, ON REJECTION OBJECTION AGAINST MRS. SHABNUM RIAZ

Dear Sirs,

1. The undersigned filed an objection against nomination of the aforementioned individual on grounds that the aforementioned individual is ineligible to be member of women chamber of commerce and to be member of women chamber of commerce, the company is question shall have majority women shareholders or a single women holding a clear majority of 50 percent and M/s Libra (Private) Limited whose authorized representative the aforementioned individual is, does not have majority of women shareholders.
2. The Complaint is being denied for lack of evidence, however, sufficient record was provided to establish the allegation.
3. Under the decision of Islamabad High Court, in case titled Aftab Ahmad Barlas V Director General of Trade Organization and others WP 4172/2019, an individual is required to be eligible to vote for the nominating chamber as well to be eligible to be member of general body of FPCCI.
4. Ever since, the aforementioned individual is ineligible to be member of women chamber of commerce, therefore, she cannot be nominated by Women Chamber of Commerce and Industry, Peshawar.
5. Appellant reverse right to argue further grounds at appeal stage if needed.
