Objection on the nominations of Women CCI, Karachi South: **Ms. Naheed Kamal, EC (Corporate)**
She is nominated from the Corporate Class but virtually her business name is M/s. Naheed Kamal which is neither a body Corporate nor a multinational corporation.

Ms. Nazli Abid, GB (Associates)

Is a Corporate member of the Chamber, nominee is been sent for Associates class where as he doe s not belong to Associate Class.


Ms. Tahir Naseem, EC/GB (Corporate)

Nominee from Women CCI, Lahore Division, she is nominated from the Corporate Class but virtually her business name is M/s. Tahira Enterprises which is neither a body Corporate nor a multinational corporation.

Ms. Hina Mansab, EC/GB (Corporate) nominee from Attock Women CCI, she has not provided the sale tax number where it is compulsory for Corporate member and also her both addresses are same i.e. residence and business according to rule one of the address needs to be from Attock.

Decision of the Members of the Election Commission of FPCCI:

Secretary General, FPCCI received objection on 19.11.20, after expiry of submitting last date of objection, hence the objection cannot be entertained at this stage.





I have the honor to refer to the FPCCI, **Letter/Notification No.FPCCI.EI- 2021/2020
dated 4th November 2020, issued by your honor,** regarding the provisional list of
the nominees of the Members Trade Bodies for the General Body & the Executive
Committee of the FPCCI for the year 2021.

In this connection, we would like to say that we are the nominees of the Islamabad
Women Chamber of Commerce and Industry, (Hereinafter referred to as the IWCC&I),
nominated as member of the Executive Committee and General Body of the FPCCI, as
per details given below:

- a) Ms. Naima Ansari, (EC & GB of FPCCI) (Associate),
(Entry at Sr. No.119 of the Provisional List),**
**b) Ms. Fareeda Rashid, (GB of FPCCI) (Corporate),
(Entry at Sr. No.120 of the Provisional List),**

Hence we are competent to raise and file our objections about the entries regarding the
inclusion of incompetent and ineligible persons in the provisional list of the nominees
of the Members Trade Bodies for the General Body & the Executive Committee of the
FPCCI for the year 2021.

OBSERVATIONS/OBJECTIONS:

1) That on going through the aforesaid "**Provisional List**", it appears that at Sr, **No.137 & 138 of the said "Provisional List"** the following two

Nominees have been nominated by the **Women Chamber of Commerce & Industry, Karachi South**

a) Ms. Naheed Kamal, (EC & GB of FPCCI) (Corporate),
(Entry at Sr. No.137 of the Provisional List),

The aforesaid nominees are not qualified and eligible to be included in the aforesaid "Provisional List" within the meaning of Trade Organizations Act 2013 and Trade Organizations Rules 2013, as explained below:

1) According to the aforesaid "Provisional List" **Ms. Naheed Kamal, (at Sr No.137 of the Provisional List),** is a Corporate Member of the Chamber and she is nominated from the "Corporate Class", **but virtually she does not come within the definition of corporate member as laid down under Rule 2 (1) (g) of the Trade Organizations Rules 2013,** (Hereinafter referred to as the Rules). The name of her business concern is **M/s Naheed Kamal,** which is neither a body corporate nor a multinational corporation. **Hence in terms of Rule 20 (2) (c), read with Rule 11 (7) of the Rules, she is not eligible to become nominee of the said Chamber. Accordingly her nomination be graciously rejected and the "Provisional List" be rectified accordingly.**

b) According to the aforesaid provisional list Ms.Nazli Abid (at Sr No. 138 of the provisional List is a Corporate Member of the Chamber, Nominee is been sent for associate class where as she does not belong to associate class. According to clause 2(b) associate member means a member of a trade organization which is not a body corporate or a multinational or a sales tax registered manufacturing concern or a sales tax registered business concern.

2. Ms. Tahira Naseem, (EC & GB of FPCCI) (Corporate),

Nominee from Women Chamber of Commerce & Industry Lahore division. (Entry at Sr. No.126 of the Provisional List),

The aforesaid nominees are not qualified and eligible to be included in the aforesaid "Provisional List" within the meaning of Trade Organizations Act 2013 and Trade Organizations Rules 2013, as explained below:

I) According to the aforesaid "Provisional List" *Ms. Tahira Naseem , (at Sr No.126 of the Provisional List)*, is a Corporate Member of the Chamber and she is nominated from the "Corporate Class", *but virtually she does not come within the definition of corporate member as laid down under Rule 2 (1) (g) of the Trade Organizations Rules 2013*, (Hereinafter referred to as the Rules). The name of her business concern is *M/s Tahira Enterprises*, which is neither a body corporate nor a multinational corporation. *Hence in terms of Rule 20 (2) (c), read with Rule 11 (7) of the Rules, she is not eligible to become nominee of the said Chamber. Accordingly her nomination be graciously rejected and the "Provisional List" be rectified accordingly.*

ii. Her name is not in the final voter list of Women Chamber of Commerce & Industry, Lahore for the year 2020.

iii. Her business Tahira Enterprises does not fulfill requirement of Corporate Member

iv. She is not eligible for Corporate Class membership as at the same time. She was last year Associate Member of Handicrafts Association of Pakistan.

v. Tahira Enterprises the member company of Tahira Naseem is not member of WCCI for continuous period of 2 years.

vi. She is sole proprietor of one company and partner in other. One company cannot be represented with two different names in two different trade bodies

3) *Ms. Hina Mansab, (EC & GB of FPCCI) (Corporate)*,

***Nominee from Attock Women Chamber of Commerce & Industry (Entry at Sr. No.133 of the Provisional List)*,**

No sales tax number is either provided on record, where as it is compulsory for a corporate member to be a registered sales tax entity. Under the rule clause 11 b, the prospective members business fits within the defined business scope of jurisdiction of the trade organization as provided in the

said trade organizations approved memorandum and articles of associations under the license granted by the Federal Government. Ms. Hina Mansab both addresses (House no 499 st no 109, I 8/4 Islamabad) of residence and business are same and of Islamabad Whereas according to the rule one of the address needs to be from Attock. Therefore she is not eligible to become the member of Attock women chamber and hence the nomination may not be accepted.

PRAYER:

In view of the above humble submissions, it is requested that as explained and prayed in the above Paras, nominations of the ineligible and incompetent persons be graciously rejected and the "Provisional List" of the nominees of the Members Trade Bodies for the General Body & the Executive Committee of the FPCCI for the year 2021 be rectified accordingly.
