**DECLINED**


Objection was not substantiated with any prudent evidences and accordingly the objection(s) are declined at this stage.

**Appeal by Objector**

Appeal under Rule 18(6) of TOA-2013 against SG-FPCCI decision on rejection objection against Mr. Ali Khan Achakzai. Business turnover of Mr. Ali Khan Achakzai is not sufficient enough to be a Corporate Member and does not have active Sales Tax Registration.

**Decision of the Members of the Election Commission of FPCCI:**

The basic rule to determine the Corporate member is defined in Rule 2(g) of ToR-2013 that a sale tax registered person should have the turnover more than 50 million and in the instant case the sale tax number is black list which is verified from online verification of FBR Portal, hence the nomination of Mr. Ali Achakzai excluded from the voter list of FPCCI Election for the year 2021.


I hereby, raise the following objections on nomination of the aforementioned individual

1. Chaman Chamber of Commerce has listed Mr. Ali Khan Achakzai as Corporate member of its chamber. However, I would draw your attention to Section 2(g) of the Trade Organizations Rules, 2013, which require annual turn-over in excess of Rupees fifty million to qualify as Corporate member of any chamber. Mr. Ali Khan is director of M/s Kozak Logistic (Private) Limited and it is highly unlikely that M/s Kozak Logistic (Private) Limited has an annual turnover in excess of Rupees fifty million and Mr. Ali Khan is put to strict proof of it.
2. No active sales tax number is provided, whereas, it is compulsory for a corporate member to have a sale tax registration.

Please note in light of Islamabad High Court decision in case titled Aftab Ahmad Barlas V Director General Trade Organization and others WP 4172/2019, an individual is required to eligible to vote for the specific class in his nominating chamber, which is evident, that Mr. Ali Khan fails to do so.

In the light of foregoing, you're requested to reject nomination of Mr. Ali Khan from Chaman Chamber of Commerce and Industry

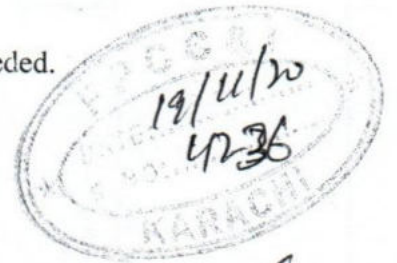

**SUBJECT: APPEAL UNDER RULE 18(6) OF TRADE ORGANIZATION RULES 2013 AGAINST FPCCI SECRETARY GENERAL DECISION DATED 16<sup>TH</sup> NOVEMBER 2020, ON REJECTION OBJECTION AGAINST MR. ALI KHAN ACHAKZAI**

Dear Sirs,

1. The undersigned filed an objection against nomination of the aforementioned individual on grounds that:-
  - a. The aforementioned individual business turnover is not sufficient enough to be a corporate member of Chaman Chamber of Commerce and Industry under Rule 2(g) of Trade Organizations Rule, 2013;
  - b. The aforementioned individual business concern don't have an active sales tax registration and the record establishes that he is blacklisted for sales tax.
2. The Complaint is being denied for lack of evidence, however, sufficient record was provided to establish the allegation.
3. Under the decision of Islamabad High Court, in case titled Aftab Ahmad Barlas V Director General of Trade Organization and others WP 4172/2019, an individual is required to be eligible to vote for the nominating chamber as well to be eligible to be member of general body of FPCCI.
4. Ever since, the aforementioned individual is ineligible to be member of corporate class of Chaman Chamber of Commerce and Industry.
5. Appellant reverse right to argue further grounds at appeal stage if needed.
