Objection was not substantiated with any prudent evidences and accordingly the objection(s) are declined at this stage


**Appeal by the Applicant**

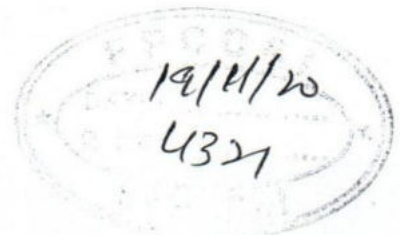

EMRAN MUNIR**


Dear Sirs,

1. The undersigned filed an objection against nomination of the aforementioned individual on grounds that:-
  - a. No record can be found against the sale tax number provided by the aforementioned individual;
  - b. Mirpur Chamber of Commerce and Industry license has expired and therefore under Article 3 of the Article of Associations Mirpur Chamber of Commerce is not eligible to nominate the member for the general body.
2. The Complaint is being denied for lack of evidence, however, sufficient record was provided to establish the allegation.
3. Under the decision of Islamabad High Court, in case titled *Aftab Ahmad Barlas V Director General of Trade Organization and others* WP 4172/2019, an individual is required to be eligible to vote for the nominating chamber as well to be eligible to be member of general body of FPCCI.
4. Ever since, the aforementioned individual to be member of general body of FPCCI on grounds that the aforementioned individual has provided an incorrect sales tax number and has defrauded.
5. Appellant reverse right to argue further grounds at appeal stage if needed.



In the light of foregoing, it is requested that the nomination of the aforementioned individual shall be rejected and the Secretary General shall be set aside.
