ADMINISTRATIVE ORDER (SOPs for Shopping Malls)

In pursuance of order dated 18.05.2020 passed by the Honourable Supreme Court of Pakistan in Suo-moto Case No. CMA 01/2020, the following SOPs and guidelines as mentioned to be implemented by the management of shopping malls/centers during the working hours as prescribed by the Home Department, Government Sindh in its order bearing No. SO(J-I)HD/8-1(04)/2020-Corona/SOPs-Shops dated 10.05.2020:

- i. No customer shall be allowed to enter the shopping malls without the face mask.
- ii. Availability of hand sanitizer for customers shall be ensured at the entry points of shopping malls.
- iii. No customer shall be allowed to enter the shopping malls without being scanned with thermal guns.
- iv. Persons with the flu like symptoms, high temperature, and dry cough shall not be allowed to enter in the shopping malls.
- v. The management of shopping malls shall reduce 1/3rd of footfall capacity in their shopping malls.
- vi. The footfall shall be digitalized to monitor the social distancing of at least 03 feet amongst the customers.
- vii. The management shall use signage throughout the premise to ensure social distancing for customers and employees.
- viii. Display instructions and awareness posters with pictorial images for workers, staff and customers at prominent places.
- ix. Persons of over 55 years and children below 12 years age shall not be allowed to enter in shopping malls.
- x. Entry & Exit points in shopping malls shall be prominently marked, displayed and strictly monitored.
- xi. The shopping malls shall be frequently cleaned with disinfectant.

All the Deputy Commissioners of Karachi Division are directed to monitor the observance of SOPs in shopping malls and take action in accordance with law and implement the directives of the Honourable Supreme Court of Pakistan.

ORDER (Pillion Riding)

No. SO(Jud-I)HD/8-1(04)/2020-Corona: In pursuance of Honourable High Court of Sindh order passed in CP # D-2249 of 2020 dated 14th May, 2020 following directions are issued for pillion riding in exercise of the powers under section 3 (1) of the Sindh Epidemic Diseases Act, 2014 (Sindh Act No. VIII 2015) and in continuation and partial modification of order of even number dated 10th May, 2020.

There will be complete ban on pillion riding except in case of family members residing in the same household (Ladies, Kids, Elderly).

There shall be no exception to this order for Law Enforcement Agencies (LEAs), Journalists/media persons, Co-workers, office staff etc.

As per Honourable High Court directions, it is clarified that these restrictions and exemptions are based on rationale for covid spread prevention as per inputs / advice of medical experts.

The rationale for exemption / restrictions is that persons of family living in same household are all exposed similarly to virus living together and there is no extra risk of sitting together of family members of same household. Whereas in case of media persons, Law enforcing agencies personnel, co-workers/ officials they live in different household and their sitting together can cause virus spread from one person to the other and then through him to his whole family, thus increasing the spread. Since the persons are in close contact with each other during pillion riding, there is increased likelihood of spread when such different persons sit together.

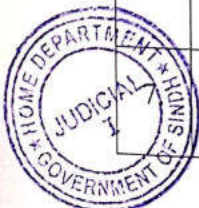

In pursuance of the Government of Sindh Notification bearing No. SO(CTC)/SGA&CD/COVID-19/Committee/2020 dated 24.03.2020 and 08.04.2020, and Committee constituted vide Home Department, Government of Sindh Notification bearing No. SO(Jud-I)HD/8-1(04)/2020-Corona dated 28th April, 2020, the sub-committee-II examined the requests/applications received from the export-oriented industries in the light of Home Department Order No. SO(Jud-I)HD/8-1(04)/2020-Corona dated 14th April 2020, wherein such industries were allowed to operate subject to the condition of ensuring adherence to SOPs bearing No. SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs dated 14th April 2020, issued by Home Department in view of COVID-19 measures.

2. Now, therefore, on the recommendations received from the Secretary, Labour & Human Resources Department / Chairman, Sub-Committee-II vide letter No. PS/SECY/LAB&HR/COVID-19/2020 dated 11th May 2020, the following export-oriented factories/manufacturing units, which are found fulfilling the criteria as per the Order and SOPs referred above {i.e. (i) Verification of export order by TDAP, (ii) Undertaking by CEO/owner on ensuring arrangements within their premises as per SOPs referred above for COVID - 19 prevention, and (iii) List of workers/staff/management who will be present/working in the premises of factory/manufacturing unit during its operation}. These units are permitted to start their operation (for export related items) subject to adherence to the SOPs.

4. It is clarified that these factories / manufacturing units are bound by the conditions, directions and processes as described in Home Department Order bearing No. SO(J-I)/HD/8-1(04)/2020-Corona dated 14th April 2020 and SOPs bearing No. SO(J-I)/HD/8-1(04)/2020-Corona/SOPs dated 14th April, 2020 respectively.

5. It is reiterated that the SOPs are put in place with a view to prevent the spread of COVID-19, therefore, **it is absolutely necessary that the SOPs are in place before the start of work as per undertaking given.** Moreover, in order to ensure timely tracking and tracing in case a positive case is detected, the required particulars of all the staff/workers/management who would be present in the premises of the factory/manufacturing unit are to be provided. The required details are name, father's name, designation, CNIC Number, residential address, cell number (if any).

ORDER - SOPs for Construction business

No. SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs-Constr. Whereas, there is a significant rise in number of Covid-19 infections, and the trend is projected to continue for the foreseeable future, whereas no treatment / vaccination / cure developed for the Covid-19 disease, whereas, there are 80% infections are asymptomatic, Government of Sindh considered it essential to take all the emergency precautions to mitigate the spread of Covid-19 contagion in the province of Sindh, it is also felt with absolute necessity that in order to ease the lockdown restrictions and facilitating normalcy to personal and business activities in the public interest while ensuring all safety precautions mitigate the spread of COVID-19 contagion.

2. Now, therefore in exercise of powers Under Section 3(1) of the Sindh Epidemic Diseases Act 2014 (The Sindh Act VIII of 2015) and in continuation of earlier orders issued vide No. SO(Jud-I)HD/8-1(04)/2020-Corona dated 14th April and 23rd April 2020, the Government of Sindh is satisfied to devise a framework through which the activities related to construction business may be regulated for opening.

3. Therefore, Government of Sindh is pleased to issue the Standard Operating Procedures (SOPs) to ensure safe work environment in which requisite activities related to the construction industry and associated sectors, as well as transportation of men, machinery and material may be carried out.

Objective:

4. The objective of these SOPs is to ensure that all construction activities during the Covid-19 Pandemic are carried out in a manner that ensures prevention of the spread of Corona Virus.

Applicability:

5. These SOPs applicable to **all activities / operations of construction industry, associated sectors as well as persons engaged therein including site managers, builders, contractors, workers, office staff, supplier, transport material/items etc.** (as far as is applicable to them) who are all required to follow the directions / instructions as related to them and there shall be no exception. Such other bodies like SBCA (for ABAD, public sector project) and Cantonment Boards to ensure compliance with SOPs within their area of jurisdiction.

6. The general directions regarding distancing measures, travel instructions, equipment, machinery, office spaces, visitors, prayer areas, canteen/eating places, residence and workplace cleanliness/ toilets shall remain the same as in previous order No. SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs dated 14th April 2020 for work place.

In addition to above following specific SOPs shall apply to construction and related activities.



A. Responsibilities of Builder / Developer / Contractor / Owner

- i) Provide an undertaking to the respective Deputy Commissioner, office regarding adherence to the SOPs and all Protocol including Emergency Response will be laid out.
- ii) Must carry out analysis of high risk areas of their workplace/site/office etc. in order to take steps as per SOPs for preventing spread of COVID-19.
- iii) ID cards should be provided to all site workers/managers to be carried while at site and while travelling to and from work.
- iv) Provision of the basic hygiene facilities like toilets, bathrooms and hand wash basins supplemented with ample supply of Soaps and hand wash to be ensured
- v) Maintain a register (Management, staff, workers, labourers whether permanent or temporarily hired etc.) engaged in any form of activity for a particular premises or site, with contact details to be maintained, which can be produced on demand readily, if so required for COVID-19 contact tracing.
- vi) On 1st day, before resuming the work on sites post lockdown period, mandatory medical check-up to be arranged for all workers, before start of work.
- vii) Entire construction sites including site office, labour camp, canteens, pathways, toilets, entry/exit gates will be disinfected after each use. Housekeeping team should be provided with necessary equipment.
- viii) In a very big construction site with over 500 employees, a doctor will be present periodically (at least once a week) at site on allotted time for screening and at other sites with 100 plus workers a medical technologist/ trained person on COVID-19 be deputed for screening.

B. Responsibilities of Site Manager/ Workers

- i) No outsider will be allowed to stay at site without following proper procedure and instructions.
 - ii) Maintain a register for workers working at the construction site with their full particulars.
 - iii) Ensure that any worker having any symptoms like cough, fever, etc. should be immediately reported to higher authority for further screening/ testing/ medical assessment.
 - iv) Ensure that workers maintain more than three feet distance between them at all times and if necessary, put floor markings etc. for such purpose.
 - v) Not more than 2/3 persons (not facing one another) should be allowed to travel in lifts or hoists and use of the staircase for climbing should be encouraged.
 - vi) Workers should not share their belongings like food, water bottles, utensils, mobile phones etc. with others.
 - vii) Workers should not shake their clothes and must change before leaving the site.
 - viii) Mode of wireless communication to be introduced where possible in order to minimize the human interaction.
- Everyone entering the site must be assessed for body temperature with a thermal gun.



- x) The number of people working at site should be minimize and instead work may be carried out in 8 hourly shifts.
- xi) More than 2 entry and exit points may be allocated to reduce rush at the exit and entry.
- xii) The principles of social distancing must be incorporated during pick and drop of the worker.
- xiii) The education regarding the manners of coughing and sneezing may be imparted.
- xiv) If the laborers are to sleep at the site then a minimum distance of 2m must be ensured between them.

C. Logistics / Equipment, Machinery, Material etc.

- i) All equipment / machinery / fixtures / Tools received shall be properly sanitized and disinfected before receipt / usage.
- ii) All construction material arriving at site should ideally be left idle for 2 days before use to ensure safe usage.
- iii) All site workers / supervisors, etc to wear proper head gear, gloves, masks, goggles, shoes. No person(s) without proper gear shall be allowed to work.

D. Waste Disposal:

- i) Any waste in human contact (used water bottles, plastic, tissue etc.) should be double bagged and properly disposed off.
- ii) Special space must be earmarked for such disposal.
- iii) Separate designated staff should be dealing with such disposal and shall not be mixing with other construction/ site workers.

Further instructions

8. As may be issued by the government for further steps necessary to contain Covid-19 spread.

9. **These SOPs / directions shall be enforceable immediately and shall remain in force till the COVID-19 emergency is specifically declared to be over by an order or this order is withdrawn.**

10. In view of importance of such measures to be fully in place for preventing spread of disease the concerned businesses / activities shall take necessary measures to have all the required arrangements fully in place before starting their operations. **The operations shall only be permitted after an undertaking by the Builder/ Developer/ Owner / CEO that all the requirements are fully in place and they are engaging in activity that is specifically permitted by the government and that they are responsible that no contravention takes place and that action can be taken under relevant laws in case of any default including closure of such place and that in case there is spread of COVID-19 due to such activity they shall be responsible for treatment/ welfare of worker/ labourers/ persons contracting the disease and any further action required for control of such spread. Such undertaking, along with the detailed particulars all the persons who will be**



working/present at any time of the operations, shall be deposited with the concerned DC of area with copies, thereof, to relevant department, such as Home, Sindh Building Control Authority, etc.

11. Any person / owner/manager engaged in any permissible activity/ operation found violating any of the instructions contained in these SOPs shall be liable for action in accordance with law as per section 4 of Sindh Epidemic Diseases Act 2014. Any builder / developer/ contractor found/ reported violating the above instructions/Standard Operating Procedures, the permission given to them during Covid-19 emergency shall stand suspended immediately and such work places may be closed.

12. Secretaries of respective departments, who are entrusted with regulation/control of respective activities/function related to above as well as respective divisional Commissioners are empowered under Section 3(1) of said Act to issue further orders, directions, notices to put this order into effect in letter and spirit and to clarify further for implementation purpose (but not allow what is not permitted or disallow what is permitted). Any action required to be taken under this order may be taken if deemed necessary by taking representative of concerned business Association (to be nominated by the concerned President).

13. A team of officers / inspectors of administration, department concerned, duly authorized by Deputy Commissioners or Secretaries concerned, Director General Sindh Building Control Authority may check the place any time for compliance of directions issued by Government.

14. Deputy Commissioner, Assistant Commissioner, Officers of Sindh Building Control Authority, Labour Officer concerned as well as personnel of Law Enforcement Agencies not below the rank of Inspector Police (or of equivalent rank for other Law Enforcement Agencies are empowered under Section 3(1) of the said Act to take any legal action on any Act in contravention of this order or directions/notices issued there under. Further legal action can also be taken under relevant Labour, Industrial and other applicable laws.

ORDER – SOPs FOR RETAIL SHOPS /SMALL TRADERS

No. SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs-Shops. In view of the spread of corona virus and resulting disease (Covid-19) and deaths worldwide and also due to increasing number of cases in Pakistan as well as in Sindh the Government of Sindh passed orders from time to time under the Sindh Epidemic Diseases Act 2014 (The Sindh Act VIII of 2015). In this regard, the Home Department, Government of Sindh imposed restrictions on all activities save essential services / office / industry. Whereas, the threat of Corona virus spread has still not vanished and the restrictions on social distancing and precautionary measures are still required to be in place. Whereas, there is also a need to balance such restrictions viz-a-viz economic effects of such ban and restriction on the movement and gathering of people and to facilitate economic activities within these restrictions.

Now, therefore in exercise of powers Under Section 3(1) of the Sindh Epidemic Diseases Act 2014 (The Sindh Act VIII of 2015) the Government of Sindh issues following **SOPs (Standard Operating Procedures) to be adopted by the persons and businesses-concerns that are specifically permitted to operate during the Covid-19 pandemic** (after signing and displaying due undertaking given for adherence to the SOPs) so that the spread of corona virus and resulting disease and deaths are prevented.

Objective:

The objective of these SOPs is to ensure that the small businesses/ retailers/ shops, that are specifically permitted to operate during Covid-19 situation, conduct themselves in a manner that prevents spread of Covid-19. That the businesses/ shops are run through trained / sensitized staff in a manner that helps contain the virus spread.

Applicability:

These SOPs for retailers / small shops / traders and also applicable to showrooms, customer service centres are responsibility of all such Owners/Proprietors / CEOs / Manager-in-charge and such individuals running the business and managing such sale points **that undertake to conduct their business according to these SOPs** and shall be applicable to all persons engaged in such business including **Owners, Proprietor, as well as their staff/workers etc.** who are all required to follow the directions / instructions and there shall be no exception. These are also applicable to Customers who are visiting such places and who, in case of any violation/default on their part, can be proceeded against under relevant laws.

The General SOPs for conduct of any permissible business at any workplace / workspace issued earlier vide order number SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs dated 14th April 2020 shall apply for staff travelling, staff awareness/conduct, workplace management/ cleanliness/ distancing, goods handling and transportation etc. to the fullest as applicable to these businesses/shops.

Timings for business:

Monday to Thursday from 8:00 am to 4:00 pm



ORDER – SOPs FOR RETAIL SHOPS /SMALL TRADERS

Page 1 of 5

A. Responsibility of Proprietor / Owner

Any person who is proprietor, owner, manager, in-charge or person responsible for any shop, outlet, showroom, business center, has to ensure following:

- i) It shall be the responsibility of Proprietor / Owner to ensure **compliance of SOPs/ directions**, as well as other applicable directions issued by the Government from time to time.
- ii) Further necessary **instructions / protocols may be prepared for the staff** in the light of these SOPs for ensuring compliance by all concerned.
- iii) Following documents should be signed and prominently displayed at the entrance of shop.
 - a. An **undertaking** regarding adherence to the SOPs (that they have ensured compliance as per SOPs and made such arrangements, that they shall be responsible for adherence to the SOPs issued vide this order and earlier SOPs dated 14th April 2020, that along with the undertaking list of all persons including themselves with full particulars are given, that they shall be responsible for all their subordinate staff/workers to adhere to all the SOPs for workplace, that they shall provide necessary distancing space, masks, gloves, sanitizers and frequent hand washing facilities at the workplace/ during the duty hours.)
 - b. **list of persons** including themselves as well as their staff/workers/ delivery persons/ others who may be present during any time for working at their workplace(s) giving their required particulars (name & fathers name, CNIC, residential address and Contact/cell number) for purpose of tracing/tracking in case anyone tests positive.
 - c. **Absence of such undertaking/list or an improper undertaking or incomplete list of persons engaged in such business shall be construed as violation of the SOPs and shall be liable for action.**
- iv) **All the staff / persons at the premises shall be properly briefed** on the Covid-19 spread, preventive steps / precautions against the spread of the virus, sign / symptoms etc. and that all the precautionary measures are followed by all present within such premise / site / workplace.
- v) **Display at prominent places the instructions and awareness posters** in Urdu, Sindhi and English (as per language commonly read/understood) for workers and staff. Where necessary pictorial version of instructions and awareness posters may be used for labour class.
- vi) **Must Provide face masks, disposable gloves** to the staff.
- vii) **Should not allow any customer / visitor without a mask**
- viii) Sufficient availability of **hand-sanitizers or ideally hand washing facility** to be ensured at the workplace for all the staff/workers to use.
- ix) That the practice of **handshake and greetings by physical contact** in any manner is actively discouraged among worker / staff or greeting the customer. Instead, greetings by way of waving hands or bowing or paying respect by folding both hands as per social and cultural norm should be advised.
- x) **Persons with flu like symptoms**, high temperature, dry cough etc. should not be allowed.
- xi) **Persons of old age, high risk / co-morbid (diseases) should be encouraged to use on-line / on phone order / delivery method.**
- xii) **As far as is possible online/ on phone mechanism of taking orders and delivery must be employed** and ensured following SOPs as issued for online/ecommerce vide order of same number dated 25th April, 2020.
- xiii) **In case any staff /worker shows signs of flu like illness** the owner/management shall ensure to immediately notify district health authorities and get that labour/employee screened/tested and follow relevant SOPs for suspected cases.
- xiv) **If the virus spread amongst the worker/staff or community** due to such business activity the owner / management shall accordingly take all necessary measures including suspension of activities till clearance given by Health Authorities.



- xv) **Owner, / Proprietor / CEO shall be responsible for treatment / welfare of worker / laboures** / persons contracting the disease and any further action required for control of such spread.
- xvi) **Random tests for Covid-19** may be conducted by health authorities from time to time.
- xvii) In case, of **any positive case** and required further testing for other contacts of any positive case the expenses will be borne by the owner/CEO/Management.
- xviii) Shop owner to **maintain a daily log of medical history** and other symptoms of each staff and delivery rider.
- xix) In case of flu, temperature & cough, the **employee must be quarantined** forthwith and should not be allowed to enter into work place. He must be tested on expenses of employer.
- xx) Owner must have ready **information in place to respond**, should a rider be diagnosed with the virus and inform local medical authority/District Control room/Deputy Commissioner.
- xxi) **No person/customer/staff shall be allowed** inside the premises who is not wearing a mask or **not adhering to distancing measures or not cooperating to implement SOPs**. In case of any issue such incident/matter be immediately reported to district administration control room / police station / security/ LEAs on duty.
- xxii) Such directions for the customer shall be **prominently displayed by posters/ short videos** displaying precautionary measures.
- xxiii) Such sale premises with smaller shops shall ensure that **entry and exit points** are prominently displayed in a manner that people coming for shopping may not collide with each other. That there is enough space that people while walking are able to keep over three feet distance and such **markings may be placed on the floor/wall inside shop and also outside for waiting customers**, if any.
- xxiv) Such premises / shop should have the **number of persons pre-calculated according to space** available (calculated as per space available for public and the condition of having persons with over three feet distance between them). Such maximum capacity of persons inside the premises/ shop **should be displayed on the poster at prominent place at the entrance**.
- xxv) **Dedicated staff may be deployed, where necessary, for ensuring distancing and limited** number inside premises. Such staff at the entrance points may guide /hold the other persons/customers entering the premises / shop if the space is already full.
- xxvi) Such floor **markings/ distancing queues** (like holding shopping trolley to keep distance) should be employed where necessary.
- xxvii) In case of shops in narrow alley, or where necessary for social distancing, a **one way flow of customers/staff** should be maintained and **separate entry and exit points clearly marked** with arrows indications/markings/posters to guide the direction of such flow of customers/ visitors.
- xxviii) **Frequent cleaning with disinfectant** (0.5% chlorine solution or other standard disinfectant) of all **frequently touched surfaces**, handles, trolleys etc. shall be ensured. In case of more customer flow / big shop / premises a dedicated staff may be deployed to ensure frequent cleaning with disinfectant.
- xxix) Owner / Manager himself or in case of big establishment a **dedicated staff** providing hand sanitizing for incoming customers / visitors is strongly recommended.
- xxx) It is also suggested the shops in a building/ in vicinity may **collectively take steps** or respective association of that area to ensure compliance with SOPs. It will be easier to share burden for jointly arranging Thermal gun, dedicated staff for customer guidance / queuing, floor markings for waiting customers/visitors outside shops or posters, videos etc. for awareness among customers.

B. Cleanliness and other SOPs related to work premises / work place

As per SOPs issued earlier vide Order No.SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs dated 14th April, 2020 which shall be ensured as far as applicable to shops/ sale points.



It is reiterated that the premises should be properly ventilated. Air-conditioning should be avoided, however if necessary due to location / nature of work then must operate with 100% fresh air intake instead of recirculated air.

Any person / owner / manager engaged in any permissible activity/ operation found violating any of the instructions contained in these SOPs shall be liable for action in accordance with law as per section 4 of Sindh Epidemic Disease Act 2014 as well as any other applicable law including Labour and Industrial laws, etc. Any business unit / shop / store / found / reported violating the above instructions / Standard Operating Procedures, shall have the permission given to them during Covid-19 emergency suspended immediately and such work places may be closed.

Secretaries of respective departments viz. Industries, Labour, etc. who are entrusted with regulation / control of respective activities / functions related to above as well as respective Divisional Commissioners are empowered under Section 3(1) of said Act to issue further orders, directions, notices to put this order into effect in letter and spirit and to clarify further for implementation purpose (but not allow what is not permitted or disallow what is permitted). Any action required to be taken under this order may be taken if deemed necessary by taking representative of concerned Industrial Association (to be nominated by the concerned President).

A team of officers / inspectors of administration, Industries and Labour Department duly authorized by Deputy Commissioners or Secretaries concerned may check the place any time for compliance of directions issued by the Government.

Deputy Commissioner, Assistant Commissioner, Labour Officer concerned as well as personnel of Law Enforcement Agencies (LEAs) not below the rank of Inspector Police (or of equivalent rank for other Law Enforcement Agencies are empowered under Section 3(1) of the said Act to take any legal action on any Act in contravention of this order or directions / notices issued there under. Further legal action can also be taken under relevant Labour, Industrial and other applicable laws.

This order shall come in force with immediate effect and shall remain in force till further orders.

ORDER

No: SO(Jud-I)HD/8-1(04)/2020-Corona: **Whereas** there is a declared pandemic of COVID-19 that has afflicted many countries including Pakistan which requires adequate steps to contain the spread of this disease. That in order to contain the disease the Government of Sindh imposed gradually increasing restrictions on social gatherings /crowds starting from 14th March, 2020. That in order to have a uniform lockdown strategy at National level an order of even number dated 2nd April, 2020 was issued as per coordination meetings of National Coordination Committee (NCC). Similarly certain decisions were taken about the lockdown during the meeting of NCC dated 07th May, 2020 after reviewing the overall situation including disease spread and economic effects of lockdown.

Whereas the Government of Sindh considers that it is necessary to have a uniform policy as also directed by the Honorable Supreme Court of Pakistan in its order dated 04th May 2020 in Suo-Moto case no. 01/2020. Therefore as per decisions taken during the NCC meeting, after due consultations of federating units with the Federal Government at the NCC, certain businesses are allowed conditional to their following the SOPs against Covid-19 spread as the disease spread has not yet subsided but the economic impacts warrant controlled opening of businesses where the SOPs are strictly followed so as to contain the disease spread.

Now therefore in view of above considerations the Government of Sindh in exercise of powers under Section 3(1) of the Sindh Epidemic Diseases Act 2014 (The Sindh Act VIII of 2015), and in continuation of order of even number dated 14th April and 23rd April 2020, hereby directs as under:-

1. All restrictions/bans, timings and exceptions shall continue as per earlier Order number No: SO(Jud-I)HD/8-1(04)/2020-Corona dated 14th April, 2020 and continued vide Order of same number dated 23rd April, 2020. Accordingly, all the closures/bans, restrictions on movement from 5:00 pm to 8:00 am on all days, restrictions on movement by personal transport, declared essential services and permitted industries / businesses with applicable restrictions, as in these orders, shall continue with the exceptions as are given in this order.

A. Sectors that would continue to remain closed:-

- All industries / businesses not cleared for opening
- Shopping malls / Plazas
- Educational Institutions
- Offices not cleared for opening
- Marques, Marriage halls, Banquet halls, cinemas
- Public processions / gatherings/congregations of all nature at any place
- Organized events, sports, concerts etc.
- Restaurants, Hotels, Social Clubs (Except Home delivery which is permitted and driver hotels situated on highways)
- Entertainment areas, beaches, public parks.
- Public Transport (Intra-city, Inter-city, Inter-provincial)



B. Sectors that are open/ being opened subject to their strictly following the SOPs:-

(i). **Activities / businesses already permitted** vide earlier orders of even number dated 14th and 23rd April, 2020

(ii). **Construction activities** permitted with strict following of SOPs issued vide order No. SO(Jud-I)HD/8-1(04)/2020-Corona-SOP-Constr dated 14th April 2020 and dated 10th May 2020.

(iii). **Construction related manufacturing** permitted to start subject to the following of SOPs issued vide order No. SO(Jud-I)HD/8-1(04)/2020-Corona-SOP dated 14th April 2020.

- a) Pipe Mills (PVC and Steel)
- b) Electrical Cable and switchgear manufacturing
- c) Steel / Aluminum manufacturing including re-rolling mills
- d) Ceramic manufacturing
- e) Paint factories
- f) Carpenter / Furniture shops
- g) Real estate
- h) Retail shops related to construction manufacturing

(iv). **Community Markets/ Retail outlets, Stand-alone /Neighborhood shops situated in residential localities** (excluding shops situated in shopping Malls, Plazas) subject to strictly following of SOPs issued vide Order. SO(Jud-I)HD/8-1(04)/2020-Corona-SOP-Retail dated 10th May 2020.

- a) The timings shall be from 8:00 am to 4:00 pm, Monday to Thursday.
- b) The following shall however continue to remain closed.

Barber shops/ Beauty Parlours/hair cutting saloon/Spas
Game centre/Videogames/Dabba/Carrum/Pool Games shops
Gyms/Café/Sit-in-eatery
Also social clubs and parks

2. **Fridays, Saturdays and Sundays are declared as "Safe days", with 100% lockdown** except the essential like persons requiring emergency medical care, personnel of law enforcement agencies, Medical and allied staff, technical staff attending electricity, gas, water, sewerage related works and Municipal staff on duty, Goods transport, charity organizations limited personnel engaged in ration distribution / relief work in coordination with District Administration and Law Enforcement agencies, Postal/ Courier services, Milk shops selling dairy products, newspaper distribution, media persons, medical stores within or adjacent to hospitals. Moreover Grocery/General stores, bakeries, chicken/meat/fish shops, fruits/vegetable shops can remain open from 8:00 am to 5:00 pm.

3. **Hotspots of Covid-19/ High risk neighbourhoods / areas** as declared by the Health Department / District Administration through an order by the Commissioner / Deputy Commissioner may continue with the strict restrictions as may be determined including strict lockdown and non-opening of non-essential shops/manufacturing in such area till the spread is contained

4. Responsible behaviour:-

While the gradual opening up of businesses and related activities is undertaken in line with the National guidelines as per decisions at NCC and for the sake of uniformity within country as also done by other provinces it becomes more of Public responsibility to comply with the distancing and preventive measures against Covid-19 spread. It requires care, concern, discipline and above all patience to conduct oneself in such situation of more opened-up activities when the cases show a rise. This calls for new life style and pattern of living as the definitive treatment or vaccine for the Corona virus causing Covid-19 is not yet available and may take many months to a year or more to become available. Thus, it calls for adjusting work, social and economic activities as per SOPs to prevent the spread of Covid-19. Thus It is of utmost importance that the general public in general and the owners / managers of shops / workplaces, businesses and manufacturing units in particular ensure adherence to General SOPs issued vide order No. SO(Jud-I)HD/8-1(04)/2020-Corona-SOPs dated 14th April, 2020 and other specific SOPs as are issued from time to time so that the disease spread is contained.

It is pertinent to declare that the Government of Sindh would continue to review the disease spread pattern periodically and in case of increased COVID-19 cases beyond the health facilities / capacity of health care systems the relaxation in lockdown may be reviewed and may be reversed or it may be further relaxed in case the disease is contained.

With the above advisory it is reiterated that any person / owner / manager engaged in any permissible activity/ operation found violating any of the instructions contained in the detailed order and SOPs as referred is this order shall be liable for action in accordance with law as per section 4 of Sindh Epidemic Diseases Act 2014. Any business unit/ shop/ store/ manufacturing or non-manufacturing unit found/reported violating the instructions/Standard of Operation Procedures, shall be proceeded against in accordance with law and may have the permission given to them during Covid-19 emergency suspended immediately and such work places may be closed.


Secretaries of respective departments viz. Industries, Labour, Food/Food regulatory Authority, Health etc. who are entrusted with regulation/control of respective activities/function related to above as well as respective divisional Commissioners are empowered under Section 3(1) of said Act to issue further orders, directions, notices to put this order into effect in letter and spirit and to clarify further for implementation purpose (but not allow what is not permitted or disallow what is permitted). Any such order/direction/notice is to be issued by fully taking onboard the respective Law enforcing agencies / Police to ensure proper implementation mechanism.

A team of officers / inspectors of administration and /or duly authorized representatives of concerned departments under intimation to the Commissioner/ Deputy Commissioner concerned, industries and labour department duly authorized by Deputy Commissioners or Secretaries concerned may check the place any time for compliance of directions issued by Government.

Deputy Commissioner, Assistant Commissioner, Labour Officer concerned as well as personnel of Law Enforcement Agencies not below the rank of Inspector Police (or of equivalent rank for other Law Enforcement Agencies are empowered under Section 3(1) of the said Act to take any legal action on any act in contravention of this order or directions/notices issued there under. Further legal action can also be taken under relevant Labour, Industrial and other applicable laws.

This order shall come into force at once and shall remain in force till 31st May, 2020.





ADMINISTRATIVE ORDER

In pursuance of the Home Department's Order No. SO(I-I)HD/8-1(04)/2020-Corona dated 02.04.2020, it is hereby ordered that:

3. No joy riding is allowed and anyone coming out must have a valid reason to do so.
4. No home delivery / take away of any sort is allowed from restaurants / fast food shops.
5. In the Industrial zones, all Industries related to essential services such as food, pharmacy and related packaging are allowed. Only exporting manufacturers are allowed to process their manufactured goods out of their industry while no new manufacturing of non-essential items is allowed during lock down.
6. E-commerce activity related to essential items (food and medicines) carried out through recognized courier services shall be allowed in the territorial jurisdiction of Karachi division.
7. All persons having symptoms of Corona Virus (COVID-19) shall immediately report to the Health Department, Government of Sindh Control Room in the office of Commissioner, Karachi Division Contact No: (021) 99204452, (021) 99206565, (021) 99204439, (021) 99204451, Whatsapp No: 0316-0111712 and/or 1166 (Federal Government's helpline).

All the Deputy Commissioners of Karachi Division are directed to enforce the orders in letter and spirit, and further take decisions in coordination with the concerned Deputy Inspector General of Police and Senior Superintendent of Police to resolve day to day issues in public interest.

ORDER

Whereas the Corona Virus spread and increase in COVID-19 cases has been seen worldwide causing devastating consequences and illness and deaths resulting from it. That social distancing measures and such precautionary measures are seen to decrease the COVID-19 cases and resulting deaths. That Government of Sindh issued orders from time to time earlier to avoid unnecessary and avoidable movement of public in order to contain the spread of disease.

That after careful considerations of the situation and the spread of disease and further deliberations in National Coordination Committee the Government is satisfied that such restrictive measures adopted are necessary to continue for some time to contain the spread of disease and break the chain of spread of virus.

Now therefore in exercise of powers under section 3(1) of Sindh Epidemic Diseases Act 2014 (The Sindh Act VIII of 2015) and in supercession of all previous orders hereby issues following directions, regulations and necessary measures to be observed and adopted by all the concerned businesses, general public etc.

Complete Closure/Ban

- 1) All educational institutions i.e. schools, colleges, medical colleges, technical and vocational institutes, Universities (both public and private), coaching centres, madaris (already closed till 31st May, 2020).
- 2) Shopping Malls, Cinema Halls, Marriage Halls, Banquet Halls, Marques, Lawns, clubs, hotels, halls, auditoriums, Farm Houses, Beaches, Electronic Markets, Showrooms, Boutiques, Beauty Parlors, Luxury items & Outlets etc.
- 3) Entertainment areas where public gathers including but not limited to Farm Houses etc, Beaches like Sea View, Hawke's bay, Sandspit, Paradise Point, etc.
- 4) Religious & social congregations, ceremonies, functions, gatherings of all kind,
- 5) Gathering on Shrines, Public Visitors meeting prisoners.
- 6) Intercity and Inter-Provincial Public Passenger Transport (Goods transport of essential / permissible items to continue).

Restriction on Congregational Prayers

Only 3 to 5 persons designated for mosque (like Pesh Imam, Moazzin, Care-Taker) will offer Namaz by Jammāt including Juma prayer and that the General Public will offer their prayers / Namaz at their respective homes as per directions and guidance from the religious scholars (as per consideration in order No. SO(J-1)/HD/8-1(04)/2020-Corona dated 26.03.2020). Except last rites like funeral, burial etc. while adopting social distance and attending by close family members only and after informing local SHO of area.

These restrictions on such religious gathering apply in similar manner to religious places of other religions.

Partial Ban / Opening of shops etc from 8:00 am To 5:00 pm – all activities / movements

- a) All shops & manufacturing units etc, including General / Convenience / Grocery Stores, eatable food items and related manufacturers, suppliers and others in supply chain. Medical stores situated in Malls and Superstores **except** those Medical Stores situated within or adjacent to Hospitals / Health Facilities.
- b) Fresh milk shops may be open from 05:00 am to 08:00 pm.
- c) Pet shops opening from 12:00 Noon to 2:00 pm by owner/manager & helper for only feeding of pets kept therein (no sale etc allowed)

Note: There shall be complete ban on all public movement & activities from 12:00 pm to 03:30 pm on Friday. Which may resume from 03:30 pm till 06:30 pm (for Friday only)

Ban / Restriction On Movement Of People from 5:00 pm to 8:00 am

Ban Not applicable to

- Person requiring emergency medical care.
- Law enforcing agencies personnel.
- Doctor, medical & related staff providing attending emergency services.
- Technical staff attending electricity, gas, water, Sewerage related emergencies / services, cleaning municipal staff when on duty.
- Persons on good transport carrying essential goods / permitted service's related items with one helper / cleaner (no passenger allowed on goods transport)
- Newspaper sorting & distribution may start from 05:00 am.

Restrictions on movement of persons by transport

- Move/travel singly with over 3 feet distance between persons.
- Maximum two persons in car (one more allowed in case sick person requiring attendant).
- Staff/Labor for permissible activities on travel in Company Vehicle with clearly marked banner/displaying showing Company / Office / Factory name such that staff/labor is seated at a distance from one another (about 1/3 of seating capacity) and adopted precautions.
- Carry ID Card / Service Card during movements to show to LEAs.

Essential Items / Services to operate

No other Industry or service to operate except

- **Food and related** shops / manufacturers / distributors and all related in chain like wheat & rice, pulses, bardana etc. Seeds, fertilizers, pesticide, fish, meat, vegetable / fruit, dairy, poultry, poultry feed and related activities in chain & related shops, stores, godowns, manufacturers and transport etc.
- **Agriculture and related** activities including harvesting etc and related use of Thrashers, Tractors their repairs / maintenance etc.
- **Health and related** services Hospitals, Laboratories, Pharmacies, Drug Stores, Manufacturing, packaging, transport etc i.e. all within value / supply chain items of personal hygiene like Soaps, Sanitizers & disinfectants etc.
- **Electricity, Gas, Oil, LPG, Power Generation (Solar, Wind, Bagasse etc) Production** Generation, distribution, storage where applicable and related maintenance activities.
- **Essential Municipal Services, Water Supply** (including Water Tankers, Sewerage, Solid Waste)
- **Transport of Goods & Essential Items** (Food and medicine & emergency services materials supplies).



- **Welfare Organizations** duly registered / permitted for distribution of ration / relief goods in coordination with District Administration and LEAs.
- **Public & private telecom / cellular companies'** technical staff for maintenance with limited admin staff.
- **Call Centres, Customers support centres** with no customers including 24 hours helpline for cellular, telecom, mobile / internet banking and bill payment with minimal staff.
- **Technical Staff** of Cellular companies (for repair / maintenance of towers/cables & related services) with minimal admin staff.
- **Banks** with minimal essential staff.
- **Newspaper, Printing, transport & distribution.**
- **Port Operations, PNSC, Custom and IRS** essential staff.
- **Media** persons on duty.
- **Railway freight** services and their essential staff.
- **Petrol pumps & related services, oil tankers, LPG, transport, storage** etc.
- **Postal / courier** services.
- **Sindh Government Administration & essential staff** vide notification of SGA&CD 18.03.2020 (Officers of closed department to remain on call at their respective places of duty for any further duty/assignment).
- **PSPC & NSPC** (Pakistan Security Printing Corporation & National Security Printing Company) printing fresh currency notes, etc.
- **SECP** related activities and Pakistan Stock Exchange with stress on online / work from home environment.

Transport of Goods

- No ban on transport of food or medical related items and permissible goods.
- No ban on transportation to other provinces from their godowns / port to such province (Such warehouses, godowns can be opened and loading takes place by informing local Deputy Commissioner Office).
- Transport of imported items from Port.
- Transport of export items (one time permission) that are ready to ship from godown/storage (no factory opening / new production allowed).
- Transport from Karachi Port may leave for distribution during night hours for inter-provincial goods using Northern bypass route.

Directions for owner / employers / manager

- i) Employers of industries and commercial entities concerning essential commodities (food) and medicines and other related activities in supply chain are to ensure that the employees maintain safe distance and adopt pre-cautionary measures at work place.
- ii) Employer / Manager of permissible commercial entity, dealing with customers, are to ensure that adequate space is available inside the store, factory, godown etc. and the customers/staff are maintaining safe distance and adhering to precautions. Floor markings and volunteers may be required to guide the flow of the people in queues.
- iii) Employer shall also ensure that any employee complaining or having symptoms of Corona Virus (COVID-19) shall be tested, isolated and reported as per practice in vogue.
- iv) Owner / Employer / Manager will be held responsible in case of failure to comply with the above orders.



Special directions on Suspects / Positive Cases of COVID-19.

- 1) All those persons who have been declared positive of Corona Virus shall immediately isolate themselves at Home under intimation to relevant health teams of Health Department or in specified isolation centers established by the Government, and shall remain in isolation till complete recovery.
- 2) All the public / private hospitals / laboratories / health centers, attending Corona Virus patients / conducting Corona Virus laboratory diagnostic test shall send report to Health Department, Government of Sindh twice a day (0100 hrs and 1300 hrs) on Fax No. (021) 99222837 with immediate effect.
- 3) All persons having symptoms of Corona Virus (COVID-19) shall immediately report to the Health Department, Government of Sindh Control Room Contact No. (021) 99204452, (021) 99206565, 0316-0111712 and / or 1166.

Commissioners and Deputy Commissioners of the respective Division and Districts in the province are empowered to further issue any orders, directions or notices for clarifying or putting directions of this order into effect in **coordination and consultation with respective DIGs and SSPs and corresponding officer of Pakistan Rangers at Division / District level**, while issuing such directions, notices or orders in the light of Orders issued from Home Department, Government of Sindh, from time to time.

Any person disobeying any direction or order issued under this order or any person facilitating, in any manner, the defiance of this order issued under the Sindh Epidemic Diseases Act shall be deemed to have committed an offence punishable under section 188 of the Pakistan Penal Code as provided under Section-4 of the said Act.

Deputy Commissioners and Assistant Commissioners as well as personnel of Law Enforcing Agencies above the rank of Inspector or equivalent are empowered under Section 3(1) of the said Act to take any legal action on any contravention of this order or the directions/orders/notices issued there under including action under Section 188 of Pakistan Penal Code.

This order shall come into force at once and shall remain in force till 14th April, 2020.

Subject: WAIVER OF DEMURRAGE AND DETENTION CHARGES

Kindly refer to this Directorate's letter of even number dated 14.03.2020, regarding COVID-19 pandemic leading to complete sealing of Western Border of Pakistan with Afghanistan and Iran w.e.f. 16.03.2020, at Chaman and Torkham causing halt of movement of forward transit containers destined for Afghanistan.

2. A number of requests have been received from the Afghan Traders, various Associations and the Consulate General of Islamic Republic of Afghanistan-Karachi, informing about the mounting axe of demurrage and detention charges on containers stuck-up in Ports of Pakistan and the Customs Border Stations at Chaman and Torkham due to closure of Western Border, with the request to intervene for looking in to the grievance of Afghan Traders and liaising with concerned authorities for finding out the way to waive off demurrage and detention charges.

3. This Directorate General, in order to gauge the magnitude of cost drew out data of containers which are stuck-up in Pakistan due to closure of Western Border. Following statistics contain details of containers lying at different ports since 16.03.2020:-

4. In addition to the above, approximately 1618 containers are either stranded en-route to Chaman or are stacked inside Railway Yard Chaman; similarly, around 440 containers are either stranded en-route to Torkham or are stacked inside NLC Terminal Jamrud / Torkham. The moratorium on Transit Trade activity at Western Border has resulted in tremendous difficulties being faced by Afghan Traders and other stakeholders due to anticipated escalation in cost of doing business.

5. The National Emergency situation which has led to halt of activity at Western Border, calls for relief measures to mitigate the miseries of the traders, Pakistan Customs being the vanguard agency which promotes trade facilitation works continuously to remove bottlenecks in smooth operation of trade flow. Since Afghanistan is a landlocked neighboring country which predominantly relies on Pakistan for facilitating its trade volume under the Afghanistan Pakistan Transit Trade Agreement, 2010, it is incumbent upon the stakeholders in Pakistan to extend assistance in eliminating the hardships occurring as a consequence of special situation like the COVID-19 pandemic which has affected more than 190 countries across the globe and led to sealing of international borders.

6. It is, therefore, requested that the Terminal Authorities may allow waiver of demurrage on all containers lying at the port since 16.03.2020, till such time all containers have crossed border after resumption of trade activities at the Western Border. Likewise, the Shipping Companies / Association may like to waive the container detention charges which will accrue on the containers after stipulated period of free days.

ORDER

No. SO(Jud-I)HD/8-1(04)/2020-Corona: Whereas, there has been a need to take further preventive measures in wake of increasing Corona Virus cases (COVID-19) in Sindh, therefore, the Government of Sindh, in exercise of powers conferred Section 3(1) of the Sindh Epidemic Diseases Act 2014 (The Sindh Act VIII of 2015), and in continuation of earlier Order of even number dated 22.03.2020, is satisfied that it has become extremely urgent and important to implement following **additional measures** for the purpose of breaking the chain of spread of the virus:

- 1) No industry, except that is related to essential food items and medical and related items for domestic consumption is allowed to operate at any time of the day.** Those industrial units / establishments etc, making / producing / packaging etc, any non-essential items / items unrelated to health and food shall close their operations as unnecessary gathering of factory workers and their movement in mass numbers seen during the day is posing greater threat of spread of disease.
- 2) Government offices and other essential services offices, which are allowed vide earlier Order, shall operate only with bare minimum staff / technical staff.**
- 3) There shall be strict ban on movement of persons from 8:00 p.m to 8:00 a.m and:**
 - a) All grocery / convenience / general / departmental stores (earlier allowed) will remain closed during this time.
 - b) No medical stores (except those situated within / adjacent to public / private hospitals) are allowed to operate during this time.
 - c) Movement of any person is strictly not allowed during this time except in medical emergency or staff responding to issues related to essential services like electricity, gas, emergency and hospital staff.

This Order shall come in force **w.e.f. 25.03.2020** and shall remain in force for a period of thirteen days.

The Government of Sindh in exercise of powers under section 3(1) read with 3(3) of the said Act further empowers Commissioners and Deputy Commissioners of the respective Districts and Division in the province of Sindh to issue any further orders, directions or notices in coordination with respective DIGs and SSPs for the implementation of this order in letter and spirit.

Any person disobeying any direction or order issued under this Order or any person facilitating, in any manner, the defiance of this order issued under the Sindh Epidemic Diseases Act shall be deemed to have committed an offence punishable under section 188 of the Pakistan Penal code as provided under Section 4 of the said Act.

Deputy Commissioners and Assistant Commissioners as well as personnel of Law Enforcing Agencies above the rank of Inspector or equivalent are empowered under Section 3(1) of the said Act to take any legal action on any contravention of this order or the directions / orders / notices issued there under including action under Section 188 of Pakistan Penal Code.

MINUTES OF THE MEETING OF COMMITTEE ON ISSUES RELATED TO IMPORTERS AND EXPORTERS UNDER THE CHAIRMANSHIP OF ADDITIONAL CHIEF SECRETARY HOME DEPARTMENT ON 25-03-2020

A Meeting of Committee constituted vide SGA&CD Notification bearing No. SO(CTC)SGA&CD/COVID-19/COMMITTEE/2020 dated 24th March 2020, to redress and resolve any issues of Importers and Exporters was held under the chairmanship of Additional Chief Secretary, Home Department, and attended by Secretary, General Administration Department and Secretary Labor Department at 1400 hrs on 25.03.2020.

2. The Secretary, Labour & Human Resources Department shared informed that as the Government of Sindh has already issued Order for the closure of non-essential industries and services vide Order dated 22.03.2020, since then a number of employers approached his office with request that the export oriented factories may be allowed to function, because they have already received orders from foreign clients and/or their product stock is ready for shipment. He further apprised the Chair that those employers are advised to first ensure social distancing as per Government of Sindh and World Health Organization (WHO) guidelines in transportation for their workers and at workplace. Since then, 50 such requests have been received at his office so far, wherein it has been assured by the exporters that they will adhere to guidelines issued by Government of Sindh and WHO time to time for COVID-19 regarding transportation and workplace safety and ensure all necessary precautions, and will not raise finger at Government of Sindh in any inadvertent situation. He also informed the issues raised by the importers with regards to ensure the consistent supply of essential food medical related items during the lockdown.

3. The Secretary, General Administration apprised the chair regarding global scenario in wake of COVID-19 outbreak and its general impact on industries, supply chains, and other businesses.

4. After threadbare discussions, with the concurrence of Chair, following decisions were made:

CIRCULAR

In pursuant to Ministry of National Food Security & Research, Government of Pakistan letter No. F-1-1/2020-DFSC-I dated: 22-03-2020 all the stakeholders are informed that Department of Plant Protection (DPP) being a regulatory body enforcing Plant Quarantine Act 1976 & Rules 1967 and Agriculture Pesticides Ordinance 1971 & Rules 1973, is allowed to continue operations (inspection, treatment & certification of agriculture based commodities e.g Food, Seed & Pesticides) pertaining to imports and exports. The concerned law enforcement agencies are requested that not to restrain the movement of registered fumigators as they can continue their activities for disinfecting the containers / consignments under International trade, being important and essential services on or behalf of DPP. The Registered fumigators are advised to ensure compliance with safety SOPs against COVID-19 laid down by the Government in respect to their movements. Moreover, your officials must keep and present original attested copy of registration certificate issued by DPP along with company identity cards and CNIC to law enforcement agencies when and where required.

SUBJECT: CLARIFICATION

I am directed to refer to this department order no. SO(Jud-I)HD/8-1(04)/2020-Corona, dated 22nd March, 2020, regarding exemption of ban on movement of people related to Essential Services and clarify as under

2. Any activity within supply chain related to the declared essential services is covered, like transport, distribution, storage, printing and packaging etc. related to such products/ services like for example POL (transport, storage) Poultry (feed etc.) etc etc. which are activities related to the declared essential services. Private security agencies / guards on duties related to essential services (those guards deployed at home / personal security may be exempted by concerned SP / SSP, if found necessary).
3. Call centers and their staff, providing essential services related to IT, Banks, Mobile Banking and Bill payment without contact with customers and with bare minimum of essential staff at work place to have such services running are covered in the above mentioned order.
4. Postal/ courier services with bare essential staff for essential services including delivery of pension at doorsteps and Pakistan Security Printing Corporation (printing/ paper/ ink factories) supplying fresh currency notes to Banks and replacing the old ones and required to operate with bare minimum/ essential staff.
5. The Securities & Exchange Commission of Pakistan, Pakistan Stock Exchange, Central Depository Company of Pakistan, National Clearing Company of Pakistan and related office staff working online / from home environment along with minimal admin staff at work place for such activities are deemed to be covered.

6. Charitable organizations, in addition to those mentioned in the said order, supplying food and necessary items to the needy are deemed to be exempted, who may all, including those earlier mentioned, may undertake their operations after due submission of their credentials as well as plan of activities to the Deputy Commissioners of their respective districts. They are to ensure that there is no rush and grouping of people during such activities and the ration is distributed to individual households at doorsteps. Concerned SSsP and Deputy Commissioners are to ensure, that there is no rush/ gathering of people during such distribution activities.

7. It is reiterated that under the order issued dated 22nd March 2020 which places ban/ restriction on social interaction, gathering and movement of people to prevent the spread of Corona virus, that the heads of respective offices/ organizations/ establishments so exempted are to ensure necessary steps for social distancing, provision of hand sanitizers and frequent hand washing facilities and practices at work place. Legal action is warranted in case of any contravention of the order.

8. It is also pertinent to clarify that pillion riding on motorbikes which will increase the virus spread manifolds is strictly not allowed.

9. No activity which is not related to the services declared as essential is allowed at any cost.

ORDER

No: SO(Jud-I)HD/8-1(04)/2020-Corona: Whereas there has been an increase in the number of Corona Virus cases (COVID-19) in Sindh and that this increase, as has been seen worldwide, is expected to rise exponentially if adequate preventive measures are not taken mainly being the prevention of social contact and gatherings in any form and that further steps are required to step up the restrictions and closures for the purpose of breaking the chain of spread of the virus.

Now, therefore, in exercise of powers under Section 3(1) of the Sindh Epidemic Diseases Act 2014 (The Sindh Act VIII of 2015) and in continuation of earlier orders of even number dated 14th March, 2020 and 17th March, 2020, the Government of Sindh is satisfied that it has become extremely urgent and important to prevent mixing/gathering/meeting of people by taking extreme measures in order to contain the spread of COVID-19 and therefore imposes ban on the movement and the gathering of people in order to prevent spread of virus from social contacts for a period of 15 days w.e.from 23.03.2020 starting at 12:00 on the same date.

There shall be a complete ban on movement of people including Intercity or Inter-Provincial Travel or gatherings of any kind foreption religious, social or any other purpose at any place public or private including all offices, public or private situated within the territorial limits of province of Sindh except the following:-

- 1) Personnel related to Health \Services like Hospitals, Laboratories and Medical stores.
- 2) Personnel related to Law Enforcing Agencies enforcing / implementing this order.
- 3) Personnel related to Essential Services / Offices going to perform their duties or providing essential services as declared in later part of this order.
- 4) People in need of medical care with an attendant.
- 5) People going to buy grocery and medicines.
- 6) Necessary / unavoidable religious rites like the last rites, Namaz-e-Janaza, Burial and related events provided that all precautions against spread of disease are taken and a safe distance of 01 metre (3 feet) is maintained between people gathered in small numbers / close family members after prior intimation to SHO of the area. Assistant Commissioner and SDPO of the area will supervise and as and when necessary provide added force /manpower for compliance.
- 7) Any exemption that may be deemed necessary by the Government

Following conditions will apply to the persons given exemptions:

- a) To travel in single number in vehicle but may carry one more as attendant in case there is some medical emergency but in no case more than three.
- b) One person per family may go out to buy essential medicines, grocery, etc. with the driver in case of elderly or handicapped.

- c) Person on vehicles carrying essential food items, such products from mill/factory, medicines, medical equipment with only helper / cleaner allowed on vehicle with no passenger allowed on such vehicle.
- d) Persons so travelling/ coming out as exempted are to carry valid ID Card / CNIC and official card or such authority letter duly signed and stamped by the Head. They are further required to travel & gather at work keeping in view social distance (1 metre / 3 feet) & taking safety precautions against the spread.
