



Decision of the Members of the Election Commission of FPCCI:


The document provided by Mr. Muhammad Farooq Shaikhani nominee of Hyderabad Chamber of Small Traders and Small Industry does not prove whether he is eligible to be termed in the category of Small Traders/Industry, therefore his nomination is excluded from the Voter list of FPCCI Election for the year 2021. He may appeal to the DGTO with his tax return to prove his eligibility.


I hereby, raise the following objections on nomination of the aforementioned individual

1. Hyderabad Chamber of Small Traders and Small Industry has nominated Mr. Muhammad Farooq Shaikhani who has listed himself to be in business of builder and developers, an activity which requires a substantial amount of capital and investment and accordingly the scale of activities of Mr. Shaikhani makes it clear that Mr. Shaikhani does not falls within the in definition of traders, and industry which is a pre-requisite for small traders and industry under Section 3(2)(f) of Trade Organization Act 2013. Accordingly, Mr. Shaikhani is outrightly ineligible to be member of small traders associations

Please note in light of Islamabad High Court decision in case titled Aftab Ahmad Barlas V Director General Trade Organization and others WP 4172/2019, an individual is required to eligible to vote for the specific class in his nominating chamber, which is evident, that Mr. Shaikhani fails to do so.

In the light of foregoing, you're requested to reject nomination of Mr. Muhammad Farooq Shaikhani from Hyderabad Chamber of Small Traders and Small Industry


Dear Sirs,

1. The undersigned filed an objection against nomination of the aforementioned individual on grounds that:-
 - a. The aforementioned individual is nominated by a chamber of small trades and industry and the scope of his business concern M/s Mian Zafar & Co is large scale which does not fall within the scope of small traders as defined under Section 3(2)(f) of Trade Organization Act 2013, making him ineligible to be member of small traders chambers at outset
2. The Complaint is being denied for lack of evidence, however, sufficient record was provided to establish the allegation.
3. Under the decision of Islamabad High Court, in case titled Aftab Ahmad Barlas V Director General of Trade Organization and others WP 4172/2019, an individual is required to be eligible to vote for the nominating chamber as well to be eligible to be member of general body of FPCCI.
4. Ever since, the aforementioned individual is ineligible to be member of general body of FPCCI on the basis of aforementioned basis.
5. Appellant reverse right to argue further grounds at appeal stage if needed.
