
I hereby, raise the following objections on nomination of the aforementioned individual

1. Rawalpindi Chamber of Traders and Small Industry has nominated Mr. Muhammad Akram who is in business of manufacturing of footwear which is costly setup to install and run, and accordingly does not falls within the in definition of traders, and industry which is a pre-requisite for small traders and industry under Section 3(2)(f) of Trade Organization Act 2013. Accordingly, Mr. Muhammad Akram is outrightly ineligible to be member of small traders associations

Please note in light of Islamabad High Court decision in case titled Aftab Ahmad Barlas V Director General Trade Organization and others WP 4172/2019, an individual is required to eligible to vote for the specific class in his nominating chamber, which is evident, that Mr. Akram fails to do so.

In the light of foregoing, you're requested to reject nomination of Mr. Muhammad Akram from Rawalpindi Chamber of Small Traders and Small Industry

**SUBJECT: APPEAL UNDER RULE 18(6) OF TRADE ORGANIZATION RULES 2013
AGAINST FPCCI SECRETARY GENERAL DECISION DATED 16TH
NOVEMBER 2020, ON REJECTION OBJECTION AGAINST MR.
MUHAMMAD AKRAM**

Dear Sirs,

1. The undersigned filed an objection against nomination of the aforementioned individual on grounds that:-
 - a. The aforementioned individual is nominated by a chamber of small trades and industry and the scope of his business concern is large scale which does not fall within the scope of small traders as defined under Section 3(2)(f) of Trade Organization Act 2013, making him ineligible to be member of small traders chambers at outset
2. The Complaint is being denied for lack of evidence, however, sufficient record was provided to establish the allegation.
3. Under the decision of Islamabad High Court, in case titled *Aftab Ahmad Barlas V Director General of Trade Organization and others* WP 4172/2019, an individual is required to be eligible to vote for the nominating chamber as well to be eligible to be member of general body of FPCCI.
4. Ever since, the aforementioned individual is ineligible to be member of general body of FPCCI on the basis of aforementioned basis.
5. Appellant reverse right to argue further grounds at appeal stage if needed.



In the light of foregoing, it is requested that the nomination of the aforementioned individual shall be rejected and the Secretary General shall be set aside.
