Appeal by the Appellant



M/S All Pakistan Custom Agent Association provided the following documents against objection.


1. Valid Custom agent License Number.

Decision of the Members of the Election Commission of FPCCI:


As per section 6 TOA-2013 the application for renewal of license should be filed 90 days prior to the expiry of the license but the same has not been provided and the Association has not provided the updated membership list for the confirmation that the nominee falls under the category of Corporate member as per objection raised by the Syed Minhaj Ud Din, Representative, All Pakistan Commercial Exporters Association, hence the trade body is excluded from the Voter List of FPCCI Election for the year 2021

SUBJECT: APPEAL UNDER RULE 18(6) OF TRADE ORGANIZATION RULES 2013 AGAINST FPCCI SECRETARY GENERAL DECISION DATED 16TH NOVEMBER 2020, ON FAILING TO MAKE ANY DECISION IN OBJECTION AGAINST MR. MUHAMMAD AMJAD CHAUDHRY

Dear Sirs,


1. The undersigned filed an objection against nomination of aforementioned individual on aforementioned grounds:-
 - a. The aforementioned individual does not have an active taxpayer number, whereas it is compulsory for a corporate member under Rule 2(g) of Trade Organization Rules 2013 for a member of corporate class to have a sales tax registration;
 - b. Turnover of the aforementioned individual is less than Rs. Fifty million which makes him ineligible for nomination under corporate class
2. Whilst considering the complaint of the undersigned to carry weight, the Secretary General has sought comments from aforementioned individual, however, has failed to make any decision upon the objection submitted by the undersigned
3. Rule 18(5) of Trade Organization Rules 2013 requires the Secretary General to decide within five days from the receipt of the complaint and accordingly, the Secretary General is duty bound to make a decision within five days. In case, the respondent to the objection fails to submit any comments, the Secretary General shall decide the objection *ex-parte* on the basis of the objection of the undersigned or by according to the undersigned hearing to further substantiate the objections. However, the Secretary General has failed to decide within time stipulated by the law.
4. Considering the fact that the undersigned made a prima-facie case which compelled the Secretary General to seek comments from the respondent to the objection, who has failed to provide any comments to the satisfaction of the Secretary General. Accordingly, the nomination of the aforementioned individual shall be rejected on this ground
5. Appellant reverse right to argue further grounds at appeal stage if needed. Appellant further reserve right to add supplementary grounds if ever the matter is decided by the Secretary General



Dear Sir,

I hereby, raise the following objections on nomination of the aforementioned individual

1. No active sales tax number is provided, whereas, it is compulsory for a corporate member to have a sale tax registration. According requirement of corporate member set under Rule 2(g) of Trade Organization Rules 2013 is not complied with
2. M/s Macafat International does not have an annual turnover in excess of Rupees fifty million, therefore, under Rule 2(g) of Trade Organization Rules 2013, Mr. Muhammad Amjad Chaudhary cannot be nominated as corporate member

Please note in light of Islamabad High Court decision in case titled Aftab Ahmad Barlas V Director General Trade Organization and others WP 4172/2019, an individual is required to eligible to vote for the specific class in his nominating chamber, which is evident, that Mr. Muhammad Amjad fails to do so.

In the light of foregoing, you're requested to reject nomination of Mr. Muhammad Amjad Chaudhry from All Pakistan Custom Agents Association.
