
**Decision of the Members of the Election Commission of FPCCI:**

Dear Sir,

I hereby, raise the following objections on nomination of the aforementioned individual

1. Habib Jamal proprietor of M/s Habib & Co is listed on the suspended list of FBR in regard to sales tax registration. Accordingly, someone who is listed on suspended list is illegible to be a voting member of any chamber or association
2. Mr. Habib was not on the voter list for the association for year 2019-2020, therefore suggesting that he has not completed his two years in association and in line of Islamabad High Court Judgement referred below, he is not eligible to be nomination to FPCCI

Please note in light of Islamabad High Court decision in case titled Aftab Ahmad Barlas V Director General Trade Organization and others WP 4172/2019, an individual is required to be eligible to vote for the specific class in his nominating chamber, which is evident, that Mr. Habib fails to do so.

In the light of foregoing, you're requested to reject nomination of Mr. Habib Ajmal from Faisalabad Chamber of Small Traders and Small Industry

**SUBJECT: APPEAL UNDER RULE 18(6) OF TRADE ORGANIZATION RULES 2013 AGAINST FPCCI SECRETARY GENERAL DECISION DATED 16<sup>TH</sup> NOVEMBER 2020, ON REJECTION OBJECTION AGAINST MR. HABIB AJMAL**

Dear Sirs,

1. The undersigned filed an objection against nomination of the aforementioned individual on grounds that:-
  - a. Name of the aforementioned individual is not listed in the voters list of the nominating association for the year 2019-2020 and in the light of Islamabad High Court judgement it is necessary for the person to be eligible to vote at nominating association for him to be nominated in the General Body of FPCCI
2. The Complaint is being denied for lack of evidence, however, sufficient record was provided to establish the allegation.
3. Under the decision of Islamabad High Court, in case titled Aftab Ahmad Barlas V. Director General of Trade Organization and others WP 4172/2019, an individual is required to be eligible to vote for the nominating chamber as well to be eligible to be member of general body of FPCCI.
4. Ever since, the aforementioned individual is ineligible to be member of general body of FPCCI on the basis of aforementioned basis.
5. Appellant reverse right to argue further grounds at appeal stage if needed.



In the light of foregoing, it is requested that the nomination of the aforementioned individual shall be rejected and the Secretary General shall be set aside.
