Business Forum stressed on improvement of connectivity in all D-8 countries as connectivity is the basis of economic integration by interaction.

- 8. The current Covid-19 outbreak is volatile and its impact on the economy is uncertain. The pandemic impacted lives and global economy. In this situation, D-8 Business Forum stressed on developing an innovative collaboration mechanism among D-8 member states particularly in health sector. The Business Forum shall also endeavour for extensive collaboration for sharing best practices, lessons learned, knowledge and technology.
- Business Forum shall endeavour to strategize trade recovery through D-8 value chain initiatives of technology transfer, business process, applied skills, science and technology, industry academic linkage, maximizing D-8 nations' impact within each other and beyond based on shared resources and knowledge.
- 10. Business Forum stressed on involvement of technologies to facilitate trade, investment, production and supply. Present technology trends are dominated by areas such as Fin-tech, Ed-tech, Clean-tech, Health-tech, Agri-tech, e-commerce, etc amongst others. - 11. Business Forum emphasized on mechanization, digitization and automation in both quality and quantity of agri production and food security. Meaningful collaboration in the areas of farm-mechanization, food processing, and fisheries and aquaculture would be given priority.
- 12. Business Forum emphasized to work on potential marine resources for the sustainable evolution of blue-based commercial products. Sustainable use of these marine-based natural products would help in modern-day applications of pharmaceutical and food industries.
