

FPCCI has the pleasure to invite applications for **46<sup>th</sup> FPCCI Export Awards** for the year 2021-2022 (July-June). As you are aware FPCCI export awards are considered highly prestigious at home and abroad and the recipients of FPCCI Awards enjoy an exalted position in international markets and are recognized as high profile exporters of the country.

As per tradition, the FPCCI Export Awards will be presented by a VVIP Personality at a usually impressive function attended by Parliamentarians, Bureaucrats, Foreign Diplomats, Leading Businessmen and the Social Elite. The event is expected to be held in month of February 2022.

Applications are invited for the following Categories of Awards, latest by:

**Monday, 16<sup>th</sup> January 2023**

#### **1. PRIDE OF PAKISTAN EXPORT AWARD**

The **Pride of Pakistan Export Award** will be given to a Group of Company / Organization whose overall export performance is the highest in the country during the year 2021-2022 (July to June) in any one or more of the categories of **(i) General Services (ii) Investment** or **(iii) Export** not less than 15 Billion Rupees (please submit documentary proof for this category of award), indicating foreign exchange earned during 2021-2022 (July-June) as per terms & conditions of the application.

#### **2. PREMIER OF PAKISTAN EXPORT AWARD**

The **Premier of Pakistan Export Award** will be given to a Group of Company / Organization whose overall export performance is the highest in the country during the year 2021-2022 (July to June), not less than 10 Billion Rupees (please submit documentary proof for this category of award), indicating foreign exchange earned during 2021-2022 (July-June) as per terms & conditions of the application.

#### **3. BUSINESSMAN OF THE YEAR GOLD MEDAL**

**Businessman of the Year Gold Medals** will be given to Leading Businessmen in sub-sectors of the following Categories during the year 2021-2022 (July to June), who have earned foreign exchange during 2021-2022 (July-June), not less than 5 Billion Rupees, as per terms & conditions of the application. Complete documentation and proof / evidence in support shall be required for each category of Gold Medal:

- (i). **Export:** Export to Traditional Markets/New Markets, by the Company/Organization/Multinational Company (whose branch office in Pakistan).
- (ii). **Services:** (1) Airline & Aviation (2) Banking & Financial Services (3) Buying Houses (4) Freight Forwarding & Logistics (5) Foreign Exchange Earnings (6) Hotel & Tourism (7) Housing & Construction (8) Insurance (9) Leasing (10) Ports & Shipping (11) Pre-shipment Inspection (please submit documentary proof for this category of award).
- (iii). **IT & Telecom:** (1) Call Centers (2) Computer Marketing & Networks (3) Infrastructure Development (4) Software Development (5) Telecommunication (6) Web Development.
- (iv). **Investment:** Foreign / Local Investment (establishment of New Units / Industries in Pakistan), by the company or group of companies (please submit documentary proof for this category of award).

#### **4. BEST LADY EXPORTER TROPHY**

To encourage **LADY EXPORTERS**, FPCCI awards a TROPHY to a lady entrepreneur who may be Chief Executive / Proprietor / Managing Director / Director and has the credit of highest overall export performance in any item during 2021-2022 (July-June), having earned foreign exchange during 2021-2022 (July-June), not less than 2 Billion Rupees, as per terms & conditions of the application. The performance shall be judged on the basis of the exports of one single company and not of a group of companies.

#### **5. BEST EXPORT PERFORMANCE AWARDS**

The **Best Export Performance Awards** will be given to those Companies whose export performance in any of the Products / Items in the list of **Annexure-A**, is the highest in Pakistan as per terms and conditions, during the year 2021-2022 (July – June), not less than 500 Million Rupees.

#### **6. SPECIAL EXPORTER AWARDS**

FPCCI awards **SPECIAL EXPORTER AWARD** to those exporters, whether commercial or industrial, who have earned foreign exchange during 2021-2022 (July-June), not less than 500 Million Rupees, in any item as per terms & conditions of the application.

#### **7. BEST REGIONAL EXPORTER AWARDS**

This Category of Awards is open to Group of Companies, besides individual companies whose overall Exports is the highest during the year 2021-2022 (July-June), not less than 250 Million Rupees, to one or more of the following Regions/Groups/FTA Countries:

**(i) Export to Asia (ECO, SAARC, ASEAN) OR ANY OTHER TRADING GROUP**

FPCCI in order to encourage exports to the Asia Region has introduced three Awards for the highest overall exports in value to the following Trading Blocs in Asia:

- (a) **ASSOCIATION OF SOUTH EAST ASIAN NATIONS (ASEAN):** Brunei Darussalam, Cambodia, Indonesia, Laos, Malaysia, Myanmar, Philippines, Singapore, Thailand, Vietnam.
- (b) **ECONOMIC COOPERATION ORGANIZATION (ECO):** Afghanistan, Azerbaijan, Iran, Kazakhstan, Kyrgyzstan, Tajikistan, Turkey, Turkmenistan, Uzbekistan.
- (c) **SOUTH ASIAN ASSOCIATION FOR REGIONAL COOPERATION (SAARC):** Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Sri Lanka.

**(ii) Export to Africa, South America, Australia**

FPCCI encourages exports to the following non-traditional / not fully exploited areas and regions and will distribute three (3) separate awards for the highest overall exports in value to the following destinations:-

- (a) Africa
- (b) South America (including Central American States)
- (c) Australasia (Australia, New Zealand and Papua New Guinea)

**(iii) Export to FTA / PTA Countries**

FPCCI encourages exports to countries with whom Pakistan has entered into Free Trade Agreements (FTA) and Preferential Trade Agreements (PTA). It will reward the highest overall exports in value to the following countries with whom; Pakistan has signed FTAs:

- (a) Indonesia (PTA)
- (b) Iran (PTA)
- (c) Malaysia (FTA)
- (d) Mauritius (PTA)
- (e) People's Republic of China (FTA)
- (f) Sri-Lanka (FTA)

**The proof of Exports to the above regions or groups / continents / FTA / PTA Countries, along with summary of Items / Products exported is required. Separate Application (Annexure C) for each of the above destinations, who have earned foreign exchange during 2021-2022 (July-June) as per terms & conditions of the application**



## 8. MERIT EXPORTER AWARDS

FPCCI awards MERIT EXPORT AWARDS TO RECOGNIZE EFFORTS FOR EXPORTS OF TRADITIONAL ITEMS, AS WELL NON-TRADITIONAL ITEMS TO NEW MARKETS. The exporters may apply in the following categories:

- b. Traditional Items to New Markets.
- c. Non-Traditional Items to New Markets or any other Market.

**Note:**

- i. 'Traditional Items' means the items / products listed in Annexure 'A'.
- ii. 'Non-Traditional Items' means the products / items not listed in Annexure 'A'.
- iii. 'New Markets' means the markets / countries where the items / products declared by the applicant to have been exported, were not exported by the applicant earlier to that destination / market.
- iv. All such applicants are required to submit a 'Certificate' from the Customs Authority that the Traditional / Non-Traditional Items are exported first time to the new Market (Country to export) during the year 2021-2022, not less than 100 Million Rupees by the applicant.
- v. **In case the Products / Items have been exported for the first time to any market from Pakistan, the FPCCI reserves the right to consider application of such exporter(s).**

## 9. YOUNG ENTREPRENEURS EXPORTER AWARDS

FPCCI awards YOUNG ENTREPRENEURS AWARD TO ENCOURAGE AND PATRONIZE THE YOUNG EXPORTERS. The basic condition of the Award is that the Chief Executive, Proprietor or Partner should not be more than 40 years of age and the export performance in any particular item in **Annexure 'A'**, during 2021-2022 (July-June), not less than 50 Million Rupees.

**NOTE: EACH APPLICANT FOR THE FPCCI'S EXPORT AWARDS WILL BE REQUIRED TO FURNISH ITS EXPORT PERFORMANCE IN ACCORDANCE WITH THE PROFORMA (SEE ANNEXURE D). ONLY THOSE COMPANIES WILL BE ELIGIBLE FOR AWARD, WHICH APPLY IN THE PRESCRIBED MANNER.**

**FPCCI EXPORT AWARDS FOR 2021-2022 (JULY-JUNE) WILL BE GOVERNED BY THE RULES AND REGULATIONS FRAMED BY FPCCI IN THIS BEHALF. A COPY OF THE RULES AND REGULATIONS APPROVED BY THE AWARDS COMMITTEE OF FPCCI IS ENCLOSED HERewith FOR GUIDANCE AND COMPLIANCE (SEE ANNEXURE B).**

1. Applications for participation in the FPCCI Export Award for 2021-2022 shall be submitted on the prescribed form, the specimen (Annexure C) of which has been furnished to all constituents of FPCCI and available on FPCCI Website i.e. www.fpcci.org.pk
2. After scrutiny of applications and issuance of selection letters for Export Awards in any or for various categories / items, each application should submit Advertisement / Contribution in the form of Bank Draft/Pay Order drawn in favour of the FEDERATION OF PAKISTAN CHAMBERS OF COMMERCE & INDUSTRY, as per the following slabs.
3. The applicants must submit their applications according to the following minimum export performance of the each category, they are applying.

Each applicant shall submit detailed statement showing Volume of Exports / Services along with the prescribed application form (Annexure C) duly filled in for the period 2021-2022 (July-June) in respect of the concerned item(s) / Services, authenticated and verified by the concerned bank(s). The application should be supported by the following documents:
  - I. FPCCI Application Form duly filled-in, see Annexure 'C' (for all Applicants).
  - II. Bank Certificate duly attested by two Bank Officers (applicable to export / service related applicants).
  - III. FPCCI Export Awards Pro-forma (see Annexure 'D'), duly attested by the concerned bank(s) (applicable to export / service related applicants).
  - IV. Application / contribution fee through Demand Draft / Pay Order favoring "The Federation of Pakistan Chambers of Commerce & Industry (FPCCI)" (for all Applicants).
  - V. Bill of Lading (B/L) (on requisition/demand, if necessary).
5. All those Companies / Group of Companies, who are applying in Award Category 1(iii) or 2(iv) in Investment, are required to submit proof of Investment (Foreign / Local).
6. The Export Award shall be received by the Chairman, Chief Executive, Managing Director, Proprietor or Director or a person duly authorized to receive the award of the recipient Company.
7. Selection of Award Winners will be made by the Awards Committee of FPCCI.
8. It is compulsory for each Award Applicant on submission of Application, to give the following material in advance:
  - a. Advertisement material (full page color, Size 8x11", alongwith USB & Color Page Advertisement) of your Company (to be printed in Export Awards Souvenir).
  - b. Citation/Brief History of your Company to be published in Export Awards Souvenir (Not more than ½ printed page)
  - c. Color photograph (Size 5x3") which was taken on the occasion of last FPCCI Export Awards function (45<sup>th</sup> FPCCI Export Awards) with brief caption on the back of the photograph. If your company was not the Export Award Winner in preceding year, you can send the photograph of the Export Awards Function held in the earlier year(s) (if any), or any photograph of honor, otherwise FPCCI will print your advertisement in the specified area.
  - d. **Soft material on USB of Corporate Advertisement (11x8" – Landscaped)** to be displayed on SMD / Digital Screen during the event.
  - e. **Soft Image on USB of Logo** of your Organization, which will be displayed on the SMDs / Digital Screen.
  - f. **FPCCI will present a Certificate** to your Company. Please provide full name of your Company / Organization in application form.
  - g. Name and Designation of the person who will receive the Export Award (only Chairman, Chief Executive, Managing Director, Proprietor or Director or a person duly authorized shall receive the Award of the recipient Company) along with the copy of the CNIC.
  - h. FPCCI will issue **2 complimentary Invitation** Cards to the Recipient Organization for the event. Please share his / her name, designation alongwith CNIC number.
9. If a company fails to complete all the requirements of the awards, FPCCI has the right to reject or accept the company for the award by the approval of Award Committee of FPCCI.
10. Once the selection for the award is made or the letter of selection is issued to the company, the Advertisement / Contribution amount deposited will become non-refundable under all circumstances.
11. The decision of the FPCCI Award Committee with regard to the selection of Award Winner shall be final and binding on all concerned and it shall not be challengeable / contestable in any court of law. FPCCI reserves the right to accept or reject any application for FPCCI Awards without assigning any reason.
12. The FPCCI reserves the right to demand any further proof regarding the documents submitted in support of the claim of the awards.


