Reference letter No. Nil dated Nil, received in FPCCI Head Office Karachi on 10th November 2023, filed by Complaint, Mr. Ehteham Zaman, Attock Chamber of Commerce & Industry, on the nominees of Corporate and Associate Class of subject Chamber.

The hearing was held in FPCCI Head Office Karachi and the Consuls of Complainant(s) and the Respondent(s) also attended and represented on their behalf. Arguments were advanced by both the parties, after going through the said arguments and the documents referred/ submitted, my finding are as follows;

Corporate Class Nominee

1. No Proof of mandatory Turn Over of Rupees Fifty Million shown or submitted by the Respondent (Corporate).
2. That the nominee has not provided the Active Sales Tax status as the same is shown to be suspended since July 2013. Nor any proof of turnover has been produced or submitted.
3. The website was checked by the office of FPCCI, the same was found functional. However, neither the list of Membership was available nor the Membership verification could be accessed.
4. The judgment referred by the complaint is fully applicable in this complaint.
