Reference letter No. Nil dated Nil, received in FPCCI Head Office Karachi on 10th November 2023, filed by Mr. Kamran Riaz, Nominee from Pakistan Chemical & Dyes Merchants Association, raising various objections on Mian Shahid Iqbal, nominee on GB (Associate) nominated by All Pakistan CNG Association.

2. The License of the Association is valid upto 8th May 2026, issued by the Ministry of Commerce.
3. The Association has provided all the basic documents as required for the verification of Member nominated.

Decision of the Secretary General:

The nomination of Mian Shahid Iqbal, Nominee on GB (Associate) from All Pakistan CNG Association is valid and found well in order for needful inclusion in the Provisional List of Voters issued on 4th November 2023. Moreover your objections are not substantiated with any prudent evidences and accordingly your objection(s) are declined.
