Reference objection letter received in FPCCI Head Office Karachi on 10<sup>th</sup> November 2023, filed by Mr. Muhammad Ali Farooq, nominee of Pakistan Electronics Manf. Association, on the inclusion of the nominees Mr. Mamoor Khan, EC&GB (Associate) and Syed Minhaj ud Din Shah, GB (Corporate) from All Pakistan Commercial Exporters Association of Rough & Un-Polished Precious & Semi-Precious Stones.

The hearing was held in FPCCI Head Office Karachi and the Consuls of Complainant(s) and the Respondent(s) also attended and represented on their behalf. Arguments were advanced by both the parties, after going through the said arguments and the documents referred/ submitted, my finding are as follows;

1. That the nominees have completed two years valid membership of trade organization, as has produced, membership Certificate from the year 2021 of the said Association.
2. The Nominee from Corporate has produced Sales Tax Registration Certificate and also produced Tax Return Copy, which shows that his turn over is more than Rupees Fifty Million
