
Subject: OBJECTIONS UNDER RULE 18(4) OF THE TRADE ORGANIZATIONS RULES 2013, UPON THE NOMINATION SENT BY HARDWARE MERCHANTS ASSOCIATION OF MR. NADEEM A. KUSHTIWALA (ASSOCIATE CLASS)

Reference objection letter dated 10th November 2023, received in FPCCI Head Office Karachi on the same date, filed by Sh. Omer Sarfraz, nominee of Pakistan Steel Pipe Industry Association, raised objections on Mr. Nadeem A. Kushtiwala, nominee on EC&GB (Associate) of Pakistan Hardware Merchants Association.

The Consul of the objector, raised serious allegations on Pakistan Hardware Merchants Association, as defunct and non-compliance Trade Organization.

The hearing was held in FPCCI Head Office Karachi and the Consuls of Complainant(s) and the Respondent(s) also attended and represented on their behalf. Arguments were advanced by both the parties, after going through the said arguments and the documents referred/ submitted, my finding are as follows;

In view of the remarks / documents submitted by the Complainant and the Respondent and the documents available with FPCCI, the Office of the DGTO's Order No. 122/2021 (F.No. 6(72)/2021-TO) dated 3rd December 2021, in line with the Order Sheet under C.M.A. No. 17 of 2021 of Honorable High Court of Islamabad issued on 5th November 2021, the nominations received from Pakistan Hardware Merchants Association, cannot be entertained at this stage, till the final outcome / decision of the Honorable High Court of Islamabad and the directives from the esteemed Office of the Director General of Trade Organizations.
