Reference letter / objection dated 10TH November 2023, filed by Mr. Mohammad Hanif Lakhany, nominee of Pakistan Silk and Reyon Mills Association, raising various objections on Mr. Mohammad Arif, EC&GB Corporate of All Pakistan Marble Industries Association.

The hearing was held in FPCCI Head Office Karachi and the Consuls of Complainant(s) and the Respondent(s) also attended and represented on their behalf. Arguments were advanced by both the parties, after going through the said arguments and the documents referred/ submitted, my finding are as follows;

In view of your objections, the findings based on the objections raised, and the documents available with FPCCI, are as follows:

- 1. That the Respondent was not able to provide any document showing affiliation with marble industries rather was involved in the business of tool manufacturing.
- That the nominee on Corporate Class has provided documentary evidences of FBR proving that he is filer from the concerned District.

In view of the facts and the available documents, the name of Mr. Mohammad Arif, EC&GB Corporate of All Pakistan Marble Industries Association, is hereby excluded / removed from the provisional list of voters.
