The Learned Council for the Respondent, Nominee on Corporate Class, has submitted / provided his active Sales Tax profile which shows that he is registered with the sales tax department. As far as the issue of turnover is concerned, the Council has provided the Form 29 of the nominee company which shows that he is one of the director in his Company. As such the said nominee is competent to be nominated on the Corporate class.

The Learned Council for the Respondent, Nominee on Associate Class, at the outset submitted that the nomination paper has been submitted on behalf of Syntex Pharmaceutical Company, which is a sole proprietorship concerned as per the tax profile. Whereas entire objection as raised by the Complaint is in respect of M/s. Syntex Pharmaceutical, status of the said entity was changed to Private Limited Company. The said Private Limited Company was however defaulted and was auctioned by the Court. The learned Council for the Complaint has submitted certified copies issued by the Hon'ble Banking Court at Rawalpindi issued which shows the name of the Judgment Debtor as M/s. Syntex Pharmaceutical Private Limited Company

In the light of above, the Complaint seems to be devoid of merit, as the said two nominee are competent to be nominee of the subject trade body. Hence, the Complaint is denied.
