Quote: "Although the license of PCETA has not been granted under the Trade Organizations Act 2013, and the matter is still pending final adjudication on matter of question of law before the Honorable High Courts. Furthermore, a contempt application against DGTO is pending on the same matter in CMA 10986/2018 before the Honorable High Court of Sindh. Therefore, the DGTO is constrained to offer any views on the matter until final outcome of the relevant petitions / application before the High Courts of Pakistan. The matter stands disposed off accordingly." Un-Quote.

In view of the above, the objection received from the Objector cannot be entertained, and the nominations received from PCETA are valid for necessary inclusion of the nominees in the provisional voters list of FPCCI.
