OBJECTION UNDER RULE 18(4) OF THE TRADE ORGANIZATIONS RULES 2013 AGAINST THE NOMINATIONS SENT BY HARIPUR CHAMBER OF COMMERCE & INDUSTRY AS PUBLISHED IN THE PROVISIONAL LIST FOR THE ELECTION YEAR 2024-2025

Reference letter No. Nil dated Nil, received in FPCCI Head Office Karachi on 10th November 2023, filed by Mr. Shaikir Ullah, Khyber Chamber of Commerce & Industry, against the nominee of Haripur CCI on Associate Class.

The hearing was held in FPCCI Head Office Karachi and the Consuls of Complainant(s) and the Respondent(s) also attended and represented on their behalf. Arguments were advanced by both the parties, after going through the said arguments and the documents referred/ submitted, my finding are as follows;

- 1. That the nominees has provided two years membership certificate of the said Association. Which shows that he is a valid member of the said Chamber. As far as objection that he has been deported by some country is also denied and said nominee has produced copy of UK Passport.
- 2. No evidence of any sort has been shown or given in respect any criminal record by the Complainant.
- The Judgment as referred is not relevant in this case as the said two nominee do qualified the various requirements of the Trade Laws.

The nomination received from Haripur Chamber of Commerce and Industry on Associate is found to be in Valid.

The Complaint is hereby declined.
