That the sole objection raised by he learned council for the Complainant is that the status of the Joint Chamber in FPCCI is only restricted to the extent that they are member of FPCCI whereas they do not have the right to vote in the election of FPCCI. In this regard he has submitted few documents. Whereas, the FPCCI has received clarification, Ref. No. 17(31)/2008-TO, dated 20th May 2015, issued by the office of the DGTO Ministry of Commerce, whereby the status of the Joint Chambers is that of Association and also have the right to vote.

The said clarification was also shared with the learned Council for the Complainant and after going through the same he has waived his objection. Furthermore, Mr.Qazi Zahid Hussain, Member EC&GB from Corporate Class has provided evidence to become valid member from Corporate Class.

In view of the explanation on the status of Joint Chambers by the Secretary General of FPCCI, as well as the evidence of Corporate Class provided by Qazi Zahid Hussain, the nominations received from the Pak-Afghan Joint Chamber are found to be valid. Accordingly the objection(s) are declined.
