Beside the said return a Partnership Deed of D-Watson Chemist has also been submitted which shows the Company "D-Watson Chemist".
2. Whereas, the NTN of Mr. Khurram Kamran, nominee on Associate of the Chakwal Chamber, showing RTO Rawalpindi, but business exists in Chakwal. The membership certificates shows the Company as "Shaukat Brothers Forwarding Agency".

In view of the objections raised by the objector and the available documents, the decision of the undersigned is as follows:

1. The nomination on Corporate Class i.e. Mr. Waqar Zafar Bakhtawari is not maintainable and be removed from the Provisional list.
2. The nomination on Associate Class i.e. Mr. Khurram Kamran, is allowed to be in the provisional list.
