That the sole objection raised and discussed by the learned council for the Complainant is that the status of the Joint Chamber in FPCCI is only restricted to the extent that they are member of FPCCI whereas they do not have the right to vote in the election of FPCCI. In this regard he has submitted few documents. Whereas, the FPCCI has received clarification, Ref. No. 17(31)/2008-TO, dated 20th May 2015, issued by the office of the DGTO Ministry of Commerce, whereby the status of the Joint Chambers is that of Association and also have the right to vote.

Furthermore, the Chamber has clarified and provided the documents, that as follows:

- List of Members of Pak-China Joint CCI.
- The nominees are valid on Corporate Class
- Membership Certificates provided by the Chamber.
- The Chamber has provided evidences that they have applied for the renewal of license.

In view of the explanation on the status of Joint Chambers by the Secretary General of FPCCI, as well as the documents provided by the Pak-China Joint CCI, the nominations received from the Chamber are found to be valid. Accordingly the objection(s) are declined.
