Whereas the council for the Respondent even though argued that the said nominee is fully qualified on corporate class but despite of his assurance that he will provide prove of Turnover of Rs. 50 Million but no such evidence was supplied.

On perusal of the file, the subject chamber has provided first page of NTN return of Mr. Bashir Arian, which shows that his proprietorship concern has a turn over less than the threshold level.

As such the objections seems are valid. The name of the said nominee on Corporate Class is hereby directed to be removed from the Provisional Voter List.
