The learned Council for the Respondents has produced / submitted documents which shows that the turnover of the nominee is more than the threshold lever of Rs. 50 Million. Beside the said documents he has also produced two year membership certificate issued by the subject Chamber. As far as licence is cornered the said chamber has already applied for the renewal of their license.
