The learned Council for the Respondent has submitted the membership certificate of the said nominee. Along with the tax profile status. He however sought time to produce the documentary evidence which shows that the said nominees are eligible to be nominated.

The learned Council for the Complaint however pointed out that as the said nominees are from small chamber therefore they should produce proof that their turnover is between 2 to 20 Million. He further argued that without the said proof the said nominee cannot be a member of small chamber as per law.
