Subject: SERIOUS DEFICIENCY: KARACHI WOMEN CHAMBER OF COMMERCE & INDUSTRY, DISTRICT EAST: FPCCI ELECTIONS 2024-2025

Reference your e-Mail dated 4th November 2023, on the subject.

FPCCI has reviewed the supporting documents provided, as well as the documents available in FPCCI records, and you may be aware that the case of Karachi WCCI District East is pending before the Honorable High Court of Sindh in CP No. D-8520 of 2017, vide Orders / Letters / Notices dated 7th November 2022, 18th March 2021, 22nd January 2021, 8th January 2021, 27th October 2020 and 27th February 2020, and the recent notices of the DGTO vide dated 11th October 2023, 22nd June 2023, for the purpose of hearing the parties.

The Office of the DGTO vide letter No. 6(40)/2022-TO dated 15th December 2022, clearly stated in para 2, as under:

"Furthermore, two competing factions are claiming the rightful representation of Chamber, for time being, the matter is subjudice with the Federal Government. Until it is resolved/decided by the Federal Government, the case of renewal of license and complaint against Lalarukh Group cannot be processed"

Therefore, till the final outcome of the case from the Office of the Honorable High Court and the Directorate General of Trade Organizations, FPCCI cannot decide the validity of the Chamber, as well as to consider the rights of the nominations from the legitimate persons.
