The hearing was held in FPCCI Head Office Karachi and the Consuls of Complainant(s) and the Respondent(s) also attended and represented on their behalf. Arguments were advanced by both the parties, after going through the said arguments and the documents referred/ submitted, my finding are as follows;

That the sole objection raised by he learned council for the Complainant is that the status of the Mirpur Chamber of Commerce & Industry in FPCCI is only restricted to the extent that they are member of FPCCI whereas they do not have the right to vote in the election of FPCCI.
