The learned Council for the Respondent has produced evidence that the nominee of the subject Chamber on Corporate Class has a valid Sales Tax Registration. He has also produced evidence which shows that his turn over is well above the threshold level of turn over as required under the TO Laws.

The objection as instituted by the Complaint seem to be invalid.
