The hearing was held in FPCCI Head Office Karachi and the Consuls of Complainant(s) and the Respondent(s) also attended and represented on their behalf. Arguments were advanced by both the parties, after going through the said arguments and the documents referred/ submitted, my finding are as follows;

In view of objections raised by the objector, and based on the available documents as provided by the Zhob CCI, following are the facts and findings:

1. That the nominee on Corporate Class has provided necessary documentary evidences of FBR proving that he is valid member.
2. That the nominee on Associate Class has provided necessary documentary evidences of FBR proving that he is valid member.
3. That the Zhob CCI (License No. 193) has completed two years of valid membership with FPCCI on 21st December 2016.
4. That the License of Zhob CCI which was earlier canceled by the DGTO / Ministry of Commerce vide Notification No. 6(119)/2020 dated 30th August 2021, which the appeal is pending before the Secretary Ministry of Commerce.
5. Regarding validity of the nominations of Members of Zhob CCI on EC and GB of FPCCI, you did not provided sufficient and prudent evidences to check the validity of the nominees.

In view of the above documentary evidences provided by the Zhob CCI, FPCCI apprise to inform you that the aforementioned nominations are found well in order for needful inclusion in the Provisional List of Voters issued on 4th November 2023. Moreover, your objections are not substantiated with any prudent evidences and accordingly your objections cannot be entertained.

Decision of the Secretary General:

The said nominations received from Zhob CCI are found well in order for needful inclusion in the Provisional List of Voters issued on 4th November 2023. Moreover, your objections were not substantiated with any prudent evidences and accordingly your objection(s) are declined.
