Subject: OBJECTION UNDER RULE 18(4) OF THE TRADE ORGANIZATIONS RULES 2013 UPON THE PROVISIONAL LIST ISSUED ON 4TH NOVEMBER 2023, REGARDING INCLUSION OF THE REPRESENTATIVE OF KHANEWAL CHAMBER OF COMMERCE AND INDUSTRY ON CORPORATE CLASS

Reference objection letter received in FPCCI Head Office Karachi on 10th November 2023, filed by Mr. Ehtesham Zaman, nominee of Attock Chamber of Commerce & Industry, on the inclusion of Mr. Zain Ifikhar as Corporate Member from Khanewal Chamber of Commerce and Industry.

The hearing was held in FPCCI Head Office Karachi and the Consuls of Complainant(s) and the Respondent(s) also attended and represented on their behalf. Arguments were advanced by both the parties, after going through the said arguments and the documents referred/ submitted, my finding are as follows;

1. That the nominee Consul has submitted two NTN status, one of the nominee and one on behalf of M/s. Welcon Chemicals Pvt. Ltd. Whereas the personal NTN status of the nominee does not disclose his business address, whereas the second NTN verification does not show that he has any business address of Khanewal.
2. Whereas the other issue raised by the Complainant in his complaint, i.e. list of member and website of the said chamber is not functional.
3. The judgment sited by the complaint, as referred in the complaint is applicable on FPCCI.
