## APPEAL FOR INCLUSION OF NAGAR CHAMBER OF COMMERCE & INDUSTRY IN THE PROVISIONAL LIST

Reference your letter No. NCCI-2024/25 dated  $6^{th}$  November 2023, received in FPCCI on  $8^{th}$  November 2023, on the subject.

Mr. Qurban Ali, represented the Nagar CCI on behalf of the Secretary General of Nagar CCI, and raised various reservations and requested the Secretary General of FPCCI to consider the nominations of Nagar CCI. He further informed that the Nagar CCI has already cleared all the dues of the Chamber. Furthermore, he accepted late payment of submission of the annual subscription due to far flung area. He expressed that the Nagar CCI always submit the subscriptions in time as well as the uncertainty of the elections of Trade Bodies as well as in FPCCI.

FPCCI with reference to the nomination papers of Nagar CCI vide No. NCCI-2024/19 dated 23<sup>rd</sup> October 2023 received on 30<sup>th</sup> October 2023 and in response to FPCCI letter No. FPCCI.EL2023-24/2023/11894 dated 31<sup>st</sup> October 2023 as well as various reminders / circulars, the Nagar CCI has failed to provide any evidence of due payments of outstanding subscriptions. Hence, FPCCI has received the outstanding subscriptions / dues on 1st November 2023, which is after the date of the nominations.

Therefore, FPCCI is unable to entertain the nominations of Nagar Chamber of Commerce & Industry as per Rule 11(5)(a) of TOR 2013 and Article 42(ii) of M&AoA of FPCCI.
