**SUBJECT: APPEAL FOR INCLUSION OF NOMINEES OF HUNZA CHAMBER OF SMALL TRADERS & SMALL INDUSTRY IN THE PROVISIONAL LIST, FOR THE YEAR 2024-2025**

Reference your letter No. Nil dated 7<sup>th</sup> November 2023, received in FPCCI Head Office Karachi on 8<sup>th</sup> November and 10<sup>th</sup> November 2023, on the subject.

On behalf of the Secretary General of Hunza Chamber of Small Traders & Small Industry, Mr. Durvesh Sharif, Executive Committee Member of the Chamber represents the Hunza CSTSI, and expressed his views to accept the nominations in view of the Small Chamber as well as limited resources. However, the Chamber has paid the outstanding dues to FPCCI. He accepted that the Chamber has paid the dues late after the due date. But he expressed his concerns on behalf of the Chamber that they paid annual subscription for the year 2023 in time. However the Hunza CSTSI has not received the circular(s) for the year 2022. Hence they paid the arrears with the request to accept the nominations.

FPCCI in view of the records available and with reference to the nomination papers of Hunza Chamber of Small Traders & Small Industry vide No. Nil dated Nil received in FPCCI Head Office Karachi on 30<sup>th</sup> October 2023, and in response to FPCCI letter No. FPCCI.EL2023-24/2023/11890 dated 31<sup>st</sup> October 2023 as well as various reminders / circulars, the Hunza CSTSI has failed to provide any evidence of due payment of outstanding arrears within the due date. Hence, FPCCI has received the outstanding subscription arrears on 8<sup>th</sup> November 2023 along with the letter under reference of Hunza CSTSI, which is after the date of the nominations.

Therefore, we regret to inform that FPCCI is unable to entertain the nominations of Hunza CSTSI as per Rule 11(5)(a) of TOR 2013 and Article 42(ii) of M&AoA of FPCCI.
