Subject: OBJECTION AGAINST THE NOMINEES OF SAHIWAL WCCI

Reference letter / Objection received in FPCCI Head Office Karachi on 10th November 2023, filed by Mr. Shoaib Dawood, Secretary General of Sahiwal WCCI, raising various objections on the 2nd Set of Nominees of Sahiwal CCI, Ms. Nabeela Farrukh and Ms. Sadia Asif.

The hearing was held in FPCCI Head Office Karachi and the Consuls of Complainant(s) and the Respondent(s) also attended and represented on their behalf. Arguments were advanced by both the parties, after going through the said arguments and the documents referred/ submitted, my finding are as follows;

Two sets of nomination has been submitted in respect of subject Chamber.

First sets of Nomination has been submitted which is duly signed by the Secretary General, Mr. Shoaib Dawood, which is duly endorsed by the President, Ms. Humarah Bukhari. The said nomination shows that before nomination an Executive Committee meeting was held on October 24th, 2023.

Whereas second set of nominations was also received by this office, which shows that the said nomination has been submitted by President Ms. Nabila Farooque and counter signed by Secretary General Mr. Rai Amir, which is duly supported by the resolution duly signed by 10 Executive Committee of the said chamber. The council of the said party also stated that an FIR has been lodged against Ms. Humarah and also the said issue is pending before the DGTO office. The next date of hearing in this respect is fixed on 27-11-2023.
