DECISION # 06 (012 – 031)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Mr. Shakir Ullah, nominee of Khyber CCI, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

"After going through the said arguments and the documents referred/ submitted, my finding are as follows;

In view of the objections raised, FPCCI has reviewed the nomination papers of Chamber of Commerce & Industry Quetta and the available records, observed the following facts and findings:

- 1. That the Chamber of Commerce & Industry Quetta is licensed trade body by the Ministry of Commerce and registered with FPCCI.
- That the nomination papers received in FPCCI are duly signed by the Secretary General and President of Chamber of Commerce & Industry Quetta, with the resolution of the Executive Committee of Chamber of Commerce & Industry Quetta.
- That the nominee on Corporate Class has provided documentary evidences proving that he is tax filer and Sales Tax Registered person.
- 4. That the nominee on Associate Class has provided valid document that he is operating business from Quetta and registered in RTO Quetta.

The nominations received from Chamber of Commerce & Industry Quetta are found well in order for needful inclusion in the Provisional List of Voters issued on 4th November 2023. Moreover, the objections raised by the objector are not substantiated with any prudent evidences and accordingly the objection(s) are declined."

Hearing Proceedings:

The main contention of the Appellant in this Appeal is that the Nominee on Corporate class do not qualify for Corporate Class, as he does not have turnover of Rs. 50 Million,. In response to the said allegation the Respondent has provided Form 29, issued by SECP which shows that the company of the Respondent is a body corporate. He also submitted his NTN return which shows that the turnover of his company is more than Rs. 50 Million.

Decision of the Election Commission of FPCCI:

In the light of above, the appeal is devoid of merits and is hereby declined and the name of Mr. Nasir Khan, nominee of Chamber of Commerce & Industry Quetta is still included in the Provisional List.

This order is passed on Thursday, 23rd November 2023.
