DECISION # 07 (013 – 032)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellants written representation / appeal received on 18th November 2023 in FPCCI Head Office Karachi from Mr. Waheed Ahmed, nominee of All Pakistan Fruit & Vegetable Exporters Importers & Merchants Association for the year 2024-25, to the Election Commission of FPCCI, against the following decision:

Decision of the Secretary General:

“After going through the said arguments and the documents referred/ submitted, my finding are as follows:

1. That the nominee has provided two years membership certificate of the said Association, which shows that he is a valid member of the said Association.
2. The nominee, Sh. Omer Sarfaraz has produced his Sales Tax Registration Certificate along with the proof that he has a turnover of more than 50 Million.
3. The Judgment as referred is not relevant in this case as the said nominee does qualified the various requirements of the Trade Laws.

The nomination of Sh. Omer Sarfraz, as GB Corporate received from Pakistan Steel Linepipe Industry Association is found to be Valid therefore your objections are hereby declined.”


Decision of the Election Commission of FPCCI:

The learned Counsel for the Appellant has alleged that the nominee of the Association is not entitled to be nominee of the said Association as his tax profile does not show that he is associated with M/s. Eagle International (Pvt.) Ltd. And also the said nominee is not associated with the business for which the said association is formed.


On the other hand the learned counsel for the Respondent submitted Form-A issued by SECP which shows that the said nominee is one of the directors of M/s. Eagle International (Pvt.)Ltd.

From the documentary proof submitted, it is clear that the appeal instituted by the Appellant /Objector is devoid of any merit. Therefore the same is declined.

This order is passed on Thursday, 23rd November 2023.
