DECISION # 11 (018 – 055)

**PASSED BY THE ELECTION COMMISSION OF FPCCI
(FPCCI ELECTIONS 2024-2025)**

Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 17th November 2023 in FPCCI Head Office Karachi from Mr. Muhammad Arif, nominee of All Pakistan Marble Industries Association, through Mr. Asghar Khan Utmankhel, Chairman of the Association, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

“After going through the said arguments and the documents referred/ submitted, my finding are as follows;

In view of your objections, the findings based on the objections raised, and the documents available with FPCCI, are as follows:

1. That the Respondent was not able to provide any document showing affiliation with marble industries rather was involved in the business of tool manufacturing.

2. That the nominee on Corporate Class has provided documentary evidences of FBR proving that he is filer from the concerned District.

In view of the facts and the available documents, the name of Mr. Mohammad Arif, EC&GB Corporate of All Pakistan Marble Industries Association, is hereby excluded / removed from the provisional list of voters.”

Hearing Proceedings:

This appeal is been instituted by Mr. Asghar Khan Utmankhel, Chairman of APMIA, whereas the objection on the nominee of the said Association was that he is not doing any business with regard to Marble as he is manufacture of tools etc. The explanation as given by the said chairman of the association that tools are used in marble industry and as such it is the integral part of the said industry cannot be accepted. He also submitted a table calendar of the firm showing the advertisement of machine tool, which are manufactured at his manufacturing unit. There is no relevancy is established that the concern unit is engaged in process of marble industry. Besides, the said nominee produced his nill return which shows that his turnover for the year i.e. 2021-2022 is Nil.


Decision of the Election Commission of FPCCI:

In the light of above the Appeal is devoid of any merit and is hereby declined.

This order is passed on Thursday, 23rd November 2023.
