DECISION # 13 (021 – 061)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Syed Ali Hammad Kazmi, nominee of Live Stock Farmers Association of Pakistan, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

“After going through the said arguments and the documents referred/ submitted, my finding are as follows;

1. That the nominees has provided two years membership certificate of the said Association. Which shows that they are valid member of the said Association.
2. The nominee, Mr. Sheikh Mubarak, has produced his Sales Tax Registration Certificate along with the proof that he has a turnover of more than 50 Million.
3. The Nominee, Mr. Sultan Rehman, while relying upon his membership certificate of the Association. He is also elected Vice President of FPCCI for the year 2020 from the same Association.
4. The Judgment as referred is not relevant in this case as the said two nominee do qualified the various requirements of the Trade Laws.

The nomination received from Pakistan Waste Products Association are found to be Valid therefore your objections are hereby declined. The Complaint is hereby declined.”

Hearing Proceedings:

Through this appeal the Appellant has challenged the nominations of Pakistan Waste Products Association.

The sole ground taken by the Appellants is that both the nominees are not qualified to be nominated on their respective seats as both of them do not qualify the criteria as set forth under the TO laws.

In this regard the learned Counsel for the Respondents has produced, for Corporate Class nominee, his NTN return, partnership deed, etc. which shows that his turn over is more than required turnover as under the law. It is also argued that the said nominee is running a rice mill, the main product is polished rice, and during this process, there is broken rice, rice husk etc. which do fall under waste. In addition to this number of other documents has been produced which shows that the said nominee is fully qualified. As far as the nominee of Associate class is concerned, the said nominee also fully qualified as he has produced invoice showing to have purchased/sold paper cone, mix yard waste, etc. As such both the said nominees have fully qualified to be nominated by the said association.


Decision of the Election Commission of FPCCI:

In the light of above the Appeal is devoid of any merit and is hereby declined.

This order is passed on Thursday, 23rd November 2023.
