**PASSED BY THE ELECTION COMMISSION OF FPCCI  
(FPCCI ELECTIONS 2024-2025)**

Consequent upon written representation / appeal to the Election Commission of FPCCI, received on 18<sup>th</sup> November 2023 in FPCCI Head Office Karachi from appellants who are not representing FPCCI on General Body and Executive Committee Members of FPCCI for the year 2024-25, against the following decision:

**Decision of the Secretary General:**


“Since, the Objectors / Addresses are not the members nominated by any Trade Body on the Executive Committee and General Body of FPCCI for the year 2024-25, hence the objections raised by the Objectors, cannot be entertained, as per Rule 18(4) of TOR 2013 and FPCCI Circular dated 4<sup>th</sup> November 2023.”


**Decision of the Election Commission of FPCCI:**


As the appellants are not the Members nominated by any Trade Body on the Executive Committee and General Body of FPCCI for the year 2024-25, the appeals filed by the Appellants, are not considered /maintainable. Accordingly, the hearing was not called by the Election Commission of FPCCI in terms of Rule 18(6) of TOR 2013 and FPCCI Circular dated 4<sup>th</sup> November 2023.

In view of the above, the Election Commission of FPCCI upheld the decision of the Secretary General of FPCCI.
