## DECISION # 23 (038 – 130)

### PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 18<sup>th</sup> November 2023 in FPCCI Head Office Karachi from Mr. Muhammad Ali Farooq, nominee of Pakistan Electronics Manf Association, against the decision of the Secretary General of FPCCI, as follows:

#### Decision of the Secretary General:

"After going through the said arguments and the documents referred/ submitted, my finding are as follows;

1. That the nominees has provided two years membership certificate of the said Association. Which shows that they are valid member of the said Association.
2. The nominee, Mr. Faisal Salim Vohra, has produced his Sales Tax Registration Certificate along with the proof that he has a turnover of more than 50 Million.
3. The Nominee, Ms. Kurratul Ain Zahid, while relying upon her membership certificate of the Association also referred to her NTN profile, which shows that she is doing business of Agriculture etc.
4. The Judgment as referred is not relevant in this case as the said two nominee do qualified the various requirements of the Trade Laws.

The nomination received from Agriculture and Dairy Farmers Association are found to be Valid therefore your objections are hereby declined”.

Hearing Proceedings:


The learned Counsel for the appellant has raised objection on the decision of SG FPCCI, whereby both the nominees of the said Association were allowed to remain on the Provisional voter list. The learned Counsel for Respondent on Corporate has provided his NTN profile which shows that the said nominee is doing business of agriculture, and also submitted his bank statement which shows that turnover of his company is more than threshold level as required under the TO laws. As far as the issue of nominee on Associate class is concerned, she produced her NTN which was duly mentioned in nomination papers submitted by her Association, which shows that the company name is not mentioned in the said nomination papers.

Decision of the Election Commission of FPCCI:

In the light of above, the nominees on corporate class and associate class of Pakistan Agriculture & Dairy Farmers Association are entitled as valid voters in the provisional list. The Appeal is devoid of merit and is declined.
