DECISION # 31 (049 – 162)

PASSED BY THE ELECTION COMMISSION OF FPCCI (FPCCI ELECTIONS 2024-2025)

Consequent upon Appellant written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Mr. Jamal Khan, nominee of Hajj Organizers Association of Pakistan, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

"The learned Counsel for the Complaint pointed out that the nominee of Associate Class is from Private Limited Company. As per the basic definition of Associate Class a body cooperate cannot be nominated on the Associate Class.

The learned Counsel for the Respondent argued that he will submit documents which will show that he is eligible to be member of Cooperate class. However no such documents were provided / submitted.

In the light of above the nominee of the subject Association seems to be invalid. The Complainant is accepted."

Hearing Proceedings:

The appeal is filed with a prayer that the nominee on Associate class be treated on Corporate Class as in Association the same is allowed.


The said prayer / request is denied as the said request was to be made through resolution of the Executive Committee before the cutoff date of correction before the SG FPCCI. The existing nomination has been filed after approval of the Executive Committee of the said Association, while the instant appeal the request has been submitted by the Appellant.

Decision of the Election Commission of FPCCI:

In the instant appeal the nomination received from the said Association of Mr. Jamal Khan from Associate Class, whereas he falls under the category of Corporate Class. Whereas, the Association or the nominee did not requested for any rectification of the said nomination at any forums such as at Secretary General of FPCCI and the Election Commission of FPCCI. Hence, the request to accept the nomination of Mr. Jamal Khan cannot be accepted, and the appeal is hereby declined.

This order is passed on Thursday, 23rd November 2023.
