Consequent upon Appellant's written representation / appeal to the Election Commission of FPCCI, received on 18th November 2023 in FPCCI Head Office Karachi from Mr. Muhammad Bashir Arain, nominee of Khairpur CCI through Mr. Sheraz Khan, Secretary General Khairpur CCI, against the decision of the Secretary General of FPCCI, as follows:

Decision of the Secretary General:

“On perusal of the file, the subject chamber has provided first page of NTN return of Mr. Bashir Arian, which shows that his proprietorship concern has a turn over less than the threshold level.

As such the objections seems are valid. The name of the said nominee on Corporate Class is hereby directed to be removed from the Provisional Voter List. The Complaint is allowed “

Hearing Proceedings:


The appeal is in respect of restoration of Nominee on Corporate class. With the appeal, the said nominee has submitted a bank certificate showing the nominee company account a turnover of more than Rs. 50 Million and also provided only 1st page of Income Tax Return. But he was unable to submit the Bank Statement and the relevant page of Income Tax Return which shows the Revenue of the firm.

Decision of the Election Commission of FPCCI:

In the light of above the appeal is devoid of any merit and is hereby declined, and the nominee on corporate class is still excluded from the Provisional list of voters.

This order is passed on Thursday, 23rd November 2023.
